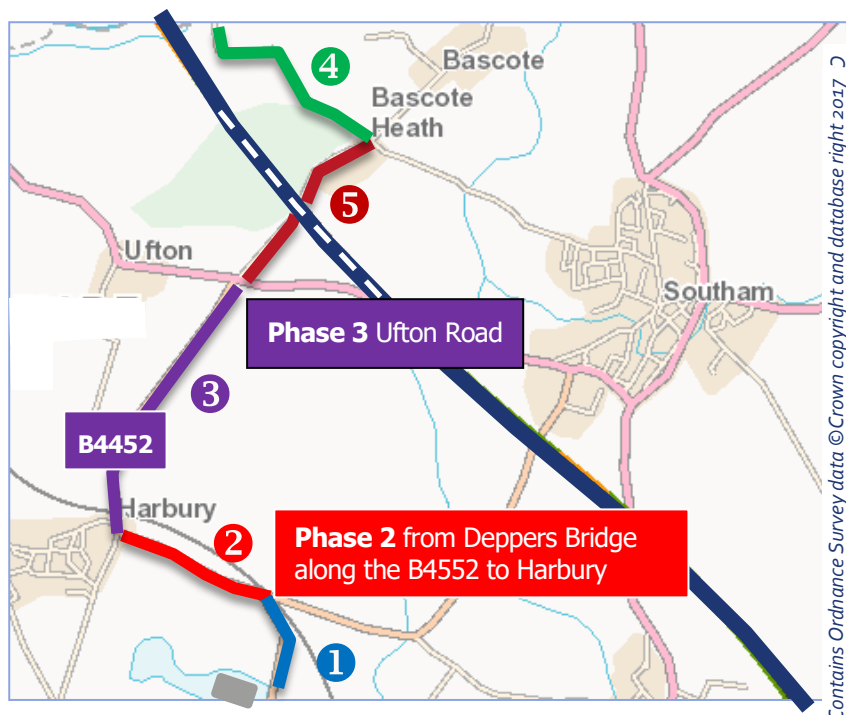
# Long Itchington Wood Tunnel utilities – phase 3

High Speed Two (HS2) is the new high speed railway for Britain. Initial works have now started and are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

We will be continuing our works to install utilities from the electricity substation near Harbury to the tunnel compound entrance.

**Phase 1** is complete. **Phase 2** working hours have been extended to include weekends to ensure that works are completed to **start Phase 3 on 10<sup>th</sup> July. The work is along the Ufton Road from Harbury to the A425 junction.** We have extended the working hours on this phase to address local concerns. The road will be closed for up to 6 weeks. Access will be maintained for all households and businesses along the route. A clearly signed local diversion will be in place. Our contractors may also be on site for up to one hour beforehand to set up the works.
