Notice of ground investigation works

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM.

Marsh Lane, Coleshill.

We will be carrying out overnight ground investigation works in your area. These will consist of surveys to map the road layout and to understand the ground conditions for future junction improvements.

To minimise disruption for road users we will be carrying out these works overnight between the hours of 8.00pm and 6.00am. All restrictions will be lifted at 6.00am on each day.

Traffic management.

To ensure a safe working environment we will reduce Marsh Lane to one lane at the junction with Lichfield Road (see map below). There will also be temporary traffic lights in place of the permanent lights at this junction.

From Monday 8th July to Saturday 20th July 2019.

Working hours will be Monday to Sunday, 8.00pm to 6.00am.

Our contractors may be on site for up to one hour beforehand and afterwards to set up and close down the works.
