## Notice of ground investigations Coleshill

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM.

### We will be carrying out overnight works.

We will be carrying out overnight ground investigation works in your area to prepare the route for the main construction works. The ground investigation works will consist of surveys which will gather data to map and identify the contours of the ground. We will also be digging shallow trial pits to establish which utilities are located in this area and the makeup of the ground for future junction improvements.

### We need to operate traffic management.

A section of the Birmingham Road between Park Road and A446 roundabout will be closed to west bound traffic, during this period, to allow us to undertake these works safely. A traffic management system and a signed diversion will be in place and access to frontages will be maintained.

Access for pedestrians and cyclists will also be maintained.

### Location of traffic management and early works

We'll operate traffic management in the areas highlighted on map on next page.

Ensure all traffic management is clearly signed with any diversions clearly marked.

Answer your questions via the 24/7 HS2 helpdesk.

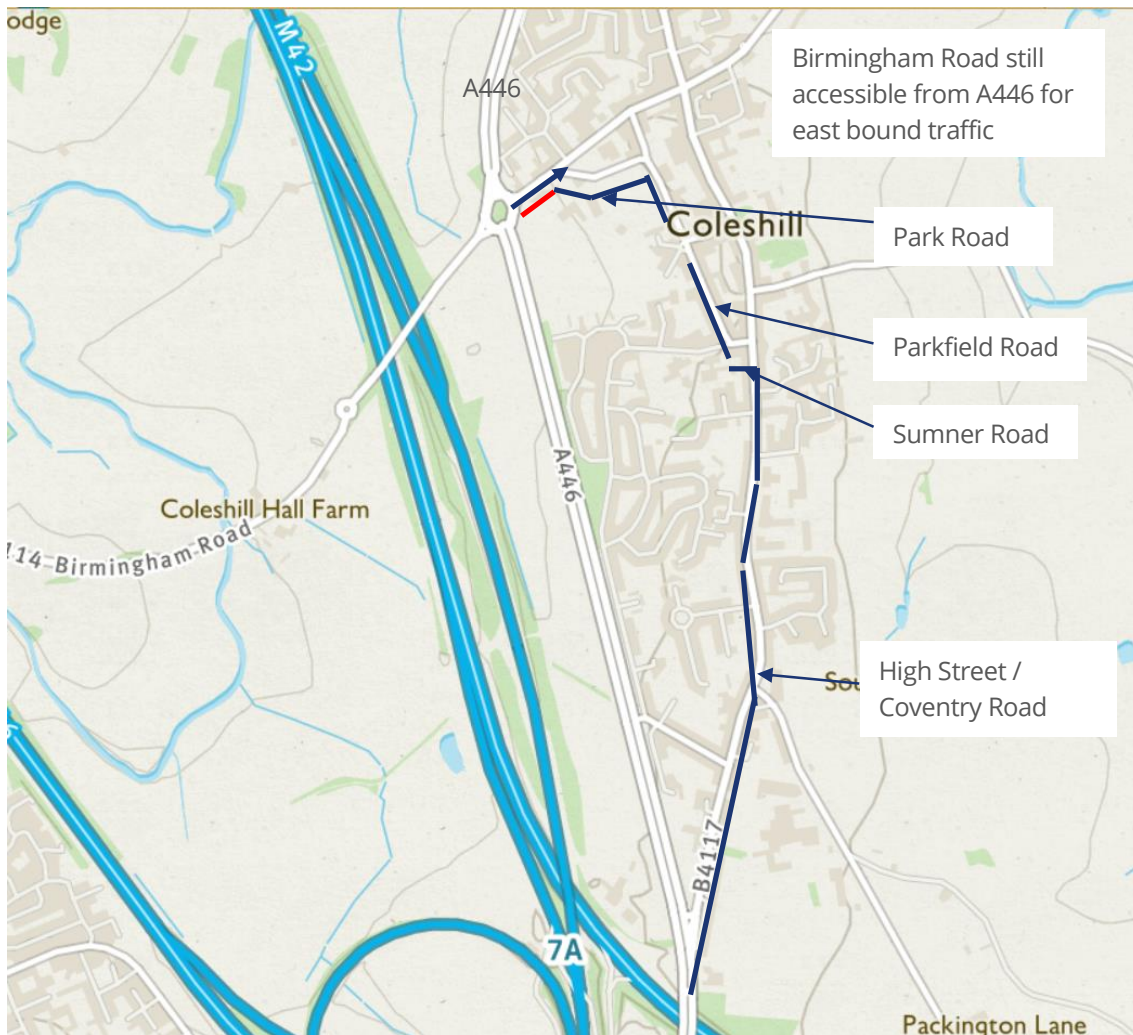
