

Notice of temporary road closure

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM.

A446, Lichfield Road closures.

From 8pm to 6am on 18 May and 19 May 2019 we will be carrying out overnight ground investigation works in private land at the junction between Watton Lane and Lichfield Road. These surveys are to identify the location of utilities like gas and water pipes and electricity cables, which may need to be diverted as part of construction of the railway. The surveys will involve digging trenches close to the road.

What are the traffic restrictions?

To carry out the utility surveys safely, we need to manage traffic in the area. This will include the temporary road closure of Lichfield Road (A446) in both directions, between Marsh Lane and Watton Lane. This closure will be in place between 8pm to 6am on both Saturday and Sunday. We'll carry out the surveys in phases, rather than all at once. Local traffic diversion routes will be in place.

Duration of works

The works will take two nights to complete.

Working hours will be 8pm to 6am Saturday and Sunday night/ Monday morning.

Our contractors may be on site for up to one hour beforehand and afterwards to set up and close down the works.

Some low level noise from onsite machinery during working hours.

Minor disruption to traffic flow in the area.
