High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM.

We're uncovering Britain's past.

Before we begin to build the new railway, the surrounding area will become part of the largest archaeology programme ever undertaken in the UK.

Across the HS2 route, more than 1,000 archaeologists, scientists and conservators are revealing the everyday lives of the people and their communities from the last 10,000 years.

Our works won't affect highways in your area.

We'll dig a number of trenches per day on land to the South of Water Orton, and explore each for a few days, before filling them back in if nothing is discovered. Our works will not disrupt highways, traffic movement or building access in the area.

Duration of works

From April to June 2019.

Working hours will be Monday to Friday, 8am to 5pm.

Our contractors may be on site for up to one hour beforehand and afterwards to set up and close down the works.

What to expect

A number of trenches will be dug per day.

We will work in one area at a time.

Our works will not disrupt highways or traffic movement in the area.
