High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM.

### We're uncovering Britain's past.

Before we begin to build the new railway, the surrounding area will become part of the largest archaeology programme ever undertaken in the UK.

Across the HS2 route, more than 1,000 archaeologists, scientists and conservators are revealing the everyday lives of the people and their communities from the last 10,000 years.

Archaeological works will commence on private land close to the following:

- Middleton, Church Lane
- Weeford, Watling Street
- Packington, Jerry's Lane
- Whittington, Tamworth Road

### Our works won't affect highways in your area.

We'll dig a number of trenches per day, and explore each for a few days, before filling them back in if nothing is discovered. We'll work in one specific area at a time. Our working hours will be Monday to Friday, 8am to 5pm, with an hour set-up either side. Our works will not disrupt highways, traffic movement or building access in the area.

Our works schedule is subject to change depending on site conditions, however we'll keep you informed of any adjustments.
