# Temporary closure of Long Itchington Road

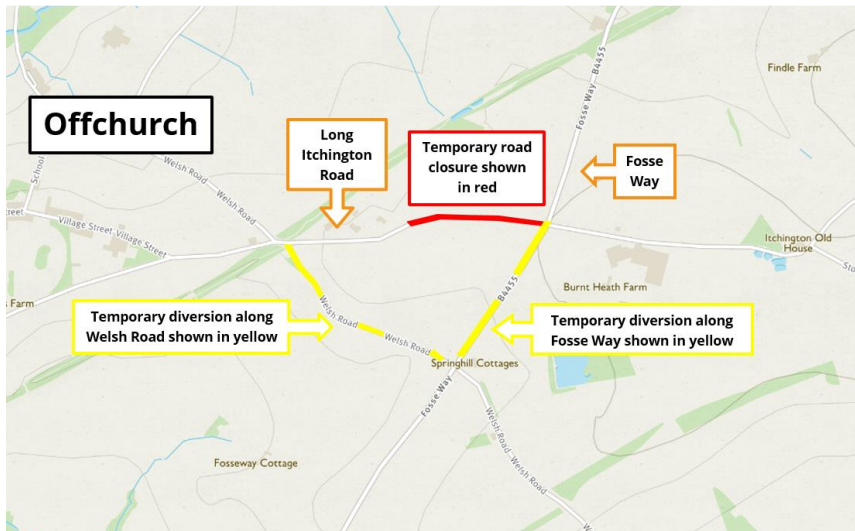
High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are now underway in your area, and are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

LM will be temporarily closing a section of Long Itchington Road in Offchurch (on the National Cycle Route 41) to create a safe zone for accessing our HS2 worksite off the nearby Fosse Way (B4455).

The closure will be in place 24 hours a day, 7 days a week for around six weeks (subject to site and weather conditions), in the area shown on the below map. Pedestrians and cyclists will not be able to move through the closure for health and safety reasons.

The temporary closure will help us continue preparing for an HS2 compound at our Fosse Way worksite. In future, the compound will support the safe delivery of early and main works for the railway.

### Duration of works

We will be at work on the road from Wednesday 25 September until early November 2019.

Our working hours will be between 8.00am and 6.00pm from Monday to Friday, and between 8.00am and 1.00pm on Saturdays. We might be on site for up to one hour before or after to set up or pack up.

Some noise from on-site vehicles during working hours, and potential traffic delays nearby during peak times.
