High Speed Two (HS2) is the new high speed railway for Britain. MLP Pipelines, who operate a fuel distribution network, we will be diverting one of their mains to allow for the construction of the new railway. To allow us to plan the movement of the mains and have a full understanding of local ground conditions, we will need to carry out surveys in the area. These surveys will take place during June 2019.

What are we doing?

MLP Pipelines will be carrying out a diversion to an existing mains, in the Curdworth area. In order to help us plan the diversion we need to carry out trial excavations to establish the exact locations of existing underground utilities.

To carry out these investigations will be using trial pits and boreholes. The work should being during the week of 24 June 2019 and last for approximately four weeks.

How will this affect you?

These works should not cause disruptions to any roads. You will see workers in the field near the Birmingham and Fazeley Canal and Marston Lane. Once the works are completed we will reinstate the areas and remove all equipment from the site.
