



# **Notice of Abnormal Load Movements**

High Speed Two (HS2) is the new high speed railway for Britain.

### Who is Eiffage Kier?

Eiffage Kier is the contractor carrying out the civil engineering works for the new HS2 line. Eiffage Kier will undertake all earthworks and landscaping as well as creating new structures including bridges, viaducts and green tunnels.

### What are we doing?

As part of HS2's early works, we will be carrying out earthworks excavations using large construction machinery comprising excavators, bulldozers and dump trucks. These vehicles will be delivered to site under escort during mid-May and June 2019.



#### What route will be used?

Following assessment, the route selected has been assessed as being the most suitable to take the abnormal loads and will travel along the following route:

- 1. From junction 11 of the M40 north along the A361 through Wardington and Chipping Warden.
- 2. Turn left onto the Welsh Road passing Aston Le Walls and along the Banbury Road through Lower Boddington.
- 3. Turn right onto Stoneton Lane followed by an immediate left into our site entrance.

### What to expect

Abnormal loads travelling from the M40 junction 11 to our construction site near Wormleighton.

## **How many vehicles** are involved?

In total around twenty construction vehicles loaded on the back of low loaders are being transported slowly to our construction site and will be under the control of an escort vehicle.

# When will the vehicles pass through?

The deliveries will take place during mid-May and June. The vehicles will not come all at once but be delivered in stages over a number of days.

## Will the roads be closed?

Roads won't be closed though the escorts will be responsible for ensuring that the vehicles are transported safely along the highway.
