Eligible entrants:	Entry is only open to Australian residents who are 13 years and over. Entrants must be available to travel to Melbourne or Sydney to take part in the VIP Photoshoot Experience. Entrants under the age of 18 must have parent or legal guardian approval to enter.

1. Any capitalised terms used in these Conditions of Entry have the meaning given in the Schedule, unless stated otherwise.
2. The Promotion commences on the Start Date and ends on the End Date ("Promotional Period"). Entries are deemed to be received at the time of receipt by the Promoter and not at the time of transmission or deposit by the entrant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.
3. Valid and eligible entries will be accepted during the Promotional Period.
4. 5. **Judging:**
 - a. **Finalists (12 total – 1 per Monthly Period):** The Finalists will be determined by representatives of the Promoter. Each entry will be judged on the basis of the individual creative merit of the Photo submitted on entry. The best valid entry for each Monthly Period, as determined by the judges, will win the Finalist prize specified above.
 - b. **VIP Photoshoot Experience (to be awarded to 6 Finalists only):** 6 of the 12 Finalists will also be awarded a VIP Photoshoot Experience. See Finalist Bonus Prize in schedule above for prize details. The bonus prize will be awarded

- to 6 Finalists only whose entries are deemed noteworthy based on the creative merit of the Finalist's Photo submission. The Bonus Prizes will be awarded at the Promoter's discretion throughout the Promotional Period.
- c. **Major Winner:** The best of the twelve (12) finalists as assessed by a representative of the Promoter at the VIP Photoshoot Experience, based on their love of glasses and overall participation on the day, will be deemed the Major Prize winner and will in addition to the Finalist prize, also receive the Major Prize.
 - d. The judges may select additional reserve entries which they determine to be the next best, and record them in order, in case of an invalid entry or ineligible entrant.
 - e. The winners/finalists will be determined by skill. Chance plays no part in determining the winners/finalists. The judges' decision is final and binding and no correspondence will be entered into.

If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize.
18. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). 20. The Promoter reserves the right to disqualify entries in the event of non-compliance with these Conditions of Entry. In the event that there is a dispute concerning the conduct of the Promotion, the decision of the Promoter is final and binding on each entrant and no correspondence will be entered into.
21. The Promoter and its associated agencies and companies will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence or wilful misconduct) in connection with this Promotion or accepting or using any prize (or recommendation), except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).
