We saw there were plans to carry out a full risk assessment of the practice premises. Managers used a confidential health questionnaire for all new employees to ensure staff working conditions were suitable.

The practice used a suite of online training programmes designed to ensure all staff training was completed in a timely and comprehensive way. Staff had started this training and we saw further protected time was allocated to complete the programme.

The principal GP was supervising an experienced pharmacist who had worked in the community and the hospital to undertake a local university prescribing course. This pharmacist was also training at regular intervals in the practice to understand the role of acting as a pharmacist within general practice. The practice planned to employ them as a clinical pharmacist in the practice when training was complete.

Any additional evidence

From practice unverified data, we saw evidence of improvement for all areas of QOF. The practice had recruited an additional practice nurse and at the time of our inspection, a new staff member had been recruited to work after a period of further training and supervision as a practice healthcare assistant and the medicines co-ordinator for the practice. Because of the increase in clinical resources, there was greater capacity to offer reviews to patients. To engage further with patients requiring a review of their long-term conditions, the principal GP had focused on patients who had complex needs or were frequent non-attenders for appointments and these patients had been invited for a review at weekly "QOF clinics".

The practice had reviewed the register of patients with hypertension and were planning further register reviews to ensure all patients with chronic disease had been identified. They had increased the number of patients on the hypertension register from 183 in September 2017 (5% of the patient list) to 243 (7%) at the time of our inspection.

We saw four comments that said staff were kind, helpful and polite, however, there were also four comments that indicated staff could be rude to patients. The practice had discussed these comments with staff and had replied online to the patients offering an apology and an opportunity to discuss it further with the practice.
NHS Choices	We saw evidence of patient feedback from four patients that said specifically that the principal GP always listened to them. Patients also commented they did not feel rushed during their appointment and they felt the GP was approachable.
Comments cards	We saw 28 cards that specifically praised the friendly and caring nature of staff at the practice. Patients commented staff were helpful and sympathetic and always did their best for patients.

Additional comments:

The practice had produced an action plan from the survey results. To address this:

- They had implemented a surgery website and a dedicated social media page to improve patient communication;
- They increased the number of GP appointments available to patients and ensured there were both male and female GPs available;
- They purchased a new telephone system to improve access;
- They increased clinical staff resources by employing a new practice nurse and a healthcare assistant;
- They commenced supervising the training of a clinical pharmacist for future employment at the practice;
- They submitted a bid to the clinical commissioning group (CCG) for increased space for the practice in the building to be able to increase service provision.

Examples of feedback received from patients:

Source	Feedback
NHS Choices	At the time of our inspection, we saw there had been 11 comments posted on the practice site between 1 January and 30 April 2018. Of these, nine comments mentioned access to the practice or the service overall. Four of these comments were negative. One patient said telephone access was difficult and three said getting an appointment with a GP was hard. However, two patients said they could make an appointment easily and patients said they felt the service had greatly improved under the new provider.
Comment cards	Two comment cards said patients sometimes waited for an appointment with a specific GP, however, 12 cards praised all aspects of the service and a further eight cards specifically mentioned getting an appointment was no problem.
Interviews with patients	Patients we spoke to said occasionally they could wait a short time to see the GP of their choice however, they also said when they needed to be seen they could always get an appointment.

^{*} The practice had received one complaint since the new provider had started in November 2017. This complaint was passed to the practice for information by NHS England (NHSE) as the complainant had contacted NHSE in the first place. The practice noted it had taken some time to receive the complaint from NHSE and apologised immediately directly to the patient for the delay. They dealt with the complaint according to the practice policy and made a response to NHSE to respond to the patient as per the policy.

Well-led

Leadership capacity and capability

Example of how leadership, capacity and capability were demonstrated by the practice

When the new provider had taken over the practice in November 2017, there had been a complete review of the practice services including governance systems, staffing and the practice presence and standing in the community, led by the principal GP.

The practice had been "rebranded"; it had been renamed, a new practice logo had been commissioned, staff had been given uniforms and name badges, governance systems had been improved and further clinical staff employed.

Vision and strategy

Practice Vision and values

The practice had a vision statement which was:

"To provide quality health services and facilities for the practice population in order to contribute in the creation of healthier lives within the community.

We aim to be a supportive team and create a friendly environment for patients, employees and clinical staff.

We strive to deal with all patients in a professional and polite manner".

All staff at the practice had contributed to the content of this statement.

Culture

Examples of feedback from staff or other evidence about working at the practice

	Staff we spoke to told us they felt they were a good team that worked well together, helped each other and were supported by management. Any additional evidence

The principal GP was supervising an experienced pharmacist to undertake a local university prescribing course. This pharmacist was also training at regular intervals in the practice to understand the role of acting as a pharmacist within general practice. The practice planned to employ them as a clinical pharmacist in the practice when training was complete.

Due to increased staffing and to support more involvement with the local community, the practice had put in a bid for more rooms in the health centre with the CCG.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a z-score, a statistical tool which shows the deviation from the England average. It gives us a statistical measurement of a practice's performance in relation to the England average, and measures this in standard deviations. We calculate a z-score for each indicator, thereby highlighting the practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are +2 or more or -2 or less are at significant levels, warranting further enquiry.

N.B. Not all indicators are part of the GP insight set and those that aren't will not have a variation band.

The following language is used for banding variation:

Significant variation (positive)

- Variation (positive)
- Comparable to other practices
- Variation (negative)
- Significant variation (negative)

Note: for the following indicators the variation bands are different:

• Child Immunisation indicators. These are scored against the World Health Organisation target of 95%.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
