Explanation of any answers:	

*The extra care service offers 15-minute pre-bookable, routine primary care appointments with GPs and nurses to patients already registered with any of the 30 GP practices in the Gateshead area. Patients book an appointment through their own, or 'home' GP practice. The home practices are aware that they should not book extra care appointments in certain circumstances. This includes patients who may require an onward referral or those with long term conditions, or chronic diseases, where the reason for the appointment is directly related to their condition.

Due to the nature of the extra care service any patient who required a referral to a secondary care service or tests were sign posted back to their own or 'home' GP practice (with the exception of some swabs or urine tests for microbiology testing which were carried out at the extra care facilities). Their records were updated accordingly and patients were told to follow this up with their own GP practice.

The exception to this was where extra care GPs felt patients needed an urgent referral for suspected cancer under the two-week weight rule. In these circumstances the consulting GP would put a note on the patients record and ask the receptionist to alert the patient's usual GP practice the following day (or on the following Monday if the consultation had taken place on a Saturday or Sunday) that a 2WW referral was required. However, there was no effective system in place to alert the patient's own GP that the patient

required further investigation or referral to another service. Nor was there any system to check that required referrals and tests had been undertaken.

The provider currently uses an intranet system, email and a website to share details of all patient safety alerts with clinicians who work for the service. The registered manager told us that they were in the process of implementing Share Point (a web based document management system) to aid better communication with staff and that this was due to go live approximately January 2019. Pharmacists employed by the provider dealt with all medicines related patient safety alerts and a system was in place to ensure these were actioned appropriately across all provider locations.

Staff working for the service were given an induction. A comprehensive induction pack was available on site.

Locum GPs who worked on a sessional basis and nurses who worked for the service were not given the opportunity of an appraisal. The registered manager told me that they were in the process of introducing appraisal for their salaried GPs. All GPs and nurses who worked for the service had access to the providers clinical lead and a pastoral GP who they could contact for advice and support. Clinicians were also able to access a social media application where they could seek advice, support and guidance from other GP's working for the provider.

Any additional evidence

In March 2016, the provider had also surveyed GPs who worked for the extra care service:

- 17 (71%) responded to the survey
- 94% felt that 15 min appointments were appropriate
- 42% felt that demand for Sunday appointments could be improved
- 75% felt that access to a patient's full patient records was extremely beneficial (a further 19% felt this was beneficial)
- Inappropriate bookings included patients requesting referral to specialist services; management of chronic diseases; requests for repeat medication and requests for sicknotes.

The registered manager told us that they were continually reinforcing appointment criteria with referring practices and a handbook was available in each practice with further details.

The service offers 15-minute pre-bookable, routine primary care appointments with a GP to patients already registered with any of the 30 GP practices in the Gateshead area (total patient population 222,000). They do not offer appointments for:

- Patients with long term conditions, or chronic diseases, where the reason for the appointment is directly related to their condition should be booked into the service.
- Patients with complex mental health issues, where the reason for the appointment is directly related to their condition.
- Cases of alcohol or substance misuse.
- Patients who require a sick note.
- Repeat medication requests.
- Patients who might require an onward referral.
- · Patients who have not agreed to "data sharing".
- Patients who are known to be aggressive/violent.
- Nurse appointments for patients under 18 years of age
- Patients on maggot therapy

Patients access appointments via their 'home' or usual GP practice. The extra care facilities also offer a nurse led wound dressing service on a weekend. 50% of appointments were pre-booked and the remaining 50% were same day appointments.

Two stated that support could be better in some areas and one reported that they did not feel supported or valued All felt that clinicians, non-clinical staff and management worked well together
Telephone interview with member of the nursing team	The member of staff stated that they felt well supported for their role in the extra care service and had a point of contact with the provider who they could contact at any time they were working for the service. They also stated that they felt staffing levels were sufficient and that they had the training and equipment they needed to perform their roles. However, when questioned they were not able to describe any process for sharing information such as learning from significant events and complaints or best practice guidance. Nor did they receive any supervision or appraisal for their role with CBC health. The registered manager told us that as the nursing staff were from community services and the clinical lead for community services was employed by CBC Health they felt there was no need to carry out an additional appraisal.
Feedback from GP	Feedback from one Gateshead based GP about the extra care facilities was that it provided a pressure valve and that they felt assured consultations would be carried out by good quality doctors, that they would be good solid consultations and would not require further follow up. Another stated that it was 'an excellent support service to GP practices in

	The registered manager was able to describe how the provider had been supportive of staff during times of illness and difficult personal circumstances. Staff had access to occupational health services. GPs working for the services had access to a pastoral GP whose role included supporting and mentoring GPs, particularly during times of pressure and stress.

Examples of actions to improve quality in past 2 years

Area	Impact
General prescribing audit – July 2017 to June 2018	The aim of the audit was to consider whether patients could have been managed effectively without the need for a GP appointment. It did not look at the appropriateness of medicines prescribed. During the period in question 6069 prescriptions were issued. The audit revealed that:
	The three most frequently prescribed medicines could easily have been prescribed under the Think Pharmacy First scheme.
	 30% of prescriptions under the respiratory category were for antihistamines which could have been bought over the counter or recommended by a pharmacist.
	 1199 (under 20%) of prescriptions were for a clinical condition that could have been routinely managed by a community pharmacist.
	The conclusion of the audit was that more effective triaging of patients when booking an appointment would have resulted in less demand for GP appointments and more signposting to the Think Pharmacy First scheme.

Antibiotic audits (Sept/Oct 2015; Nov 16 to Jan 17; Nov 17 to Jan 18)

Antibiotic audit – Sept/Oct 2015

- 269 oral antibiotics had been prescribed during this period.
- 48% of the prescriptions were not for an appropriate course length.
- 55% of the prescriptions did not adhere to best practice guidance either in terms of choice or length of course.

Antibiotic audit – Nov 16 to Jan 17

- 863 oral antibiotics had been prescribed during this period.
- The audit showed that best practice course length was not being adhered to when prescribing amoxicillin. In addition, amoxicillin was being wrongly prescribed for otitis media against best practice guidance.

Antibiotic audit – Nov 17 to Jan 18

- 695 oral antibiotic prescriptions were issued during this period.
- A random selection showed that 39% of the prescriptions were for amoxicillin.
- There had been a reduction in general antibiotic prescribing by 18% since the previous audit.
- 79% of prescriptions were for an inappropriate course length
- 55% of prescriptions did not conform to best practice guidance.

However, there was no evidence of the learning from these audits being shared with staff or discussed with individual clinicians.

Audit of written consultation records

The aim of the audit was to ensure that consultation records were of a consistently high standard and included an adequate clinical history, record of examination findings, working diagnosis, appropriate prescribing and evidence of safety netting/follow up arrangements.

19 records were reviewed which related to 6 clinicians. The findings were that:

- 18 of the 19 records showed a working diagnosis.
- All prescriptions were felt to have been appropriate
- The conclusion was that the consultations were safe and that the patient could be effectively managed using the written notes in all cases.

Examples of service developments implemented in past 2 years

Development area and impact

The provision of the extra care facilities had started as a pilot scheme in 2015. Originally it was anticipated that the extra care services would be delivered from three locations but the outcome of the pilot was that this was not feasible or sustainable. They had also piloted a home visiting service but

found that the 55-square mile coverage area was too big to manage, particularly during the rush hour. In addition, the service aimed to deliver additional weekday nurse appointments nurse. However, the pilot revealed that there was little demand for these appointments. This was therefore changed to a weekend wound management clinic which was introduced at the request of the local clinical commissioning group to ensure patients were able to access wound care services over a weekend.
