Overall rating: Good

At the last inspection in January 2018 we rated the practice as requires improvement for providing safe and well-led services because:

- Diagnoses were not always clearly recorded in the patient records.
- Prescription stationary was not monitored appropriately.
- Actions identified by infection control risk assessments were not always clearly recorded or completed.
- Disease registers were not always accurate or up to date.
- Patients who were approaching end of life were not clearly identified.
- Concerns regarding poor performance were not addressed in a timely manner.

At this inspection, we found that the provider had satisfactorily addressed these areas and is now rated good overall.

Staff had appropriate knowledge of treating older people including their psychological, mental and communication needs.

<ul style="list-style-type: none"> • Patients with long-term conditions had a structured annual review to check their health and medicines needs were being met. For patients with the most complex needs, the GP worked with other health and care professionals to deliver a coordinated package of care. • Staff who were responsible for reviews of patients with long-term conditions had received specific training. • GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma. • The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension. • Adults with newly diagnosed cardio-vascular disease were offered statins. • Patients with suspected hypertension were offered ambulatory blood pressure monitoring, through a local practice that the surgery had links with. • Patients with atrial fibrillation were assessed for stroke risk and treated appropriately.

- Regular audit of clinical records had improved the coding of diagnoses clearly within the patient records.
- A repeat cycle audit of antibiotic prescribing delivered and maintained improvement in meeting local prescribing guidelines. In the first cycles, 16 patients were identified who had not been

prescribed antibiotics in line with the local prescribing guidelines. The latest audit identified only two patients who did not meet local prescribing guidelines. One of these had been prescribed at the request of hospital consultant and the other was appropriately prescribed due to a complicated presentation.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique we can be 95% confident that the practice's performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

The following language is used for showing variation:

- Child Immunisation indicators. These are scored against the World Health Organisation target of 95% rather than the England average.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
