We rated the practice as **requires improvement** for providing safe services because:

- The practice did not have appropriate systems in place for the safe management of medicines. This was in respect of the monitoring of prescribed high-risk medicines and acting in accordance with patient safety alerts related to medicines.

All staff undergo safeguarding update training annually and at a level appropriate to their role.</p> <p>Policies and procedures had been reviewed and updated to include information on identifying and reporting female genital mutilation (FGM), Child sexual exploitation (CSE) and Prevent (support to people at risk of joining extremist groups and carrying out terrorist activities). Staff demonstrated good knowledge and awareness in respect of safeguarding.</p> <p>The practice had identified their vulnerable patients and alerts were in place. Alerts were also placed on the records of patients and their families where protection concerns had been identified. GPs attended safeguarding meetings if possible and submitted reports where relevant.</p>

<p>Explanation of any answers and additional evidence:</p> <p>We found that medical equipment in two of the GPs bags had not been serviced/calibrated. The practice told us that following the inspection, these items had been removed from use until they had been calibrated.</p>

<p>Explanation of any answers and additional evidence:</p> <p>We examined a sample of records relating to risk assessment and premises and equipment checks.</p> <p>A health and safety policy was in place, the practice had recently completed a risk assessment in relation to health and safety issues identified.</p> <p>There was an up to date fire risk assessment in place.</p> <p>Electrical safety tests had identified areas that were not satisfactory. We saw evidence that remedial action was planned to take place to address these.</p> <p>The practice is situated within a purpose-built health centre. The premises were managed and</p>	

maintained under contracts by a facilities management company.

Premises security risks had been identified and discussed at meetings with the facilities management company. A formal risk assessment had recently been developed and implemented.

Clinical cleaning schedules were also in place in clinical rooms.</p> <p>Infection control and prevention posters were in clinical rooms.</p> <p>Spillage kit available in key areas of the practice.</p> <p>Staff had received hand washing updates and training updates in infection prevention and control.</p> <p>A Legionella risk assessment had been undertaken in December 2018. We saw evidence of recent water temperature testing records documented by the maintenance team.</p>

<p>Explanation of any answers and additional evidence:</p> <p>Staff said the division of labour was well organised at the practice to allow for cover and support where required. All clinicians had access to a validated sepsis tool through the IT system. Staff had undertaken training in awareness of sepsis and there was guidance for staff to refer to, they demonstrated a good understanding.</p>

<p>Explanation of any answers and additional evidence:</p> <p>When referrals were made (including a two-week referral), an explanation was given to patients about why an urgent referral had been made and the action to be taken if an appointment was not received within two weeks. (The two-week appointment system was introduced so that any patient with symptoms that might indicate cancer, or a serious condition such as cancer, could be seen by a specialist as quickly as possible).</p>	

The practice did not currently receive information regarding patients, including children, when they did not attend for their appointment in secondary care. Following the inspection, the practice told us they would be implementing new processes to monitor and review patients who do not attend.

<p>Explanation of any answers and additional evidence:</p> <p>Medicines fridges were monitored with the minimum and maximum temperatures documented. Fridges were serviced annually. The cold chain policy was displayed and staff were aware of what to do in the event of disruption in the cold chain.</p> <p><i>(The 'cold chain' is a term used to describe the cold temperature conditions in which certain products need to be kept during storage and distribution. Maintaining the cold chain ensures that vaccines are transported and stored according to the manufacturer's recommended temperature range of +2°C to +8°C until the point of administration.)</i></p> <p>Prescription pads were logged into the practice on receipt and with details of which room they were taken to, however printer script papers were left in printer drawers when the room was not occupied including overnight.</p> <p>We found some uncollected prescriptions that had been waiting for collection over a month. The practice assured us they would investigate the cause of them not being collected and put in place a protocol to monitor these.</p> <p>The practice had appropriate medicines, oxygen, pulse oximeters and an automated external defibrillator in place for medical emergencies. We saw evidence of regular documented checks on these.</p> <p>We identified that reviews of patients had not occurred in line with national guidance to ensure appropriate prescribing of medication in accordance with patient safety alerts. We saw evidence that a patient safety alert regarding the prescribing of Sodium Valproate had not been acted upon appropriately in the case of the identified patients.</p> <p>We found that patients on high risk medications, for example, Methotrexate and Sodium Valproate had not been reviewed appropriately or as required. We saw that some patients on Methotrexate therapy had not received monitoring and reviews as per guidance.</p>

Any additional evidence or comments

- The average daily quantity of hypnotics prescribed was much higher than local and national averages. The practice was considering reviewing the prescribing of these items to identify cause and reduce quantities prescribed.

Older people

Population group rating: Good

Findings

- The practice used a clinical tool to identify older patients who were living with moderate or severe frailty. The practice worked with the local frailty team and those identified received a full

assessment of their physical, mental and social needs.

- The practice followed up on older patients discharged from hospital. It ensured that their care plans and prescriptions were updated to reflect any extra or changed needs.
- Staff had appropriate knowledge of treating older people including their psychological, mental and communication needs.
- Health checks were offered to patients over 75 years of age.
- The practice worked with other organisations such as Age UK to develop initiatives to improve care and treatment for older people.

People with long-term conditions

Population group rating: **Good**

Findings

- Patients with long-term conditions had a structured annual review to check their health and medicines needs were being met. For patients with the most complex needs, the GPs and nurses worked with other health and care professionals to deliver a coordinated package of care.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were assessed and offered statins according to protocols.
- Patients with suspected hypertension were offered ambulatory blood pressure monitoring.
- Patients with atrial fibrillation were assessed for stroke risk and treated appropriately.

Findings

- Childhood immunisation uptake rates were in line with, and in one case, above the World Health Organisation (WHO) targets.
- The provider told us about their system in place to monitor and encourage children to receive the required immunisations. When appointments were missed the practice took appropriate action by offering opportunistic immunisations, contacting parents and offering flexible appointments. Non-attenders were discussed at clinical meetings, safeguarding meetings and with the health visiting service who were also informed of non-attendance and uptake concerns.
- The practice did not have arrangements for following up failed attendance of children's appointments following an appointment in secondary care
- Young people could access services for sexual health and contraception.
- Contraceptive advice, support and treatments were provided.
- Children under the age of 10years old were offered a same day appointment.

Patients had access to appropriate health assessments and checks including NHS checks for patients aged 40 to 74. There was appropriate and timely follow-up on the outcome of health assessments and checks where abnormalities or risk factors were identified. Patients could book or cancel appointments online and order repeat medication without the need to attend the surgery.

Any additional evidence or comments

- The practice's uptake for cervical screening was below the 80% coverage target for the national screening programme. To increase coverage of cervical screening the practice offered morning and evening appointments, opportunistic screening, alerts were placed on patient records and the importance of this screening was publicised at the practice.

People whose circumstances make them vulnerable

Population group rating: Good

Findings

- End of life care was delivered in a coordinated way which took into account the needs of those whose circumstances may make them vulnerable.
- The practice held a register of patients living in vulnerable circumstances including those who misused drugs and alcohol and those with a learning disability. They were able to work with and signpost these patients to local support services.
- The practice had a system for vaccinating patients with an underlying medical condition according to the recommended schedule.
- Alerts were placed on the records of patients who needed additional support, for example, if they were unable to read, needed assistance in decision making or needed an interpreter service.
- The practice demonstrated that they had a system to identify people who misused substances.

**People experiencing poor mental health
(including people with dementia)**

Population group rating: Good

Findings

- The practice maintained a register of patients who experienced poor mental health. The register supported clinical staff to offer patients experiencing poor mental health, including dementia, an annual health check and a medication review.
- The practice assessed and monitored the physical health of people with mental illness, severe mental illness, and personality disorder by providing access to health checks, interventions for physical activity, obesity, diabetes, heart disease, cancer and access to 'stop smoking' services.
- There was a system for following up patients who failed to attend for administration of long-term medication.
- Patients at risk of dementia were identified and offered an assessment to detect possible signs of dementia. When dementia was suspected there was an appropriate referral for diagnosis.
- The practices performance on quality indicators for mental health were in line with and above local and national averages.
- Staff had received dementia awareness training.

There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

The following language is used for showing variation:

	Variation Band	Z-score threshold
1	Significant variation (positive)	$Z \leq -3$
2	Variation (positive)	$-3 < Z \leq -2$
3	No statistical variation	$-2 < Z < 2$
4	Variation (negative)	$2 \leq Z < 3$
5	Significant variation (negative)	$Z \geq 3$
6	No data	Null

Note: for the following indicators the variation bands are different:

- Child Immunisation indicators. These are scored against the World Health Organisation target of 95% rather than the England average.
- The percentage of respondents to the GP patient survey who responded positively to how easy it was to get through to someone at their GP practice on the phone uses a rules based approach for scoring, due to the distribution of the data. This indicator does not have a CCG average.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.

- **COPD:** Chronic Obstructive Pulmonary Disease
- **PHE:** Public Health England
- **QOF:** Quality and Outcomes Framework
- **STAR-PU:** Specific Therapeutic Group Age-sex weightings Related Prescribing Units. These weighting allow more accurate and meaningful comparisons within a specific therapeutic group by taking into account the types of people who will be receiving that treatment.
