#### Findings

- The practice used a clinical tool to identify older patients who were living with moderate or severe frailty. Those identified received a full assessment of their physical, mental and social needs.
- The practice followed up on older patients discharged from hospital. It ensured that their care plans and prescriptions were updated to reflect any extra or changed needs.
- Staff had appropriate knowledge of treating older people including their psychological, mental and communication needs.
- Health checks were offered to patients over 75 years of age.
- The practice conducted home visits when required and was one of the lowest users of the medical response team in the Clinical Commissioning Group (CCG), evidence that the cared for their own

patients wherever possible.

- The practice hosts a weekly community audiology clinic which is mainly used by people from this group.
- The practice ran a weekly ward round at a local nursing home to look after the elderly patients who had extra care needs.

## People with long-term conditions

## Population group rating: Good

### Findings

- Patients with long-term conditions had a structured annual review to check their health and medicines needs were being met. Where possible reviews are synchronised to avoid multiple appointments. For patients with the most complex needs, the GP worked with other health and care professionals to deliver a coordinated package of care.
- The practice had three GPs and one nurse with advanced diabetes training so was able to participate fully in Advance Primary Care diabetes programme.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins. Patients with suspected hypertension were offered ambulatory blood pressure monitoring.
- Patients with atrial fibrillation were assessed for stroke risk and treated appropriately.

- The practice had arrangements to identify and review the treatment of newly pregnant women on long-term medicines. These patients were provided with advice and post-natal support in accordance with best practice guidance.
- The practice had arrangements for following up failed attendance of children's appointments following an appointment in secondary care or for immunisation and would liaise with health visitors when necessary.
- Young people could access services for sexual health and contraception.
- Since 2011 the practice has seen a rise in the number of young families registered and has therefore taken Child Health Services (CHS) back in house.

- Patients had access to appropriate health assessments and checks including NHS checks for patients aged 40 to 74. There was appropriate and timely follow-up on the outcome of health assessments and checks where abnormalities or risk factors were identified.
- Patients could book or cancel appointments online and order repeat medication without the need to attend the surgery.
- There was a wide range of appointments times, useful for patients of working age, including early morning, evening and on Saturdays.

## Findings

- End of life care was delivered in a coordinated way which took into account the needs of those whose circumstances may make them vulnerable.
- The practice held a register of patients living in vulnerable circumstances including homeless people, travellers and those with a learning disability.
- The practice had a system for vaccinating patients with an underlying medical condition according to the recommended schedule.
- The practice demonstrated that they had a system to identify people who misused substances.
- The practice reviewed young patients at local residential homes.

## People experiencing poor mental health (including people with dementia)

## Findings

- The practice assessed and monitored the physical health of people with mental illness, severe mental illness, and personality disorder by providing access to health checks, interventions for physical activity, obesity, diabetes, heart disease, cancer and access to 'stop smoking' services.
- There was a system for following up patients who failed to attend for administration of long-term medication.
- When patients were assessed to be at risk of suicide or self-harm the practice had arrangements in place to help them to remain safe.
- Patients at risk of dementia were identified and offered an assessment to detect possible signs of dementia. When dementia was suspected there was an appropriate referral for diagnosis.
- One of the partners is the CCG lead for dementia. Under their guidance the practice has improved its diagnosis rate for dementia. The practice's percentage rose from 40% to 90% of what would be expected in such a practice. All staff had received dementia training.

- Patients with multiple conditions had their needs reviewed in one appointment.
- The practice liaised regularly with the local district nursing team and community matrons to discuss and manage the needs of patients with complex medical issues.
- Care and treatment for people with long-term conditions approaching the end of life was coordinated with other services.
- The practice provided enhanced diabetic care, it was able to initiate insulin treatment. Therefore, these patients did not have to attend secondary care for this intervention

## **Families, children and young people**

**Population group rating: Good**

### **Findings**

- Flexible appointments were available on the day so that school age children did not need to miss school.
- We found there were systems to identify and follow up children living in disadvantaged circumstances and who were at risk, for example, children and young people who had a high number of accident and emergency (A&E) attendances. Records we looked at confirmed this.
- All parents or guardians calling with concerns about a child were offered a same day appointment when necessary.
- Parents with concerns regarding children under the age of 10 could attend a drop-in clinic held at the same time as the twice weekly baby clinic.
- There was a Sexual Health service, including Chlamydia testing, with particular attention paid to the screening of men.
- There was free condom availability.

## **Working age people (including those recently retired and students)**

**Population group rating: Good**

### **Findings**

- The needs of this population group had been identified and the practice had adjusted the services it offered to ensure these were accessible, flexible and offered continuity of care.
- The practice was open from 7am four morning a week. Pre-bookable appointments were also available to all patients at additional locations within the area, as the practice was a member of a cooperative service. There was some Saturday morning opening based on demand. Evening opening alternates between different days every other week.

**People whose circumstances make them vulnerable**

**Population group rating: Good**

**Findings**

- The practice held a register of patients living in vulnerable circumstances including homeless people, travellers and those with a learning disability.
- People in vulnerable circumstances were easily able to register with the practice, including those with no fixed abode.
- The practice adjusted the delivery of its services to meet the needs of patients with a learning disability.
- The practice was an IRIS accredited practice (IRIS is a general practice-based domestic violence and abuse training support and referral programme) and both clinical and administrative staff have been involved in domestic violence awareness training. The practice registered patients who had fled their homes to a local refuge. The practice realised that some of these patients would not have the usual forms of identity on them. Therefore, they were supported to register without them.
- Same day appointments were often used by patients with more chaotic lifestyles. Telephone appointments are often also used by these groups.
- The practice looked after the residents of a local sheltered accommodation for people with learning difficulties) and all these patients were offered regular appointments.

Members of the patient participation group (PPG) told us that their meetings were structured, minuted and constructive. An area where their contribution had been heard, for example was in the wide range of appointments that the practice offered. This was especially useful for patients of working age, and included early morning, evening and Saturday clinics. The PPG had conducted surveys of the patients and it was from that that the appointments had been developed.

Examples of continuous learning and improvement
The practice had been proactive in the NHS Health Check Programme and the practice manager had helped advise the local Public Health team on how to increase the uptake of these checks within the Bromley area.
The practice was committed to testing innovation. At the request of the PPG the practice had commenced Patient Online access before the national scheme was launched. The practice was also a pilot for both Summary Care Records and electronic prescribing. The practice manager had sat on the local implementation board so that the experiences of the practice could be shared to ensure a smooth roll out of both initiatives the area.
One of the partners has considerable expertise in dementia care. They have also supported other clinicians at the practice to improve the quality of dementia care. They have successfully taken this

approach out to other local practices to enable to them to also improve their care. So that all patients within the CCG benefit from this expertise.

The practice had recently recruited patients for a study into the decision making of taking antidepressants during pregnancy.

#### Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique we can be 95% confident that the practice's performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

- The percentage of respondents to the GP patient survey who responded positively to how easy it was to get through to someone at their GP practice on the phone uses a rules based approach for scoring, due to the distribution of the data. This indicator does not have a CCG average.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
