Older people

Population group rating: Good

- The practice used a clinical tool to identify older patients who were living with moderate or severe frailty. Those identified received a full assessment of their physical, mental and social needs.
- Hand held care plans were offered to all those with a care plan so that they could be shared with

other relevant professionals when needed.

- The practice followed up on older patients discharged from hospital. It ensured that their care plans and prescriptions were updated to reflect any extra or changed needs.
- Staff had appropriate knowledge of treating older people including their psychological, mental and communication needs.
- Health checks were offered to patients over 75 years of age.
- All elderly patients not seen within a six month period were contacted by the practice to see if they had any issues.
- All patients over the age of 65 who attended for a flu vaccination were offered a pulse check to screen for atrial fibrillation.
- One of the GPs recently sent a communication to all their local care and nursing homes to remind them of a certain group of medicines that may cause acute kidney injury (AKI) and what to do if a patient became unwell to try and reduce the development of AKI.

People with long-term conditions

Population group rating: Good

- Patients with long-term conditions had a structured annual review to check their health and medicines needs were being met. For patients with the most complex needs, the GP worked with other health and care professionals to deliver a coordinated package of care.
- Each clinical area had a lead GP or nurse.
- The practice offered pre-diabetic screening followed up by appropriate advice and support.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins.
- Patients with suspected hypertension were offered ambulatory blood pressure monitoring.
- The practice used a monitor to support the detection of atrial fibrillation (AF) and those patients who were found to have AF were assessed for stroke risk and treated appropriately.
- The practice offered personalised care plans to all patients with a long-term condition to encourage self- management through joint development of the plan with the patient.
- All patients with a long-term condition and at end of life were discussed in multi-disciplinary team meetings and were under regular review by the community matron.
- The practice provided monitoring of patients who were prescribed disease modifying anti-rheumatic drugs (DMARDs), supporting care closer to home.
- Three of the G.Ps were trained in use of a dermatoscope, which the practice used for the

assessment of moles and to aid diagnosis of melanoma.

- End of life care was delivered in a coordinated way which took into account the needs of those whose circumstances may make them vulnerable.
- The practice held a register of patients living in vulnerable circumstances including homeless people, travellers and those with a learning disability.
- The practice had a system for vaccinating patients with an underlying medical condition according to the recommended schedule.
- The practice demonstrated that they had a system to identify people who misused substances. A drug liaison worker proved support to the practice.
- The practice reviewed young patients at local residential homes.
- The practice worked with the local police service where it was concerned that welfare visits may be necessary.
- The practice had been allocated a focused care worker who supported those vulnerable patients who had issues of social isolation or needed support with financial or benefits issues.
- Military veterans were identified by the practice who held a 'tea & mince pies' session, supported
 by the local 'Veterans in Community' worker. Over 40 people attended and several were now
 regular attenders at the breakfast club and other social events, thus reducing their social isolation.

People experiencing poor mental health (including people with dementia)

Population group rating: Good

- The practice assessed and monitored the physical health of people with mental illness, severe mental illness, and personality disorder by providing access to health checks, interventions for physical activity, obesity, diabetes, heart disease, cancer and access to 'stop smoking' services.
- There was a system for following up patients who failed to attend for administration of long-term medication.
- When patients were assessed to be at risk of suicide or self-harm the practice had arrangements in place to help them to remain safe.
- The practice had an agreed practice formulary for the prescribing of anti-depressants where it was appropriate.
- Patients at risk of dementia were identified and offered an assessment to detect possible signs of dementia. When dementia was suspected there was an appropriate referral for diagnosis.
- All staff had received dementia awareness training in the last 12 months and had become Dementia Friends.

- The practice actively took part in piloting different projects with the CCG before they were rolled out to other practices, for example, CRP testing and D Dimer testing which is a test for blood clots.
- The practice supported some of its patients in becoming Expert Patients who then held self-management courses in the practice for other patients to help them live healthier lives. The practice was a finalist in the Neighbourhood Innovation Awards 2018 due to this work.
- The practice was working with the local hospice around end of life care.
- They had purchased a vascular doppler to test for peripheral arterial disease. In carrying out the
 test in the surgery this would reduce referrals to hospital and bring care closer to home. We were
 told that due to their success other practices had been given the funds to purchase the same
 equipment.
- One of the partners is a non-executive (voluntary) director on the local Springhill Hospice Trust Board.
- One of the partners is a member of two of the Heywood Middleton and Rochdale CCG borough wide committees who look at quality improvement of services.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique we can be 95% confident that the practices performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
