During our previous inspection in May 2018 we found concerns relating to the governance arrangements relating to monitoring of staff essential training, fire safety and complaints documentation. We also identified a gap in staff recruitment documentation to ensure staff were offered reasonable adjustments (where necessary).

At this inspection, we found these issues have been rectified and there was no evidence of any changes in quality of leadership which have resulted in any changes in the quality of care. Therefore, we have rated the practice as good for Well-led.

Explanation of any answers and additional evidence:

The practice had considered the breach of regulation following the May 2018 inspection and submitted an action plan to the Care Quality Commission advising how they would action these to become compliant.

During this inspection we found:

Staff training

We reviewed the staff training matrix and observed a selection of training certificates of essential training across all staff groups. The practice could evidence all staff were currently up to date with their training requirements for fire safety, health and safety and Mental Capacity Act 2005 (MCA).

We spoke with two members of the reception and administration team and found they had appropriate knowledge of fire safety, health and safety and MCA.

Training requirements were discussed at team meetings and reviewed monthly to ensure all staff were aware of their training needs.

The practice had a system in place to alert management to any areas of training that were approaching the renewal date and they were planning to instigate a "monthly training topic" to ensure all training was undertaken within each 12-month period.

The practice had reviewed their staff training policy in November 2018 and had routinely audited training compliance since the last inspection.

Complaints

The practice showed us their policy for dealing with complaints which had been updated and reviewed in March 2019. The lead person responsible for dealing with complaints had regularly reviewed the documentation relating to complaints to ensure the policy was being followed.

All complaints were reviewed by one of the GP partners before the final response documentation was sent. This process had been added to the policy to support the deputy practice manager in this role.

We looked at the documentation of three complaints, received since the last inspection, and found they had all received an appropriate and timely acknowledgement and the response letters contained information on how to escalate concerns to the Health Ombudsman.

Recruitment files

The practice had updated their recruitment policy since the last inspection, to include requesting health status for all new staff. A health questionnaire format had been implemented and was included with the recruitment paperwork checklist.

We looked at six staff recruitment files and found they all contained documentation recording the staff health questionnaire and any reasonable adjustments considered and implemented, where necessary. The practice was due to commence appraisals for staff in June 2019 and would collect the information about health status for the remaining staff as part of the appraisal conversation.

Managing risks, issues and performance

There were clear and effective processes for managing risks, issues and performance.

Explanation of any answers and additional evidence:

The practice had considered the breach of regulation following the May 2018 inspection and submitted an action plan to the Care Quality Commission advising how they would action these to become compliant.

During this inspection we found:

Since the last inspection, the practice had reviewed their fire safety risk assessments and policy. They had requested an external organisation to attend to undertake a new fire safety risk assessment, which highlighted some improvements. For example, a grab rail near an external door to assist with exiting the building near steps. The practice also replaced their evacuation chair and reviewed the fire exit signage throughout the building to ensure it was appropriately positioned.

The practice had carried out a fire drill in May 2018 and January 2019. There was a plan to undertake another fire drill in June 2019. The fire drill in January 2019 had identified a learning action for a member of staff to remain near the main entrance door to prevent anyone attempting to enter the building. Staff we spoke with were aware of this new procedure.

Appropriate and accurate information

There was a demonstrated commitment to using data and information proactively to drive and support decision making.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique we can be 95% confident that the practices performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

The following language is used for showing variation:

Note: for the following indicators the variation bands are different:

- Child Immunisation indicators. These are scored against the World Health Organisation target of 95% rather than the England average.
- The percentage of respondents to the GP patient survey who responded positively to how easy it was to get through to someone at their GP practice on the phone uses a rules based approach for scoring, due to the distribution of the data. This indicator does not have a CCG average.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
