Findings	
•	The practice used a clinical tool to identify older patients who were living with moderate or severe frailty. Those identified received a full assessment of their physical, mental and social needs.
•	The practice followed up on older patients discharged from hospital. It ensured that their care plans and prescriptions were updated to reflect any extra or changed needs.
•	The practice carried out structured annual medication reviews for older patients.
•	Staff had appropriate knowledge of treating older people including their psychological, mental and communication needs.
•	Health checks, including frailty assessments, were offered to patients over 75 years of age.
•	Flu, shingles and pneumonia vaccinations were offered to relevant patients in this age group.
•	All patients who lived in a care home were reviewed every six months to reduce polypharmacy
•	100% of patients living in a care or residential home had a personal care plan in place which was accessible to all healthcare workers involved in their care.
•	Each residential and care home had a GP allocated to it which, the practice told us improved care especially at the end of life.
•	All patients that needed one had a Statement of Intent in place.
•	All patients had a named GP and early discussions were held about the preferred place of care.

- Patients with long-term conditions were offered a structured annual review to check their health and medicines needs were being met. For patients with the most complex needs, the GP worked with other health and care professionals to deliver a coordinated package of care.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma.

- The practice shared clear and accurate information with relevant professionals when deciding care delivery for patients with long-term conditions.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins.
- Patients with suspected hypertension were offered ambulatory blood pressure monitoring.
- Patients with atrial fibrillation were assessed for stroke risk and treated appropriately.
- Patients with COPD were offered rescue packs.
- Some patients with COPD, who scored MRC3 or above on the breathlessness scale, were
 piloting a self-help app with the practice. The app helped patients manage their
 COPD independently and reduced their reliance on GP and hospital appointments.
- Patients with asthma were offered an asthma management plan.
- All patients had a named GP.

Findings

- Young people could access services from an outside provider for sexual health and contraception.
- In addition to the outside provider and due to demand, the practice ran their own sexual health and contraception clinic. This was not a commissioned service and was held once a week. The practice told us that since the beginning of January 2019, 276 patients had attended this service.
- Childhood immunisation uptake rates were in line with the World Health Organisation (WHO) targets.
- The practice contacted the parents or guardians of children due to have childhood immunisations.
- The practice had arrangements for following up failed attendance of children's appointments following an appointment in secondary care or for immunisation and would liaise with health visitors when necessary.

- The practice had arrangements to identify and review the treatment of newly pregnant women on long-term medicines. These patients were provided with advice and post-natal support in accordance with best practice guidance.
- All children under the age of 14 were offered a same day appointment with a prescribing clinician if required.
- Staff had the appropriate skills and training to carry out reviews for this population group.

Any additional evidence or comments

 The practice provided us with data from their clinical system which showed that they had since reached the 90% World Health Organisation target, although this data had not yet been verified by CQC.

Working age people (including those recently retired and students)

Population group rating: Good

Findings

• A weekly acupuncture clinic was funded by the practice and run by one of the GPs for patients who

needed pain relief. Since April 2018 only two patients had been referred to the pain clinic from the 109 patients seen. Some of the patients we spoke to on the day of the inspection gave very positive feedback about the service.

- The practice had systems to inform eligible patients to have the meningitis vaccine, for example before attending university for the first time.
- Patients had access to appropriate health assessments and checks including NHS checks for patients aged 40 to 74. There was appropriate and timely follow-up on the outcome of health assessments and checks where abnormalities or risk factors were identified.
- Patients could book or cancel appointments online and order repeat medication without the need to attend the surgery.
- Patients could request an on-line consultation with a clinician where they could send messages asking for advice. Within 24 hours the surgery would take appropriate action including replying on-line or calling the patient, with advice, arranging an appointment or prescribing as necessary.
- The practice offered extended hours appointments on Monday evenings and early Wednesday
 mornings for patients who were unable to attend the surgery during normal working hours.

- The practice assessed and monitored the physical health of people with mental illness, severe mental illness, and personality disorder by providing access to health checks, interventions for physical activity, obesity, diabetes, heart disease, cancer and access to 'stop smoking' services.

- There was a system for following up patients who failed to attend for administration of long-term medication.
- When patients were assessed to be at risk of suicide or self-harm the practice had arrangements in place to help them to remain safe.
- Patients at risk of dementia were identified and offered an assessment to detect possible signs of dementia. When dementia was suspected there was an appropriate referral for diagnosis.
- All staff had received dementia training in the last 12 months and were dementia friends.
- Patients with poor mental health, including dementia, were referred to appropriate services.

The practice had a programme of clinical audits which they carried out on a regular basis over a whole range of medicines. For example:

- Patients on a dual anti platelet medication were audited regularly. Patients were called in to the practice for a medication review and their medication was altered as appropriate improving patient safety.
- Patients on oral anticoagulation were reviewed against a set of criteria such as age and weight.

The audit was as an assurance of patient safety by a better dosing of medication and better prevention of strokes.

- The practice made a 40% reduction in the prescribing of Benzodiazepines between 2017/2018 and 2018/2019. CCG data presented to us showed a reduction from 250 prescriptions issued in 17/18 to 165 prescriptions issued in 18/19.
- The practice carried out a search every three months for patients prescribed a type of antibiotic. Since August 2017 the number of prescriptions issued was 343, this had been reduced to 28 in March 2019. This was due to better prescribing leading to fewer side effects and better care for patients.
- The CCG had provided a CRP machine to the practice which can measure for infections and aid the appropriate prescribing of antibiotics. Since September 2018 the practice had tested 172 patients for infection and avoided prescribing antibiotics in 125 patients.

During 2018/2019 the practice told us that they had trained 64 medical students, three foundation year students (FY2), three speciality trainee doctors (ST3), one assistant practitioner, one paramedic student, one associate physician and five nursing students.

• The assistant practitioner had been upskilled from a health care assistant within the practice.

- One of the receptionists had been promoted to office manager and was currently training to be a practice manager.
- Some of the administration/reception staff were trained phlebotomists.
- The practice manager and office manager held the Medical Assistant qualification and were able to help with patients when required.

Older people

Findings

Population group rating: Good

- All male patients between the ages of 40 and 80 were invited to a Prostate Cancer awareness day held by the practice. The PPG assisted in organising the day by advertising in local supermarkets and in the surgery. The event was attended by a male prostate cancer nurse, GPs and a nurse so that patients could be tested on the day. 65 men attended and 12 were tested on the day. 1 patient hadn't been to the surgery for a number of years and told the staff that he had attended because of the event.
- All patients had a named GP who supported them in whatever setting they lived.
- The practice was responsive to the needs of older patients and offered home visits and urgent
 appointments for those with enhanced needs and complex medical issues.
- The practice provided effective care coordination to enable older patients to access appropriate services.
- In recognition of the religious and cultural observances of some patients, the GP would respond quickly, often outside of normal working hours, to provide the necessary death certification to enable prompt burial in line with families' wishes when bereavement occurred.

People with long-term conditions

Population group rating: Good

Findings

Patients with multiple conditions had their needs reviewed in one appointment.

- The practice provided effective care coordination to enable patients with long-term conditions to access appropriate services.
- The practice liaised regularly with the local district nursing team and community matrons to discuss
 and manage the needs of patients with complex medical issues.
- Care and treatment for people with long-term conditions approaching the end of life was coordinated with other services.

Families, children and young people Population group rating: Outstanding

Findings

- The practice had its own foodbank which was provided by the GPs and staff. Since the introduction of the foodbank, the practice told us that they had helped 10 families with each having up to three packages of food. At Christmas they had also included presents for families where they were needed.
- The practice had secured funding to carry out a pilot in which patients between the ages of 14 and 40 with a BMI of over 27 were offered a fitness regime and dietary advice to promote weight loss over a period of 10 weeks This included hiring fitness instructors and a chef to give ideas and tips of meals to cook and how to cook them. During the pilot 78 patients had used the service which had received excellent feedback. The practice was able to give us examples of the challenges and results of some of the patients such as:
 - > One patient was unable to leave the house without another family member and after joining the scheme needed one to one sessions. After a short time the patient was attending sessions on their own due to increased confidence.
 - > One patient wanted surgery and after seeing weight loss results started regular exercise sessions without surgery.
 - > One patient who found it difficult to socialise started to hold dinner parties using ideas learnt from the chef on the scheme.

Average weight loss over the 10 weeks was 5 pounds each and a total weight loss of 4.5 stones. Patients reduced their waist circumference by an average of three inches.

- The nurses were due to start a New Mums clinic to offer advice on subjects such as breastfeeding and immunisations.
- Additional nurse appointments were available until 8.30pm on a Monday and from 7am on a Wednesday for school age children so that they did not need to miss school.
- · We found there were systems to identify and follow up children living in disadvantaged circumstances and who were at risk, for example, children and young people who had a high number of accident and emergency (A&E) attendances. Records we looked at confirmed this.
- All parents or guardians calling with concerns about a child were offered a same day appointment when necessary.
- Parents with concerns regarding children under the age of 14 could attend a drop-in clinic held at the same time as the twice weekly baby clinic.

Working age people (including those recently retired and students)

Population group rating: Good

Findings

- Patients could request an on-line consultation with a clinician where they could send messages asking for advice. Within 24 hours the surgery would take appropriate action including replying on-line or calling the patient, with advice, arranging an appointment or prescribing as necessary
- The needs of this population group had been identified and the practice had adjusted the services

it offered to ensure these were accessible, flexible and offered continuity of care.

The practice was open until 8.30pm on a Monday and from 7am on a Wednesday. Pre-bookable
appointments were also available to all patients at additional locations within the area, as the
practice was a member of a GP federation. Appointments were available until 9.30 on week day
evenings, weekends and bank holidays.

- All patients over the age of 16 were contacted by the practice and asked if they had served in the
 military. As a result, 208 patients were now on the practice military veterans register. The practice
 then organised a Veterans in the Community event where information including a website and a
 newsletter was prepared and offered to all the veterans. Some patients had carried on meeting
 with some of the other veterans reducing the isolation that some of them felt. The practice manager
 is a military veteran and offers an informal chat with support for anyone that wants it. The practice
 had signed up to the RCGP as a veteran friendly practice.
- The practice with another local practice took it in turn to host regular coffee mornings which were run by the practice staff. Refreshments were provided and games such as bingo and dominoes available. Patients who were struggling with loneliness and isolation were invited and attended.
- Some of the GPs and staff volunteer their time and engage with the local Homeless Alliance Response Team (HART). The practice donated flu vaccines and some medical supplies to the service.
- All staff had completed basic sign language training.
- The practice leaflet was available in braille.
- The practice held a register of patients living in vulnerable circumstances including homeless people, travellers and those with a learning disability.
- People in vulnerable circumstances were easily able to register with the practice, including those
 with no fixed abode such as homeless people and travellers.
- The practice provided effective care coordination to enable patients living in vulnerable circumstances to access appropriate services.
- The practice adjusted the delivery of its services to meet the needs of patients with a learning disability.
- The practice had been awarded Gold standard in the Pride of Practice awards.

People experiencing poor mental health

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique we can be 95% confident that the practices performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
