Older people

Population group rating: Good

Findings

- The practice used a clinical tool to identify older patients who were living with moderate or severe frailty. The practice had also utilised a frailty questionnaire which had been devised by the federation of five Farnham GP practices (which included River Wey Medical Practice). The practice had handed out 29 of these surveys to patients and had identified seven who had not previously met the criteria for a frailty review. Those identified received a full assessment of their physical, mental and social needs, in conjunction with the federation integrated care team.
- The practice followed up on older patients discharged from hospital. It ensured that their care plans and prescriptions were updated to reflect any extra or changed needs.
- The practice carried out structured annual medication reviews for older patients.
- Staff had appropriate knowledge of treating older people including their psychological, mental and communication needs.
- Health checks, including frailty assessments, were offered to patients over 75 years of age.
- Flu, shingles and pneumonia vaccinations were offered to relevant patients in this age group.

People with long-term conditions

Population group rating: Good

Findings

- Patients with long-term conditions were offered a structured annual review to check their health and medicines needs were being met. For patients with the most complex needs, the GP worked with other health and care professionals to deliver a coordinated package of care.
- The practice had recognised it had a low achievement for a specific diabetes register indicator in 2017/18 and had audited and changed the process for reviews for this patient group. The 2018/19 achievement was an improvement on the previous achievement.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma. We also saw an audit of inhaler use to improve quality for this population group.
- The practice shared clear and accurate information with relevant professionals when deciding care delivery for patients with long-term conditions.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins.
- Patients with suspected hypertension were offered the use of blood pressure monitoring equipment to use at home.
- Patients with atrial fibrillation were assessed for stroke risk and treated appropriately.
- Patients with COPD were offered rescue packs and patients with asthma were offered an asthma management plan.

Families, children and young people

Population group rating: Good

Findings

- The practice had met the minimum 90% target for all four childhood immunisation uptake indicators but had not met the WHO based national target of 95% (the recommended standard for achieving herd immunity).
- The practice had arranged a teddy bear clinic to encourage children aged two and three to attend for their nasal flu vaccine. Children brought their teddy bears and the practice waiting room was arranged to be age appropriate with a child size table and chairs with drinks and snacks. The practice told us approximately 60 children attended to receive their nasal flu vaccine in one day which had improved their uptake rates from the previous year from 22% to 32%. The coverage would have been higher if more flu vaccine had been available for the clinic.
- One of the practice nurses had undertaken an audit of paediatric emergency department attendances. They linked the number of attendances to a lack of education and knowledge of health services and the practice was planning to hold a patient education event on this topic in the future.
- The practice contacted the parents or guardians of children due to have childhood immunisations.
- The practice had arrangements for following up failed attendance of children's appointments following an appointment in secondary care or for immunisation and would liaise with health visitors when necessary.
- The practice had arrangements to identify and review the treatment of newly pregnant women on long-term medicines. These patients were provided with advice and post-natal support in accordance with best practice guidance.
- Young people could access services for sexual health and contraception.
- Staff had the appropriate skills and training to carry out reviews for this population group.

Working age people (including those recently retired and students)

Findings

- The practice had systems to inform eligible patients to have the meningitis vaccine, for example before attending university for the first time.
- Patients had access to appropriate health assessments and checks including NHS checks for patients aged 40 to 74. There was appropriate and timely follow-up on the outcome of health assessments and checks where abnormalities or risk factors were identified.
- Patients could book or cancel appointments online and order repeat medication without the need to attend the surgery.
- The practice had commenced using digital platforms for online access to care and treatment such as e-consult. They were planning to commence with another digital service in 2020.

Any additional evidence or comments

The practice was aware of their below target uptake for cervical cytology screening. They had recall processes in place to ensure eligible women had been called for their screening. If patients did not make an appointment or attend, they were contacted by one of the nursing team by phone. Patients could make appointments at any time during core working hours, or through the extended hours service (including at weekends). The practice computer system had alerts and flags for patients who were overdue their screening for the nurses and GPs to arrange their screening appointment when they attended for another reason.

We were shown more up to date data for March 2019 to June 2019 (from Public Health England) which showed the practice had achieved 79.1% uptake.

The nursing team told us there was a regular audit of inadequate cytology samples (samples that could not be tested) but did not have an audit trail to ensure every sample sent, had received a result. The practice told patients to call them if they had not received the results by eight weeks after the test. This relied on patients recalling their test dates and making a call to the practice at the correct time. There was a risk that a test sample could go missing or not be received without the practices knowledge if the patient did not inform them.

People whose circumstances make them vulnerable

- Same day appointments and longer appointments were offered when required.
- All patients with a learning disability were offered an annual health check.
- End of life care was delivered in a coordinated way which took into account the needs of those whose circumstances may make them vulnerable.
- The practice had a system for vaccinating patients with an underlying medical condition according to the recommended schedule.
- The practice demonstrated that they had a system to identify people who misused substances.
- The practice reviewed young patients at local residential homes.

People experiencing poor mental health (including people with dementia)

Findings

- The practice assessed and monitored the physical health of people with mental illness, severe mental illness, and personality disorder by providing access to health checks, interventions for physical activity, obesity, diabetes, heart disease, cancer and access to 'stop smoking' services.
- Same day and longer appointments were offered when required.
- There was a system for following up patients who failed to attend for administration of long-term medication.
- When patients were assessed to be at risk of suicide or self-harm the practice had arrangements in place to help them to remain safe.
- Patients at risk of dementia were identified and offered an assessment to detect possible signs of dementia. When dementia was suspected there was an appropriate referral for diagnosis.
- All staff were offered dementia training as part of their induction.
- Patients with poor mental health, including dementia, were referred to appropriate services.

Examples of improvements demonstrated because of clinical audits or other improvement activity in past two years

Audit of urinary tract infection prescribing

An audit of prescribing for uncomplicated urinary tract infections was undertaken in October 2019. The audit reviewed if prescribing had been carried out in line with local guidelines. This was a repeat audit which had been undertaken annually since 2017.

The practice had set a 90% minimum target of compliance and had achieved 37% in the 2018/19 audit. This year's audit (2019/20) had identified an increase in prescribing compliance to 59%, although it was still below the 90% standard.

The results were due to be shared at a November 2019 clinical meeting along with a reminder to prescribing clinicians to review the local guidelines. The practice was also due to share the results with the federation of five GP practices in the Farnham area as some of the non-compliance noted was prescribed by clinicians working at the same day appointment service. (Patients from River Wey Medical Practice could access the same day service if they requested a same day appointment and there wasn't any appointment availability at the surgery).

Metformin prescribing audit

The practice carried out searches of patients with type two diabetes who were prescribed metformin (a medication to lower blood sugar levels). The individual notes were then reviewed to ensure that a specific blood level test had been taken and the result was within guideline amounts to continue prescribing the metformin.

The audit had been undertaken in October 2018 and repeated in October 2019. Both years the practice had identified 100% of patients had the appropriate blood test result which enabled the safe, continued prescribing of the metformin.

Minor surgery internal audit

An audit of minor surgery carried out between September 2018 and September 2019 showed 100% had received histology results and 100% had a signed consent in the patient records.

The practice was able to demonstrate that staff had the skills, knowledge and experience to carry out their roles.

Examples of continuous learning and improvement

The practice had held an away day for the GP partners and management team in April 2019. They had discussed and identified a one year plan called River Wey 2020, which outlined the practice goals and areas for improvement for the coming year.

The practice had held a patient education event in November 2019 to talk to patients about sepsis. The event was promoted via the PPG and had a good attendance. Feedback was positive about the event and the practice had planned more for the future and covering different topics.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique we can be 95% confident that the practice's performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

No statistical variation	< 1.5 and > -1.5
Tending towards variation (negative)	≥ 1.5 and < 2
Variation (negative)	≥ 2 and < 3
Significant variation (negative)	≥ 3

Note: for the following indicators the variation bands are different:

- Child Immunisation indicators. These are scored against the World Health Organisation target of 95% rather than the England average. Note that practices that have "Met 90% minimum" have not met the WHO target of 95%.
- The percentage of respondents to the GP patient survey who responded positively to how easy it was to get through to someone at their GP practice on the phone uses a rules based approach for scoring, due to the distribution of the data. This indicator does not have a CCG average.
- The percentage of women eligible for cervical cancer screening at a given point in time who were screened adequately within a specified period (within 3.5 years for women aged 25 to 49, and within 5.5 years for women aged 50 to 64). This indicator does not have a CCG average and is scored against the national target of 80%.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.

- **PHE:** Public Health England
- **QOF:** Quality and Outcomes Framework
- **STAR-PU:** Specific Therapeutic Group Age-sex weightings Related Prescribing Units. These weighting allow more accurate and meaningful comparisons within a specific therapeutic group by taking into account the types of people who will be receiving that treatment.
