At the last inspection in December 2018 we rated the practice as requires improvement for providing effective services because performance for child immunisations and cervical screening were below national targets and there was no consistent approach for coding patients on the clinical system.

At this inspection we found that although the practice could demonstrate improvement in relation to clinical coding and exception reporting, performance for child immunisations and cervical screening remained below national targets.

Patients' needs were assessed, and care and treatment was delivered in line with current legislation, standards and evidence-based guidance supported by clear pathways and tools.

Older people

Population group rating: Good

- The practice used a clinical tool to identify older patients who were living with moderate or severe
 frailty. Those identified received a full assessment of their physical, mental and social needs.
- The practice followed up on older patients discharged from hospital. It ensured that their care plans and prescriptions were updated to reflect any extra or changed needs.

- The practice carried out structured annual medication reviews for older patients.
- Staff had appropriate knowledge of treating older people including their psychological, mental and communication needs.
- Health checks, including frailty assessments, were offered to patients over 75 years of age.
- Flu, shingles and pneumonia vaccinations were offered to relevant patients in this age group.

- Patients with long-term conditions were offered a structured annual review to check their health
 and medicines needs were being met. For patients with the most complex needs, the GP
 worked with other health and care professionals to deliver a coordinated package of care.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma.
- The practice shared clear and accurate information with relevant professionals when deciding care delivery for patients with long-term conditions.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins.
- Patients with suspected hypertension were offered ambulatory blood pressure monitoring.
- Patients with atrial fibrillation were assessed for stroke risk and treated appropriately.
- Patients with COPD were offered rescue packs.
- Patients with asthma were offered an asthma management plan.

Any additional evidence or comments

The indicator showing variation (negative); The percentage of patients with diabetes, on the register, whose last measured total cholesterol (measured within the preceding 12 months) is 5 mmol/l or less (01/04/2018 to 31/03/2019) remained similar to the 2017/18 published figure of 67%. However, the practice had reduced exception reporting for this indicator from 7.9% to 4.6% which was below both CCG and England averages.

Families, children and young people

Population group rating: Requires Improvement

- The practice has met the minimum 90% target for one of four childhood immunisation uptake
 indicators. The practice has not met the WHO based national target of 95% (the recommended
 standard for achieving herd immunity) for all four childhood immunisation uptake indicators.
- The practice contacted the parents or guardians of children due to have childhood immunisations.
- The practice had arrangements for following up failed attendance of children's appointments
 following an appointment in secondary care or for immunisation and would liaise with health
 visitors when necessary.
- The practice had arrangements to identify and review the treatment of newly pregnant women on long-term medicines. These patients were provided with advice and post-natal support in accordance with best practice guidance.
- Young people could access services for sexual health and contraception.
- Staff had the appropriate skills and training to carry out reviews for this population group.

Any additional evidence or comments

Since the last inspection the practice had taken some steps to improve child immunisation uptake. For example, by sending out letters and displaying posters around the practice in different languages appropriate to the local population to encourage uptake. However, child immunisation rates were still below target and had deteriorated for three of the four indicators as outlined below:

- The percentage of children aged 2 who have received their booster immunisation for Pneumococcal infection (i.e. received Pneumococcal booster) (PCV booster) (01/04/2017 to 31/03/2018) was 76.5%.
- The percentage of children aged 2 who have received their immunisation for Haemophilus influenza type b (Hib) and Meningitis C (MenC) (i.e. received Hib/MenC booster) (01/04/2017 to 31/03/2018) was 76.5%.
- The percentage of children aged 2 who have received immunisation for measles, mumps and rubella (one dose of MMR) (01/04/2017 to 31/03/2018) was 71.6%.

Working age people (including those recently retired and students)

Findings

- Cervical screening uptake was below the 80% national target.
- The practice had systems to inform eligible patients to have the meningitis vaccine, for example before attending university for the first time.
- Patients had access to appropriate health assessments and checks including NHS checks for patients aged 40 to 74. There was appropriate and timely follow-up on the outcome of health assessments and checks where abnormalities or risk factors were identified.
- Patients could book or cancel appointments online and order repeat medication without the need to attend the surgery.

Any additional evidence or comments

Although cervical screening uptake had improved marginally from 59.8% (2016/17 Public Health England published figures) to 61.7% in 2017/18, uptake was still below the 80% national target.

Since the last inspection the practice had taken action to improve cervical screening uptake. For example, text reminders and letters were routinely sent to non-attenders and posters were displayed around the practice in languages appropriate to the local population to encourage attendance. There was also daily hub access to cervical screening appointments from three local sites with appointments available

mornings, evenings and weekends as well as the local GP federation offering appointments for cervical screening.

People whose circumstances make them vulnerable

 of dementia. When dementia was suspected there was an appropriate referral for diagnosis.
- All staff had received dementia training in the last 12 months.
- Patients with poor mental health, including dementia, were referred to appropriate services.

The practice had carried out two cycle audits for atrial fibrillation and asthma which demonstrated improvements in the identification and clinical coding of patients with these conditions. Other audits had been carried out to reduce antibiotic prescribing and to monitor patients prescribed high risk medicines. However, quality improvement activities were minimal.

Explanation of any answers and additional evidence:

At the last inspection we identified shortfalls in relation to coding and exception reporting. Specifically, historical coding had contributed to inaccurate information on the clinical system. There was also no unified coding structure to assist clinical staff when coding. The practice had taken action to improve coding for cervical screening. However, improvements were needed for coding of chronic diseases.

At this inspection the practice showed improvement in this respect. They could demonstrate a consistent approach to clinical coding and a detailed policy had been implemented for Quality and Outcomes Framework (QOF) exception reporting. Clinical governance had been strengthened through the super-partnership with a data quality manager in post.

It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

The following language is used for showing variation:

| Variation Bands | Z-score threshold |
|--------------------------------------|-------------------|
| Significant variation (positive) | ≤-3 |
| Variation (positive) | >-3 and ≤-2 |
| Tending towards variation (positive) | >-2 and ≤-1.5 |
| No statistical variation | <1.5 and >-1.5 |
| Tending towards variation (negative) | ≥1.5 and <2 |
| Variation (negative) | ≥2 and <3 |
| Significant variation (negative) | ≥3 |

Note: for the following indicators the variation bands are different:

- Child Immunisation indicators. These are scored against the World Health Organisation target of 95% rather than the England average. Note that practices that have "Met 90% minimum" have not met the WHO target of 95%.
- The percentage of respondents to the GP patient survey who responded positively to how easy it was to get through to someone at their GP practice on the phone uses a rules based approach for scoring, due to the distribution of the data. This indicator does not have a CCG average.
- The percentage of women eligible for cervical cancer screening at a given point in time who were screened adequately within a specified period (within 3.5 years for women aged 25 to 49, and within 5.5 years for women aged 50 to 64). This indicator does not have a CCG average and is scored against the national target of 80%.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.

Note: The CQC GP Evidence Table uses the most recent validated and publicly available data. In some cases at the time of inspection this data may be relatively old. If during the inspection the practice has provided any more recent data, this can be considered by the inspector. However, it should be noted that any data provided by the practice will be unvalidated and is not directly comparable to the published data. This has been taken into account during the inspection process.

- COPD: Chronic Obstructive Pulmonary Disease
- PHE: Public Health England
- QOF: Quality and Outcomes Framework
- STAR-PU: Specific Therapeutic Group Age-sex weightings Related Prescribing Units. These weighting allow more accurate and meaningful comparisons within a specific therapeutic group by taking into account the types of people who will be receiving that treatment.
