At this inspection, the practice was rated as requires improvement for providing safe services because:

- We found the emergency equipment held by the practice did not contain pulse oximeters.
- Formal guidance on medical emergencies, including sepsis, was not available for staff.
- We found the practice did not routinely follow-up on urgent cancer referrals in line with recommended national guidance.
- The practice did not have a formal documented process in place for clinical oversight regarding the work of non-medical prescribers.
- The practice did not have readily accessible oversight of all staff training but after the inspection showed evidence that staff had received safeguarding training.

Explanation of any answers and additional evidence:

1 – At the previous inspection (under the previous provider), we found safeguarding processes and systems were not clear. At this inspection, we found the new provider had implemented improved safeguarding policies, systems and processes. We found that staff were clear on their roles and responsibilities in relation to safeguarding.

The new provider had completed an audit of the safeguarding register for children and reviewed each child to ensure that appropriate actions were taken and whether to remain on the register.

2 – Practice staff told us they had received safeguarding training to appropriate levels for their role and staff we spoke with appeared knowledgeable in relation to safeguarding. On the day of the inspection the practice did not have readily accessible oversight of all of the training that members of staff had completed and were in the process of reviewing the training received by staff. The practice was aware of this and had plans in place to ensure oversight of training was achieved following the inspection. The practice sent a sample of evidence after the inspection following our request, to show staff had received safeguarding training.

We reviewed the actions arising from the audit and found that whilst the actions appeared to have been completed in the practice, the audit did not indicate they had been completed. The practice told us they would review their approach in accurately completing updates and actions in relation to the IPC audit.

^{1 –} At the previous inspection we found the previous provider had commenced an infection, prevention and control audit six weeks prior to our inspection but had not completed it. At this inspection we found the new provider had completed a new infection, prevention and control audit in July 2019.

- 1 At the previous inspection under the previous provider, we found the practice operated with small numbers of clinical staff and a high proportion of locum use. At this inspection, we found the new provider had successfully recruited a two salaried GPs and two nurses and the use of locum staff had reduced to a small number of regular, long-term locums.
- 2 We found the emergency equipment did not contain pulse oximeters. When we raised this with the provider, they told us that pulse oximeters had been ordered for use in the emergency bag.
- 3 Whilst we found that clinical and non-clinical staff were knowledgeable about actions to take if they encountered a deteriorating or acutely unwell patient, we found that specific guidance had not been distributed to staff. The provider told us guidance would be issued following the inspection.

- 1 We spoke with members of staff who were responsible for monitoring two-week wait referrals. Staff told us they only monitored referrals where patients did not attend and did not routinely follow up on referrals which may have been delayed. The provider told us they would address this following the inspection.
- 2 At our previous inspection under the previous provider, we found there were 122 outstanding test results on the practice's system, 86 of these test results had not been opened. At this inspection, we found the new provider had implemented a new system to ensure that test results were reviewed and actioned where appropriate, in a timely manner. We found that test results had all been opened and acted upon as appropriate, on the day of the inspection.

^{1 -} At the previous inspection under the previous provider, we found there was no system in place to audit or monitor the prescribing work of non-medical prescribers. At this inspection we found the provider informally monitored the prescribing and was in the process of arranging a process of formal supervision.

- 2 We found the provider had inherited approximately 1,000 overdue medicine reviews from the previous provider. The new provider had prioritised the medicine reviews and completed 775 medicine reviews at the time of the inspection. The provider had a plan in place to complete the remaining overdue medicine reviews and had implemented a new system to ensure they were completed on an ongoing basis.
- 3 At the previous inspection under the previous provider, we found the provider's system of monitoring the expiry dates of emergency medicines and vaccines was ineffective. At this inspection we found the new provider had implemented a new system for monitoring the emergency medicines and vaccines and we found none which had passed their expiry date on the day of the inspection.

1 – At the previous inspection under the previous provider, we found that the significant events log was incomplete and did not contain details of the significant events that were recorded. At this inspection, we found the new provider had implemented a new system for recording, managing and learning from events.

Explanation of any answers and additional evidence:

1 – At the previous inspection under the previous provider, we found there was no system in place to effectively manage patient safety alerts. At this inspection we found the new provider had implemented a system for managing patient safety alerts and staff we spoke with were knowledgeable about the system.

We reviewed four patient safety alerts and found the practice had completed appropriate monitoring and actions where appropriate.

Effective Rating: Requires Improvement

At this inspection, the practice was rated as requires improvement for providing effective services because:

- The practice's audit programme was limited and the practice did not regularly review unplanned admissions and readmissions.
- The practice did not have complete oversight of all of the training that members of staff had completed relevant to their role.
- The practice did not have a formal supervision system for non-medical prescribers, salaried and locum clinical staff.

At this inspection, Quality Outcomes Framework data was not included in the inspection report or evidence table. This was because the provider had only been providing services from the location for 6 months prior to the inspection; therefore the data available related to the previous provider.

The new provider was aware of the previous provider's poor Quality Outcomes Framework performance data. Due to the prioritised work undertaken to improve patient safety, shortly before the inspection, the provider had started to take action to address the previous data. A new Nurse Manager had been appointed to oversee the recall system and patient reviews, which included changes to the recall system such as changing the recall date to the patient's birth month. Improvements to the practice's performance will be reviewed at the next inspection.

Effective needs assessment, care and treatment

Patients' needs were assessed, and care and treatment was delivered in line with current legislation, standards and evidence-based guidance supported by clear pathways and tools.

Older people

Findings

The issues identified in effective affected all patients including this population group, however, there were some areas of good practice such as:

- The practice used a clinical tool to identify older patients who were living with moderate or severe frailty. Those identified received a full assessment of their physical, mental and social needs.
- The practice trialled a dedicated home visiting GP for routine visits two mornings per week for patients with non-acute concerns.
- The practice followed up on older patients discharged from hospital. It ensured that their care plans and prescriptions were updated to reflect any extra or changed needs.
- The practice carried out structured annual medication reviews for older patients.
- Staff had appropriate knowledge of treating older people including their psychological, mental and communication needs.
- Flu, shingles and pneumonia vaccinations were offered to relevant patients in this age group.

People with long-term conditions

Population group rating: Requires Improvement

Findings

The issues identified in effective affected all patients including this population group, however, there were some areas of good practice such as:

- Patients with long-term conditions were offered a structured annual review to check their health
 and medicines needs were being met. For patients with the most complex needs, the GP
 worked with other health and care professionals to deliver a coordinated package of care.
- The practice had recruited a new nurse manager shortly prior to the inspection, to oversee the reviews of patients with long-term conditions.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma.
- The practice shared clear and accurate information with relevant professionals when deciding care delivery for patients with long-term conditions.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins.
- Patients with atrial fibrillation were assessed for stroke risk and treated appropriately.
- Patients with COPD were offered rescue packs.
- Patients with asthma were offered an asthma management plan.

Families, children and young people

Population group rating: Requires Improvement

Findings

The issues identified in effective affected all patients including this population group, however, there were some areas of good practice such as:

- Dedicated childhood immunisation clinics were implemented for patients. The provider reported that patients not attending for immunisations were contacted by a clinician.
- The practice had arrangements for following up failed attendance of children's appointments
 following an appointment in secondary care or for immunisation and would liaise with health
 visitors when necessary.
- The practice had arrangements to identify and review the treatment of newly pregnant women on long-term medicines. These patients were provided with advice and post-natal support in accordance with best practice guidance.
- Young people could access services for sexual health and contraception.
- Staff had the appropriate skills and training to carry out reviews for this population group.

Working age people (including those recently retired and students)

Population group rating: Requires Improvement

Findings

The issues identified in effective affected all patients including this population group, however, there were some areas of good practice such as:

- The practice had systems to inform eligible patients to have the meningitis vaccine, for example before attending university for the first time.
- Patients had access to appropriate health assessments and checks including NHS checks for patients aged 40 to 74. There was appropriate and timely follow-up on the outcome of health assessments and checks where abnormalities or risk factors were identified.
- Patients could book or cancel appointments online and order repeat medication without the need to attend the surgery.

People whose circumstances make them vulnerable

Population group rating: Requires Improvement

Findings

The issues identified in effective affected all patients including this population group, however, there were some areas of good practice such as:

- Same day appointments and longer appointments were offered when required.
- All patients with a learning disability were offered an annual health check. The practice had enabled the Specialist Practitioner for Mental Health to become the practice's learning disability champion and intended for them to be a familiar face for this cohort of patients.
- The practice employed a social prescriber through the Primary Care Network (PCN) who provided help for vulnerable or struggling patients to access support and services.
- End of life care was delivered in a coordinated way which took into account the needs of those
 whose circumstances may make them vulnerable.
- The practice had a system for vaccinating patients with an underlying medical condition according to the recommended schedule.
- The practice demonstrated that they had a system to identify people who misused substances.

People experiencing poor mental health (including people with dementia)

Population group rating: Requires Improvement

Findings

The issues identified in effective affected all patients including this population group, however, there were some areas of good practice such as:

- The practice employed a Specialist Practitioner for Mental Health, on a shared basis with the provider's other location, who held clinics at the practice for patients.
- The practice assessed and monitored the physical health of people with mental illness, severe
 mental illness, and personality disorder by providing access to health checks, interventions for
 physical activity, obesity, diabetes, heart disease, cancer and access to 'stop smoking'
 services.
- Same day and longer appointments were offered when required.
- There was a system for following up patients who failed to attend for administration of long-term medication.
- When patients were assessed to be at risk of suicide or self-harm the practice had arrangements in place to help them to remain safe.
- Patients at risk of dementia were identified and offered an assessment to detect possible signs
 of dementia. When dementia was suspected there was an appropriate referral for diagnosis.
- Patients with poor mental health, including dementia, were referred to appropriate services.

Monitoring care and treatment

The practice had started to implement a programme of quality improvement activity and started to review the effectiveness and appropriateness of the care provided.

Explanation of any answers and additional evidence:

- 1 We found the provider had started a programme of clinical and internal audit; however, the provider had only been in situ for six months at the time of the inspection and therefore was only able to evidence a limited audit programme.
- 2 The practice did not regularly review unplanned admissions and readmissions. The provider told us they would implement a system of review following the inspection.

Example of improvements demonstrated because of clinical audits or other improvement activity in past two years

The provider had inherited a number of concerns from the previous inspection visit. The provider implemented an action plan at the time of becoming the registered provider, which included a number of clinical and non-clinical audits to identify concerns and take action where appropriate. For example:

- The provider identified an unknown number of locum clinicians had used a generic system logon, which did not allow the provider to audit who had undertaken certain consultations, tasks or referrals. The provider completed an audit of all work undertaken on the generic logon to ensure actions taken were safe and there were no outstanding actions requiring attention.
- The provider identified a number of outstanding tasks, letters and test results. The provider completed an audit to ensure prioritisation and worked to complete all tasks, letters and test results. A new system was implemented and further audits completed to ensure compliance.

Effective staffing

The practice was generally able to demonstrate that staff had the skills, knowledge and experience to carry out their roles.

- 1 Members of staff told us examples of training courses they had completed, appeared knowledgeable around subjects discussed, and we saw some evidence of staff training through personnel files. However, the practice did not have complete oversight of all of the training that members of staff had completed and were in the process of reviewing the training received by staff. The practice were aware of this and had plans in place to ensure oversight of training was achieved following the inspection.
- 2 At the previous inspection under the previous provider, we found there was a limited appraisal and supervision system. The new provider had acted to implement a new system and we saw that non-clinical staff had receive supervision and appraisals. However, the provider had not yet developed a formal supervision system for non-medical prescribers, salaried and locum clinical staff.

Coordinating care and treatment

Staff worked together and with other organisations to deliver effective care and treatment.

The new provider was aware of the previous provider's GP National Patient Survey performance data which was in line with CCG and England averages for Caring indicators. However, the new provider had plans to further improve patient satisfaction by completing an external patient survey to understand areas which need improvement. This was planned for early 2020.

Improvements to the practice's performance will be reviewed at the next inspection.

At this inspection, the practice was rated as requires improvement for providing responsive services because:

Feedback from patients on the day of the inspection through CQC comments cards and
consultations with patients was negative in relation to being able to access the practice;
specifically by telephone and appointment availability. The practice were aware of this negative
feedback and told us they intended to take actions to improve patient satisfaction following the
inspection.

At this inspection, data from the National GP Patient Survey was not included in the inspection report or evidence table. This was because the provider had only been providing services from the location for six months prior to the inspection; therefore the data available related to the previous provider.

The new provider was aware of the previous provider's GP National Patient Survey performance data which was below CCG and England averages for Responsive indicators, particularly for accessing the practice. Due to the prioritised work undertaken to improve patient safety, shortly before the inspection, the provider had started to take action to address the previous data. This included changes to the appointment system to allow for additional pre-bookable routine appointments and additional staff tasked with answering the telephone during peak periods.

However, the new provider had plans to further improve patient satisfaction by completing an external patient survey to understand areas which need improvement. This was planned for early 2020.

Improvements to the practice's performance will be reviewed at the next inspection.

- All patients had a named GP who supported them in whatever setting they lived.
- The practice was responsive to the needs of older patients and offered home visits and urgent appointments for those with enhanced needs and complex medical issues.
- The practice provided effective care coordination to enable older patients to access appropriate services.
- Flu vaccinations for housebound patients were commissioned to be completed by community services. However, upon hearing of a delay to these vaccinations, the practice proactively completed them.

People with long-term conditions

Findings

The issues identified in responsive affected all patients including this population group, however, there were some areas of good practice such as:

- Patients with multiple conditions had their needs reviewed in one appointment.
- The practice made changes to the patient recall system to recall patients in line with their month of birth, aiming to make it easier for patients and staff to recognise when a review is due.
- The practice increased the number of health care assistant appointments available in the afternoon clinics for patients with long-term conditions.
- The practice provided effective care coordination to enable patients with long-term conditions to access appropriate services.
- The practice liaised regularly with the local district nursing team and community matrons to discuss and manage the needs of patients with complex medical issues.
- Care and treatment for people with long-term conditions approaching the end of life was coordinated with other services.

Families, children and young people

Population group rating: Requires Improvement

Findings

The issues identified in responsive affected all patients including this population group, however, there were some areas of good practice such as:

- Additional appointments were available in the afternoon to ensure patients did not need to miss school.
- We found there were systems to identify and follow up children living in disadvantaged circumstances and who were at risk.
- All parents or guardians calling with concerns about a child were offered a same day appointment when necessary.

Working age people (including those recently retired and students)

Population group rating: Requires Improvement

Findings

The issues identified in responsive affected all patients including this population group, however, there were some areas of good practice such as:

- The needs of this population group had been identified and the practice had adjusted the services
 it offered to ensure these were accessible, flexible and offered continuity of care. For example, the
 practice had increased the promotion of online services.
- Additional telephone consultations were available to patients so that they did not need to take time away from work or studies.
- Pre-bookable appointments were available to all patients during the evenings and weekends at additional locations within the area, as the practice was a member of a GP federation.

People whose circumstances make them vulnerable

Findings

The issues identified in responsive affected all patients including this population group, however, there were some areas of good practice such as:

- The practice held a register of patients living in vulnerable circumstances including those with a learning disability.
- People in vulnerable circumstances were easily able to register with the practice, including those
 with no fixed abode such as homeless people and travellers.
- The practice provided effective care coordination to enable patients living in vulnerable circumstances to access appropriate services.
- The practice adjusted the delivery of its services to meet the needs of patients with a learning disability.

People experiencing poor mental health (including people with dementia)

Findings

- Priority appointments were allocated when necessary to those experiencing poor mental health.
- Staff we spoke with had a good understanding of how to support patients with mental health needs and those patients living with dementia.
- The practice was aware of support groups within the area and signposted their patients to these
 accordingly.

- 1 At the previous inspection under the previous provider, we found there was a limited appraisal and supervision system. The new provider had acted to implement a new system and we saw that non-clinical staff had receive supervision and appraisals. However, the provider had not yet developed a formal supervision system for non-medical prescribers, salaried and locum clinical staff.
- 2 We found the provider had started a programme of clinical and internal audit; however, the provider had only taken over responsibility six months prior to the inspection and therefore was only able to evidence a limited audit programme.
- 3 We found the provider had implemented a number of systems to identify, manage and mitigate risks since our previous inspection visit. However, we also found that additional work was required, such as; introducing formal sepsis guidance to staff and ensuring complete oversight of actions from infection, prevention and control audit.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique we can be 95% confident that the practices performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

- The percentage of respondents to the GP patient survey who responded positively to how easy it was to get through to someone at their GP practice on the phone uses a rules based approach for scoring, due to the distribution of the data. This indicator does not have a CCG average.
- The percentage of women eligible for cervical cancer screening at a given point in time who were screened adequately within a specified period (within 3.5 years for women aged 25 to 49, and within 5.5 years for women aged 50 to 64). This indicator does not have a CCG average and is scored against the national target of 80%.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
