Older people

Population group rating: Good

- The practice used a clinical tool to identify older patients who were living with moderate or severe
 frailty. Those identified received a full assessment of their physical, mental and social needs.
- The practice followed up on older patients discharged from hospital. It ensured that their care plans and prescriptions were updated to reflect any extra or changed needs.
- The practice carried out structured annual medication reviews for older patients.
- Staff had appropriate knowledge of treating older people including their psychological, mental and communication needs.
- Health checks, including frailty assessments, were offered to patients over 75 years of age.
- Flu, shingles and pneumonia vaccinations were offered to relevant patients in this age group.

People with long-term conditions

Population group rating: Good

- Patients with long-term conditions were offered a structured annual review to check their health and medicines needs were being met. For patients with the most complex needs, the GP worked with other health and care professionals to deliver a coordinated package of care.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma.
- The practice shared clear and accurate information with relevant professionals when deciding care delivery for patients with long-term conditions.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins.
- Patients with suspected hypertension were offered ambulatory blood pressure monitoring.
- Patients with atrial fibrillation were assessed for stroke risk and treated appropriately.
- Patients with asthma were offered an asthma management plan.
- The practice provided a number of enhanced services that were of benefit to this population group, including ambulatory blood pressure monitoring, ECG, warfarin monitoring and spirometry.

Any additional evidence or comments

The practice had high exception reporting for diabetes and hypertension indicators. Despite the high rates, at the inspection, the practice demonstrated a robust recall system for patients with long-term conditions. The recall system was based on patients' birthdays which the administration team identified from the clinical registers. The identified patients were sent bulk text messages and if a patient did not attend further text messages would be sent. Following three attempts the practice would check to see if the patient had received a community check, and if not, the practice would then attempt to contact the patient by phone. If the patient in question was still not contactable, following a notes review, the practice would except them. We checked a selection of patients on the clinical system which confirmed this process was followed.

Families, children and young people

Population group rating: Requires Improvement

- The practice has not met the minimum 90% target for all four childhood immunisation uptake
 indicators. The practice has not met the WHO based national target of 95% (the recommended
 standard for achieving herd immunity) for all of four childhood immunisation uptake indicators.
- The practice contacted the parents or guardians of children due to have childhood immunisations.
- The practice had arrangements for following up failed attendance of children's appointments
 following an appointment in secondary care or for immunisation and would liaise with health
 visitors when necessary.
- The practice had arrangements to identify and review the treatment of newly pregnant women on long-term medicines. These patients were provided with advice and post-natal support in accordance with best practice guidance.
- Young people could access services for sexual health and contraception.
- Staff had the appropriate skills and training to carry out reviews for this population group.

Any additional evidence or comments

The practice demonstrated a robust system for contacting the parents of eligible children who did not attend a child immunisation appointment. The procedure was that If a child did not attend their appointment it would be flagged to the practice manager who then would contacted the parents of the child to ascertain why the child did not attend. If the practice manager could not contact the child's parents, after three attempts, it would be passed onto the nurse who would in addition attempt to contact the parents. If still no contact was achieved the practice would then involve the health visitors. We carried out a patient record review which confirmed this process was followed by the practice.

Despite a robust system for contacting non-attenders the practice's immunisation rates were still below the World Health Organisation (WHO) targets. We raised this with the practice at the inspection. The practice's stated rationale for this was that many children were from Japanese families, who had their immunisations in Japan where the schedule was different. In addition, the practice told us many families refuse to have their child immunised and others attend private clinics.

Although the practice could demonstrate they were making considerable efforts to improve uptake we identified at the inspection other opportunities the practice could implement to maximise uptake. For example, we found that there was a general lack of literature including educational information in other

languages to encourage families to bring children in for immunisations and there was limited access to appointments with the practice nurse for child immunisations as the nurse was only at the practice on Thursdays between 8.30am and 1pm.

Working age people (including those recently retired and students)

Population group rating: Requires Improvement

- Cervical screening uptake was significantly below the 80% national target.
- The practice had systems to inform eligible patients to have the meningitis vaccine, for example before attending university for the first time.
- Patients had access to appropriate health assessments and checks including NHS checks for patients aged 40 to 74 including cardiovascular risk assessment. There was appropriate and timely follow-up on the outcome of health assessments and checks where abnormalities or risk factors were identified.
- Patients could book or cancel appointments online and order repeat medication without the need to attend the surgery.

Any additional evidence or comments

The practice demonstrated a robust system for contacting patients who did not attend for cervical screening. Patients received three invites plus an additional attempt to contact them before excepting them under Quality Outcomes and Framework (QOF) rules and this was confirmed by the patient records we reviewed.

The practice also ensured that:

- Cervical smear sample takers monitored results from the samples they took including their adequacy rates.
- -A failsafe system was in place to ensure results were received for every sample sent and patients who
 had an abnormal result were followed up.
- -Non-attenders were flagged on the patients record so screening tests could be discussed opportunistically and smear coverage was discussed at clinical meetings.

Despite a robust system for contacting non-attenders the practice's cervical smear uptake was considerably below the national target. Although at the inspection the practice could demonstrate they were making considerable efforts to improve uptake we identified some shortfalls. For example, national screening programme information was not used to encourage hard to reach women to attend for screening such as literature in other languages and there was a general lack of information advertising cervical screening services. Women were not offered appointments with the practice nurse at different times throughout the week as the nurse was only at the practice on Thursday morning between 8.30am and 1pm.

People whose circumstances make them vulnerable

Population group rating: Good

- Same day appointments and longer appointments were offered when required.
- All patients with a learning disability were offered an annual health check.
- End of life care was delivered in a coordinated way which took into account the needs of those whose circumstances may make them vulnerable.
- The practice had a system for vaccinating patients with an underlying medical condition according to the recommended schedule.
- The practice demonstrated that they had a system to identify people who misused substances.

People experiencing poor mental health (including people with dementia)

Population group rating: Good

- The practice assessed and monitored the physical health of people with mental illness, severe mental illness, and personality disorder by providing access to health checks, interventions for physical activity, obesity, diabetes, heart disease, cancer and access to 'stop smoking' services.
- Same day and longer appointments were offered when required.
- There was a system for following up patients who failed to attend for administration of long-term medication.
- When patients were assessed to be at risk of suicide or self-harm the practice had arrangements in place to help them to remain safe.
- Patients at risk of dementia were identified and offered an assessment to detect possible signs
 of dementia. When dementia was suspected there was an appropriate referral for diagnosis.
- Patients with poor mental health, including dementia, were referred to appropriate services.

The practice could rationalise the high exception reporting for two of the mental health indicators above, as there was a low overall number of patients on the register (23 in total). We saw evidence from the clinical system that the five patients had been individually looked at by the practice before excepting.

The practice had a comprehensive programme of quality improvement activity and routinely reviewed the effectiveness and appropriateness of the care provided.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique we can be 95% confident that the practices performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.
