At the previous inspection in May 2019, we found processes for infection prevention control (IPC) were not effective, specifically relating to the management of clinical waste and management of the cold chain.

We found at this inspection that these issues had been resolved and IPC management kept patients safe.

We saw health and safety risk assessments had been carried out for staff returning to work following sickness and there were many risk assessments relating to a wide variety of areas such as lone working.

Explanation of any answers and additional evidence:

Actions taken since the previous inspection to improve management of clinical waste included:

 Discussions with the landlord regarding labelling of clinical waste and agreed actions going forward. Weekly checks were made by the practice to ensure labelling was being carried out. Once satisfied that this process was fully embedded the practice moved to monthly checks which were ongoing. Evidence seen on inspection demonstrated these processes were effective.

We saw notifiable diseases were reported appropriately. For example, a case of diphtheria had been identified in a patient and reported to Public Health England and the patient received the appropriate care. The practice ensured that the clinician received screening and post exposure treatment and did not work until test were returned clear.

To cover absences the practice utilised bank and agency staff who were regular to the practice and whose recruitment processes were the same as for employed staff.

Reception staff had received health navigation training and utilised appropriate software to support them in identifying acutely unwell patients and had the appropriate training and competencies to signpost patients to the appropriate health care.

Explanation of any answers and additional evidence:

Actions taken since the previous inspection ensured vaccines and the cold chain were appropriately managed and included:

- The vaccine fridge, seen at the last inspection, that did not allow for minimum and maximum temperature recording was removed.
- All nursing and administrative staff had received additional cold chain process training.
- Cold chain policy was updated following the previous inspection to ensure improved processes were embedded.
- Data loggers were purchased to improve temperature recording over time and management oversight if a breach of temperatures was identified.
- All fridge temperatures were recorded electronically and visible to all. The lead nurse received alerts if temperature recordings had not been carried out.
- Where temperature excursions had been identified we saw that appropriate actions had been taken.

A GP within the practice took a lead role in antibiotic guardianship and we were told that the practice were the best performing practice in the clinical commissioning group for antibiotic prescribing.

Explanation of any answers and additional evidence:

- All incidents were recorded on teamnet and shared at provider level so that learning could be shared across the organisation.
- All incidents were risk scored and the providers clinical governance team were informed if the incident was scored above 15 and an action plan was put into place.
- If there was the potential that an incident needed to be reported as per the NHS significant incidents frame work a 72 hour initial report was compiled and discussed with the providers senior management team to determine which third party organisations needed to be informed, for example, the care quality commission and clinical commissioning group via the Datix system.
- Three incidents during previous 12 months had been escalated onto the Datix system for oversight by the CCG.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique we can be 95% confident that the practices performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

The following language is used for showing variation:

Note: for the following indicators the variation bands are different:

- Child Immunisation indicators. These are scored against the World Health Organisation target of 95% rather than the England average. Note that
 practices that have "Met 90% minimum" have not met the WHO target of 95%.
- The percentage of respondents to the GP patient survey who responded positively to how easy it was to get through to someone at their GP practice on the phone uses a rules based approach for scoring, due to the distribution of the data. This indicator does not have a CCG average.
- The percentage of women eligible for cervical cancer screening at a given point in time who were screened adequately within a specified period (within 3.5 years for women aged 25 to 49, and within 5.5 years for women aged 50 to 64). This indicator does not have a CCG average and is scored against the national target of 80%.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
