<p>Explanation of any answers and additional evidence:</p> <p>As part of our inspection, we conducted a series of remote clinical searches of the practice's clinical patient records system, to assess the practice's procedures around medicines management and prescribing. The remote electronic review of the searches was undertaken by the CQC GP specialist advisor. The searches were visible to the practice.</p> <p>On the day of inspection we found that Patient Group Directives (a legal framework that allows certain registered health professionals to supply and/or administer specified medicines to a pre-defined group</p>

<p>of patients, without them having to see a prescriber) had not been completed properly and could not demonstrate that staff using them had been authorised to do so. However, this was corrected immediately during our inspection.</p> <p>Emergency medicines were stored securely. There was a stock of emergency medicine in a small bag which was accessible in an emergency. However, on the day of inspection we saw a medicine was not stored in its original packaging.</p> <p>Emergency equipment was stored in one location however some pieces of equipment were held in an emergency trolley and other pieces of equipment were on shelves. In an emergency, it may prove difficult to locate all the required equipment as it was not all stored in one specific place. However, following the inspection the practice told us that the emergency trolley had been reviewed, an audit completed and changes put in place to ensure that all equipment was held together.</p>

The practice showed us that these were discussed at meetings and the learning was shared with staff.</p>

<p>Explanation of any answers and additional evidence:</p> <p>All clinical staff had access to safety alerts information. The practice had systems and processes for receiving and actioning Medicines and Healthcare products Regulatory Agency (MHRA) alerts. Safety alerts were accessed through the electronic system and senior members of staff had responsibility for ensuring the information was cascaded and acted upon.</p> <p>However, our clinical searches showed 24 patients were prescribed a teratogenic medicine (medicine used to treat conditions such as epilepsy which can be harmful during pregnancy). Five of the records we looked at showed that although an initial discussion had been documented at the time of commencing treatment, there was no further evidence of recent discussion of ongoing risk. The provider addressed this immediately and contacted the patients explaining the on going risk and offering them the opportunity to attend the practice if concerned.</p>	

Effective

Explanation of any answers and additional evidence: Our GP specialist advisor reviewed five records for patients diagnosed with hypothyroidism (a condition where the thyroid gland does not produce enough hormones). The GP specialist advisor did not find evidence that these five patients had received the appropriate monitoring prior to their last prescription being issued. We informed the practice of this and since the inspection, they had identified all the patients that are overdue monitoring and have submitted an action taking steps to address this. Staff told us that case-based discussions were held during clinical meetings, and that this gave them an opportunity for retrospective evaluation of clinical decision-making in patient care. Staff told us they kept up to date with current evidence-based guidance through clinical meetings and during practice protected time.	

Effective care for the practice population

Findings

- The practice used a clinical tool to identify older patients who were living with moderate or severe frailty. Those identified received a full assessment of their physical, mental and social needs.
- Flu, shingles and pneumonia vaccinations were offered to relevant patients in this age group.
- The practice had systems to inform eligible patients to have the meningitis vaccine, for example before attending university for the first time.
- The practice had a learning disability register and patients on this register were offered an annual health check.
- End of life care was delivered in a coordinated way which took into account the needs of those whose circumstances may make them vulnerable.
- The practice had a system for vaccinating patients with an underlying medical condition according to the recommended schedule.
- The practice demonstrated that they had a system to identify people who misused substances.
- The practice assessed and monitored the physical health of people with mental illness, severe mental illness, and personality disorder
- Patients with poor mental health, including dementia, were referred to appropriate services.
- The practice was part of a wider Primary Care Network (PCN) which included various roles that could support patients. For example, the PCN's frailty nurse completed home visits and supported patients who were receiving palliative care but who were not at the end of their life.

Management of people with long-term conditions

Findings

Covid-19 pandemic had significantly impacted opportunities to improve performance of the treatment and monitoring of long-term conditions since February 2020. Following our remote searches of the electronic clinical record system, we had a conversation with the GP who was able to comment on the outcome of the searches and data and confirm how the practice is working to improve them.

The provider had a PCN Pharmacist who was assisting with medication reviews.

- Our clinical searches of the practice's patient records system, found 40 patients diagnosed with asthma, who had been prescribed two or more courses of rescue steroids within the last 12 months. (Steroids are used to reduce inflammatory processes of an acute asthma episode.) We looked at five records and found that three of those patients had not been followed up appropriately to ensure their asthma was well controlled; One patient was prescribed steroids as a repeat prescription and had not had a review with a GP. Two patients were overdue their review and one patient had declined an appointment.
- Most patients with long-term conditions were offered a structured annual review to check their health and medicines needs were being met. The practice was working hard to reduce the backlog of patients with long-term conditions who required routine monitoring, caused by the COVID-19 pandemic. We saw that the practice had engaged with the PCN to support them in delivering structured reviews of those patients outstanding appropriate monitoring.
- For patients with the most complex needs, the GP worked with other health and care professionals to deliver a coordinated package of care.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma. The practice accessed support from the PCN respiratory specialist nurse.
- The practice shared clear and accurate information with relevant professionals when deciding care delivery for patients with long-term conditions.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins.
- Patients with suspected hypertension were offered ambulatory blood pressure monitoring.
- Patients with COPD were offered rescue packs.

<p>The percentage of women eligible for cervical cancer screening who were screened adequately within a specified period was 69.2% which is below the 70% national uptake target level and below the 80% national target level.</p> <p>The provider was aware and had looked at ways to improve uptake. The provider had shortened appointments to offer more availability following the easing of Covid -19 restrictions. Follow up calls were made to patients that did not attend their appointments which provided an opportunity to discuss any concerns.</p>

Staff told us they felt supported in their roles and were able to speak to their line managers and wider management team when needed. However, whilst clinical staff had informal discussions relating to patient care there was no structured clinical supervision in place to ensure the competencies of clinicians working in advanced clinical roles such as nurse practitioners.</p> <p>Staff told us they were supported to undertake training. Staff had either protected time to complete training or were paid overtime.</p>

Further information about how the practice is responding to the needs of their population

The provider worked closely with the PCN and NHS Dorset (formally Dorset clinical commissioning group) to offer access to a variety of services such as 'steps to wellbeing', 'Head space', 'every mind matters' and 'conneXions' (a 24 hour help line).

The provider used the patient survey as well as engagement with the Patient Participation Group (PPG) to influence changes where possible.

- Patients had a named GP who supported them in whatever setting they lived.
- The practice was responsive to the needs of older patients and offered home visits and urgent appointments for those with enhanced needs and complex medical issues.
- In recognition of the religious and cultural observances of some patients, the GP would respond quickly, often outside of normal working hours, to provide the necessary death certification to enable prompt burial in line with families' wishes when bereavement occurred.
- The practice liaised regularly with the community services to discuss and manage the needs of patients with complex medical issues.
- All parents or guardians calling with concerns about a child were offered a same day appointment when necessary.
- The practice held a register of patients living in vulnerable circumstances including homeless people, travellers and those with a learning disability.
- People in vulnerable circumstances were easily able to register with the practice, including those with no fixed abode such as homeless people and travellers.

Access to the service

People were to access care and treatment in a timely way.

The COVID-19 pandemic has affected access to GP practices and presented many challenges. In order to keep both patients and staff safe early in the pandemic practices were asked by NHS England and Improvement to assess patients remotely (for example by telephone or video consultation) when contacting the practice and to only see patients in the practice when deemed to be clinically appropriate to do so. Following the changes in national guidance during the summer of 2021 there has been a more flexible approach to patients interacting with their practice. During the pandemic there was a significant increase in telephone and online consultations compared to patients being predominantly seen in a face to face setting.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique, we can be 95% confident that the practice's performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

- Child Immunisation indicators. These are scored against the World Health Organisation target of 95% rather than the England average. Note that practices that have "Met 90% minimum" have not met the WHO target of 95%.
- The percentage of respondents to the GP patient survey who responded positively to how easy it was to get through to someone at their GP practice on the phone uses a rules-based approach for scoring, due to the distribution of the data. This indicator does not have a CCG average.
- The percentage of women eligible for cervical cancer screening at a given point in time who were screened adequately within a specified period (within 3.5 years for women aged 25 to 49, and within 5.5 years for women aged 50 to 64). This indicator does not have a CCG average and is scored against the national target of 80%.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
