However, on the day of the inspection, we saw blank prescription forms for use in printers and handwritten pads were not handled in accordance with national guidance as these were not recorded correctly and tracked through the practice at all times. Shortly after the last inspection the practice submitted evidence that a system had been implemented to ensure prescription pads were recorded correctly and tracked through the practice and at this inspection we found the system was working effectively.

Effective

At the last inspection in August 2019, the practice was rated as requires improvement for providing effective services because:

- The practice's uptake of the childhood immunisations rates were generally below the national averages.
- The practice's uptake of the national screening programme for cervical cancer was below the local and the national averages.

At this inspection we found that childhood immunisation and cervical smear uptake had steadily improved with an effective action plan was in place to improve further and bring uptake in line with national targets. The practice is now rated good for providing effective services.

Older people

Population group rating: Good

Findings

- The practice used a clinical tool to identify older patients who were living with moderate or severe frailty. Those identified received a full assessment of their physical, mental and social needs.
- The practice followed up on older patients discharged from hospital. It ensured that their care plans and prescriptions were updated to reflect any extra or changed needs.
- The practice carried out structured annual medicines reviews for older patients.
- Staff had appropriate knowledge of treating older people including their psychological, mental and communication needs.
- Health checks, including frailty assessments, were offered to patients over 75 years of age.
- Flu, shingles and pneumonia vaccinations were offered to relevant patients in this age group.

People with long-term conditions

Population group rating: Good

Findings

- Patients with long-term conditions were offered a structured annual review to check their health and medicines needs were being met. For patients with the most complex needs, the GP worked with other health and care professionals to deliver a coordinated package of care.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma.
- The practice shared clear and accurate information with relevant professionals when deciding care delivery for patients with long-term conditions.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins.
- Patients with suspected hypertension were offered ambulatory blood pressure monitoring.
- Patients with atrial fibrillation were assessed for stroke risk and treated appropriately.
- Patients with COPD were offered rescue packs.
- Patients with asthma were offered an asthma management plan.

Families, children and young people

Population group rating: Good

Findings

- The practice has not met the minimum 90% for four of five childhood immunisation uptake indicators. The practice has not met the WHO based national target of 95% (the recommended standard for achieving herd immunity) for five of five childhood immunisation uptake indicators. However, the practice could demonstrate they had implemented a robust action plan with evidence that uptake was improving as a result.
- The practice contacted the parents or guardians of children due to have childhood immunisations.
- The practice had arrangements for following up failed attendance of children's appointments following an appointment in secondary care or for immunisation and would liaise with health visitors when necessary.
- The practice had arrangements to identify and review the treatment of newly pregnant women on long-term medicines. These patients were provided with advice and post-natal support in accordance with best practice guidance.
- Young people could access services for sexual health and contraception.
- Staff had the appropriate skills and training to carry out reviews for this population group.

Any additional evidence or comments

Leaders informed us that a number of factors had contributed to the low uptake of immunisations. In 2018 the senior nurse retired which led to the practice working with locum nurses and an overall reduction in nursing capacity. Consequently, the practice were unable to allow as much nursing admin time, and the calling of non-attenders was take up by admin staff which proved less effective at allaying the fears of parents with concerns than direct contact with a nurse.

In addition, the current situation with the covid-19 pandemic had kept patients away which has not helped to achieve better uptake. The practices recall system (text messages and letters sent) proved insufficient, and because of nursing staff shortages the practice were not able to offer telephone consultations with non-attenders. However, since the last inspection the practice could demonstrate they had put a robust action plan in place that prioritised childhood immunisations involving all staff in the process. The plan also prioritised the practices large cohort of patients from abroad with missing or incomplete immunisation records. The practice addressed this by implementing a change in the registration process for children, to focus on their immunisation records. Leaders told us that all children under the age of five were now given a face to face appointment with the nurse upon registration, to assess and administer any missing

immunisations. The practice had employed two more nurses resulting in currently 71 hours of nursing time per week with one of the nurses being the nominated child immunisation lead for the practice who contacted all non-responders to text/ letters directly via telephone.

The practice had also added information leaflets on childhood immunisations to the practice website in a number of different languages appropriate to the patient cohort and pop-up reminders on the computer system to opportunistically identify eligible patients. The lead nurse told us that there were no immunisation clinics as such because they led to an increase in non-attenders. Therefore they saw patients ad-hoc and due to the nursing capacity could always fit in children for immunisations when required.

Working age people (including those recently retired and students)

Population group rating: Good

Findings

- The practice was taking action to improve cervical screening uptake. Between September 2019 & March 2021 (latest published data), uptake had steadily improved from 53.2% to 61.3%. An effective action plan was in place to continue the improvement.
- The practice had systems to inform eligible patients to have the meningitis vaccine, for example before attending university for the first time.

- Patients had access to appropriate health assessments and checks including NHS checks for patients aged 40 to 74. There was appropriate and timely follow-up on the outcome of health assessments and checks where abnormalities or risk factors were identified.
- Patients could book or cancel appointments online and order repeat medicines without the need to attend the surgery.

Any additional evidence or comments

Leaders told us that a number of factors had contributed to the low uptake of cervical smears. As outlined previously, In 2018 the senior nurse retired which led to the practice working with locum nurses and an overall reduction in nursing capacity. Consequently, the practice were unable to allow as much nursing admin time, and the calling of non-attenders was take up by admin staff which proved less effective at allaying the fears of patients with concerns.

In addition, the current situation with the covid-19 pandemic had kept patients away which has not helped to achieve better uptake. The practices recall system (text messages and letters sent) proved insufficient, and because of nursing staff shortages the practice were not able to offer telephone consultations with non-attenders. Another factor the practice told us had affected their uptake figures was the transient population who had had cervical screening abroad and were not providing results to enter into the clinical system.

However, since the last inspection the practice could demonstrate they had put a robust action plan in place that prioritized cervical smears involving all staff in the process. The practice had employed two more nurses resulting in currently 71 hours of nursing time per week with one of the nurses being the nominated cervical smear lead for the practice who contacted all non-responders by text/letters and

directly via telephone. The practice had also added information leaflets on cervical smears to the practice website in a number of different languages appropriate to the patient cohort and pop-up reminders on the computer system to opportunistically identify eligible patients. The practice were flexible with appointments and could offer any time in the week including early and late appointments.

The practice also provided data that showed their Primary Care Network (PCN) had the lowest uptake in the Clinical Commissioning Group which was an average of 53.1%. The practices uptake of 61.3% was therefore at the higher achievement end within the PCN.

People whose circumstances make them vulnerable

- Same day appointments and longer appointments were offered when required.
- All patients with a learning disability were offered an annual health check.
- End of life care was delivered in a coordinated way which took into account the needs of those whose circumstances may make them vulnerable.
- The practice had a system for vaccinating patients with an underlying medical condition according to the recommended schedule.
- The practice demonstrated that they had a system to identify people who misused substances.

**People experiencing poor mental health
(including people with dementia)**

Population group rating: Good

Findings

- The practice assessed and monitored the physical health of people with mental illness, severe mental illness, and personality disorder by providing access to health checks, interventions for physical activity, obesity, diabetes, heart disease, cancer and access to 'stop smoking' services.
- Same day and longer appointments were offered when required.
- There was a system for following up patients who failed to attend for administration of long-term medicines.
- When patients were assessed to be at risk of suicide or self-harm the practice had arrangements in place to help them to remain safe.
- Patients at risk of dementia were identified and offered an assessment to detect possible signs of dementia. When dementia was suspected there was an appropriate referral for diagnosis.
- All staff had received dementia training in the last 12 months.
- Patients with poor mental health, including dementia, were referred to appropriate services.

Any additional evidence or comments

The practice provided a Personalised Care Adjustment (PCA) audit which demonstrated that the practice had not exempted any patients on the mental health register. The clinical IT system (System One) automatically excludes the patient with at least two invites. However, the practice provided evidence that they were continuing to recall patients after the two invites rather than excepting them.

We spoke with to members of the Patient Participation Group. Both spoke positively about the practice in terms of being a patient. Since the pandemic they told us that it had been difficult to arrange meetings with the practice and Patient Participation Group members. However, meetings were something they were keen to reinstate once circumstances allowed. The members we spoke with told us that the practice did listen to patient opinion and views and took on board any points for improvement. For example, the practice had moved a noticeboard from a corridor to the main waiting area in response to patient feedback and they had met the needs of patients who because of their cultural background had a preferred gender of GP.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique we can be 95% confident that the practice's performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

The following language is used for showing variation:

- Child Immunisation indicators. These are scored against the World Health Organisation target of 95% rather than the England average. Note that practices that have "Met 90% minimum" have not met the WHO target of 95%.
- The percentage of respondents to the GP patient survey who responded positively to how easy it was to get through to someone at their GP practice on the phone uses a rules based approach for scoring, due to the distribution of the data. This indicator does not have a CCG average.
- The percentage of women eligible for cervical cancer screening at a given point in time who were screened adequately within a specified period (within 3.5 years for women aged 25 to 49, and within 5.5 years for women aged 50 to 64). This indicator does not have a CCG average and is scored against the national target of 80%.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.

Note: The CQC GP Evidence Table uses the most recent validated and publicly available data. In some cases at the time of inspection this data may be relatively old. This has been taken into account during the inspection process.
