Explanation of any answers and additional evidence: The provider told us of an event where a patient's prescription was collected, and the practice had not determined the person collecting the prescription had authorization to do so. This led to the practice having to take action to develop a process which would protect patients from this happening again. This led to the practice devising a form where patient's authorization could be given as to who could collect their prescriptions. With the onset of the pandemic and patients no longer routinely visiting the practice, electronic prescriptions were then developed. Prescriptions would be electronically sent to the pharmacy of the patient's choice and from there the patient could arrange for collection, this reduced the need for patients to collect prescriptions from the practice.

Effective care for the practice population

Findings

- The practice used a clinical tool to identify older patients who were living with moderate or severe frailty. Those identified received a full assessment of their physical, mental and social needs.
- Health checks, including frailty assessments, were offered to patients over 75 years of age.
- Flu, shingles and pneumonia vaccinations were offered to relevant patients in this age group.
- The practice had systems to inform eligible patients to have the meningitis vaccine, for example before attending university for the first time.

- Patients had access to appropriate health assessments and checks including NHS checks for patients aged 40 to 74. There was appropriate and timely follow-up on the outcome of health assessments and checks where abnormalities or risk factors were identified.
- All patients with a learning disability were offered an annual health check.
- End of life care was delivered in a coordinated way which considered the needs of those whose circumstances may make them vulnerable.
- The practice had a system for vaccinating patients with an underlying medical condition according to the recommended schedule.
- The practice demonstrated that they had a system to identify people who misused substances.
- The practice assessed and monitored the physical health of people with mental illness, severe mental illness, and personality disorder
- Patients with poor mental health, including dementia, were referred to appropriate services.

Management of people with long term conditions

Findings

- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma.
- The practice shared clear and accurate information with relevant professionals when deciding care delivery for patients with long-term conditions.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins.
- Patients with COPD were offered rescue packs.
- Patients with asthma were offered an asthma management plan.

Any additional evidence or comments

The practice had not met the minimum 90% uptake target for three of the five childhood immunisation indicators. The practice was already reviewing this and following up with parents/carers where children had not attended appointments. We saw from previous years while the practice had not met the minimum 90% uptake target, they had consistently improved their percentage year on year. Due to the action they were already taking to improve child immunisation rates in their population.

Any additional evidence or comments

- The practice performance for the uptake of cervical cancer screening was below the 80% national target. However, the practice was aware of the difficulties within the patient population and were working hard to meet the national target.
- We found the practice were already pro-actively taking action to improve. For example, patients would be discussed in clinical meetings to actively find ways to support them to attend screenings. They had also trained and employed staff so they could carry out more of this work and also follow up patients quicker where needed.
- We found since this screen shot in March 2021 a more recent screen shot showed the percentage had much improved. The practice had a program in place where patients were reminded annually about their screening check. The practice would discuss this with newly registered patients where necessary and monitor on an annually basis patients over 25 years.
- All this seems to be improving the expected target for the practice.

For example, they had already recognised there was a communication issue with some patients within the practice area and developed in house interpreters that would now be used in consultations where it was clear there was a potential communication/listening concern that needed interpreter support. The practice had also developed social prescribers, lifestyle advisor that could support patients and maybe refer them onto other services where needed. Due to the multi-cultural population the practice serves, the staff team were also multi-cultural so they would reflect the patient population and where needed chaperoning patients would be easier and being able to seek appropriate consent when needed. <p>We found all but one of the patient experiences survey in the last year had improved, which suggests the practice action plan is producing the expected improvement.</p>

Further information about how the practice is responding to the needs of their population

- Patients had a named GP who supported them in whatever setting they lived.
- The practice was responsive to the needs of older patients and offered home visits and urgent appointments for those with enhanced needs and complex medical issues.
- In recognition of the religious and cultural observances of some patients, the GP would respond quickly, often outside of normal working hours, to provide the necessary death certification to enable prompt burial in line with families' wishes when bereavement occurred.
- There was a medicines delivery service for housebound patients.
- The practice liaised regularly with the community services to discuss and manage the needs of patients with complex medical issues.
- Additional clinical appointments were available in the practice until 6:30pm Monday to Friday for school age children so that they did not need to miss school and for patients who worked.
- All parents or guardians calling with concerns about a child were offered a same day appointment when necessary.
- The practice was open until 6pm Monday to Friday. Pre-bookable appointments were also available to all patients at the local Primary Care Network (PCN) hub between 6:30pm to 8:30pm Monday to Friday. Appointments were also available Saturday and Sunday 9am until 11am.
- The practice held a register of patients living in vulnerable circumstances including homeless people, travellers and those with a learning disability.
- People in vulnerable circumstances were easily able to register with the practice, including those with no fixed abode such as homeless people and travellers.

The practice adjusted the delivery of its services to meet the needs of patients with a learning disability.

Access to the service

People were able to access care and treatment in a timely way.

The COVID-19 pandemic has affected access to GP practices and presented many challenges. In order to keep both patients and staff safe early in the pandemic practices were asked by NHS England and Improvement to assess patients remotely (for example by telephone or video consultation) when contacting the practice and to only see patients in the practice when deemed to be clinically appropriate to do so. Following the changes in national guidance during the summer of 2021 there has been a more flexible approach to patients interacting with their practice. Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique, we can be 95% confident that the practice's performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

The following language is used for showing variation:

- Child Immunisation indicators. These are scored against the World Health Organisation target of 95% rather than the England average. Note that practices that have "Met 90% minimum" have not met the WHO target of 95%.
- The percentage of respondents to the GP patient survey who responded positively to how easy it was to get through to someone at their GP practice on the phone uses a rules-based approach for scoring, due to the distribution of the data. This indicator does not have a CCG average.
- The percentage of women eligible for cervical cancer screening at a given point in time who were screened adequately within a specified period (within 3.5 years for women aged 25 to 49, and within 5.5 years for women aged 50 to 64). This indicator does not have a CCG average and is scored against the national target of 80%.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
