We rated the practice as overall **outstanding** because:

- The practice had clear systems, practices and processes to keep people safe and safeguarded from abuse.
- People were truly respected and valued as individuals and were empowered as partners in their care, practically and emotionally, by an exceptional and distinctive service.
- Feedback from people who used the service, those who were close to them, and stakeholders was
 continually positive about the way staff treated people. People thought that staff went the extra mile,
 and their care and support exceeded their expectations.
- Feedback from patients was consistently positive and was higher than local and national averages.
- The practice demonstrated a truly patient-centred culture and staff were committed to delivering excellent care to meet the needs of individuals.
- The practice adopted a holistic approach to caring, by addressing all the needs of the patient, including their physical, mental, and emotional health, while taking social factors into consideration.
- Services were tailored to meet the needs of individual people and were delivered in a way to ensure flexibility, choice and continuity of care.
- There were innovative approaches to providing integrated person-centred pathways of care that involved other service providers, particularly for people with multiple and complex needs.
- Facilities and premises were innovative to meet the needs of a range of people who used the service.
- Patients could access care and treatment in a timely way.
- The practice had educational resources to ensure the patient population had the appropriate knowledge and understanding when accessing the surgery.

- The practice had achieved higher than national and local average results in the national GP patient survey and had maintained these high scores for several years.
- The practice had adjusted how it delivered services to meet the needs of patients during the COVID-19 pandemic.
- Leaders had an inspiring shared purpose and strived to deliver and motivate staff to succeed.
- There was compassionate, inclusive and effective leadership at all levels. Leaders at all levels
 demonstrated the high levels of experience, capacity and capability needed to deliver excellent and
 sustainable care. Risks to performance were addressed. There was a deeply embedded system of
 leadership development and succession planning, which aimed to ensure that the leadership
 represented the diversity of the workforce.
- Leaders at every level were visible and approachable. Compassionate, inclusive and effective leadership was sustained through a leadership strategy and development programme and effective selection, deployment and support processes and succession planning.
- Comprehensive and successful leadership strategies were in place to ensure and sustain delivery and to develop the desired culture. Leaders have a deep understanding of issues, challenges and priorities in their service, and beyond.
- There were high levels of staff satisfaction across all staff groups. Staff were proud of the organisation as a place to work and spoke highly of the culture. Staff at all levels were actively encouraged to speak up and raise concerns, and all policies and procedures positively supported this process. There were consistently high levels of constructive staff engagement. Staff felt valued and supported to develop professionally. There were opportunities provided for all staff for their personal development.
- There was a strong organisational commitment towards quality and inclusion across all the patient population and the workforce.
- Quality and integrity were a high priority resulting in a caring culture within a strong practice.
- The leadership, governance and culture were used to drive and improve the delivery of high-quality person-centred care.
- There was strong collaboration across all staff and a common focus on engaging with patients and other services to improve quality of care and the patient experience.
- The practice embraced social prescribing for the community to ensure patients received timely
 intervention when they needed it most, signposted them to services that could help them and ensured
 support was offered locally so the patient population could easily attend appointments.

Explanation of any answers and additional evidence:

1. Dr A M Wright and Partners had a safeguarding lead who had been trained to Level 4. This was a huge benefit to the practice as it had well documented, protocolised and embedded safeguarding processes to protect both children and adults. Safeguarding Adults Level 4 course is designed to build on the knowledge of lead professionals involved in safeguarding Adults at risk of harm, who may be involved or asked to lead an investigation regarding the abuse or neglect of an adult at risk of harm.

Staff we spoke with and those who completed the CQC staff questionnaire told us that the safeguarding lead was easily contactable. They were able to contact them during and out of working hours via telephone or the task system on the clinical record system.

During our inspection we found the systems and processes for safeguarding were tried, tested, and found to be effective in its delivery. Staff members we spoke with and who completed the CQC staff questionnaires felt confident that any potential safeguarding concern identified could be escalated in the knowledge that there would be robust oversight, a thorough investigation by liaising with multi agencies, collation of information and follow up. This alleviated undue pressure and anxiety on clinicians.

The safeguarding lead delivered safeguarding training and education to staff to enable them to recognise differences in risk levels, with additional visual support from detailed laminated posters in all consulting rooms and up to date contact numbers and names to empower prompt referrals.

The safeguarding team gathered relevant information from various sources by having direct links with Health Visiting teams, Midwives, School Nurses, Social services, Multi-Agency Safeguarding Hub (MASH) teams and the Police and linked together family members in order to risk stratify each case. As a result of gathering this detailed and high-level information we saw evidence of very detailed comprehensive reports having been generated for local safeguarding meetings. This meant the practice were able to demonstrate that their patients were safe and safeguarded from abuse.

There was a dedicated administration member of staff who collated and wrote reports, made sure that responses were timely and ensured patient records were correctly coded.

Records had specific read codes that were current with alerts, icons, information regarding parental responsibility and family contacts.

Cases were reviewed in depth with expert knowledge and oversight by the lead safeguarding GP who provided feedback to the referrer with a management plan which could include referral to social services.

Explanation of any answers and additional evidence:	

- 1. At the time of the inspection, we found that a legionella risk assessment had taken place alongside a review by an external company. We queried on the day the temperature of the main boiler and the escalation of temperatures that were below the recommended ranges. We saw a spreadsheet in place for the maintenance worker to complete but the management team had not been advised and actions taken if required. We then reviewed a legionella logbook completed by the housekeeping team which was found to be much clearer with monthly water temperatures that were within the required ranges. Since the inspection the management team had a new full legionella risk assessment carried out by the external company and were awaiting the report. The external company had been asked to provide staff with some additional legionella training in the coming months.
- 2. Electrical Installation Condition Report was completed on 3 January 2023. At the time of the inspection some remedial work was still to be completed as the practice were waiting for the external company to confirm a start date. They had contacted the external company to chase completion of this work.

Explanation of any answers and additional evidence:

- 1. We observed high standards of infection prevention and control across the whole practice. The partners of the surgery employed their own housekeeping team, and they were visible all day five days a week. We observed the premises to be clean and tidy.
- 2. The practice carried out additional infection control audits, such as handwashing, uniform, and sharps safety audits. Actions were identified in respect of sharps safety, so a staff refresher training session took place during their monthly TARGET (Time for Audit Research Governance Education and Training) meeting in July 2023. Staff were given protected time to learn, develop and review their practice. In October 2022 the practice was awarded a 5-star rating for the cleanliness of their practice by an external company.
- 3. Records we reviewed demonstrated that staff had received up to date training. The practice had a new infection control lead who was learning the role and had commenced infection control audits.
- 4. We saw examples where significant event analyses had been completed in respect of infection prevention and control. For example, a needle put in clinical waste instead of in a sharp's container. Sharps safety was reiterated to all staff and refresher training took place in July 2023.

Explanation of any answers and additional evidence:

- 1. An on-call GP was available every day to assist reception staff, nursing and GP registrars with any patient queries.
- 2. Staff we spoke with and those staff who completed the CQC staff questionnaire confirmed that they knew how to access the emergency medicines should they need to do so. They confirmed that there was an emergency button on the computer system to alert staff should an emergency arise.

The practice also had 2 fully equipped Clinical Assessment Rooms for medical emergencies which ensured that clinical staff were able to access equipment and provide emergency care as required.

Explanation of any answers and additional evidence:	

As part of the inspection clinical record searches were undertaken by a CQC GP Specialist Advisor without visiting the practice. These searches were visible to the practice. We found that individual care records were written and managed in a way that kept patients safe. The care records showed that information needed to deliver safe care and treatment was available to all relevant staff in an accessible way, for example, management plans and safety netting.

Appropriate and safe use of medicines

The practice had systems for the appropriate and safe use of medicines, including medicines optimisation.

Explanation of any answers and additional evidence, including from clinical searches.

1. As part of the inspection clinical record searches were undertaken by a CQC GP Specialist Advisor without visiting the practice. These searches were visible to the practice.

The records of patients prescribed certain high-risk medicines were checked to ensure the required monitoring was taking place.

The records we examined provided evidence that patients prescribed high risk medicines had been monitored appropriately.

The clinical searches identified a total of 32 patients prescribed Disease Modifying Anti-Rheumatic Drugs (DMARD's) such as azathioprine (a type of medicine that helps reduce inflammation). Of these we sampled 4 patient records and found they were being appropriately monitored.

The practice had a system in place to note the prescriptions of patients prescribed high risk medicines to highlight they must have blood tests at the required intervals and repeat prescriptions would be issued if the required tests had taken place. We noted that the recording of patient medicine reviews provided consistent and comprehensive information regarding the patient and their prescribed medicines.

During the pandemic the practice, in line with guidance, postponed routine medication reviews and phlebotomy unless considered necessary. The practice took a decision to protect high risk patients as the risk of COVID-19 to these patients was greater than delaying recommended blood tests.

Patient centred care was at the core of the work carried out at the practice. All patients were reviewed by birth month to include all those who required medicine monitoring and reviews. Appointments for reviews were extended dependent on how many long-term conditions required monitoring, reducing the need for patients to come back for additional appointments.

The clinical searches identified a total of 3 patients prescribed combination medicines such as clopidogrel and esomeprazole. (Medicines for heart disease and stomach protection). Of these we sampled all 3 records and found they were being appropriately monitored.

- 2. We noted some antibacterials were prescribed in higher-than-average quantities. We discussed this with the lead GP who told us that the practice had an antibiotic champion. Antibacterial prescription items had been discussed formally and informally. There were charts in the education room to show prescribing of the surgery. The practice was also aware that prescribing of quinolones, co-amoxiclav, cephalosporins and quinolones was higher than ICB and England average and had undertaken a review and found that it was mainly due to GP Registrars sticking strictly to NICE guidance. All prescribers had all been made aware of local formulary for medications. Advanced Nurse Practitioners spoke with a GP partner if they wanted to prescribe quinolones etc. They planned to continue to monitor both areas and carry out audits to review and implement changes.
- 3. On the day of the inspection, we found that most staff had the appropriate authorisations to administer medicines (including Patient Group Directions or Patient Specific Directions). However, two new nurses had commenced work at the practice and the lead GP had not authorised the PGDs, but this was rectified at the inspection.
- 4. The practice could not fully demonstrate the prescribing competence of non-medical prescribers, and their formalised review of their prescribing practice supported by clinical supervision or peer review. This was discussed during a CQC staff interview and on the day of the inspection the partners of the practice told us that they had discussed this, written a formalised practice process which would commence on 1 September 2023.
- 5. At our inspection we found that the management of the medicine's refrigerators, in relation to the recording and monitoring of the temperatures, was effective. However, we did find one package that had not been stored correctly and could not be assured of the efficacy of the medicines that they contained. This was removed by the provider during the inspection.

Explanation of any answers and other comments on dispensary services:

- There was a GP partner responsible for dispensary services. We were told that they were visible and visited the dispensary daily.
- The dispensary was well organised, clean and well managed.
- The dispensary provided medicines to approximately 33% of the practice's registered patients (those who resided more than one mile from a pharmacy) and dispensed approximately 144,000 items per year. Turnaround times for dispensing medicines were 72 hours at the time of our inspection.
- All members of the dispensary team had completed NVQ Level 2 training. All dispensers received annual competency checks.
- The practice was signed up to Dispensary Services Quality Scheme (DSQS). The scheme is voluntary
 and rewards organisations for providing high-quality services to dispensing patients. As part of the
 scheme, the practice undertook an annual Dispensing Review Use of Medications (DRUMs), and these
 were carried out by the nursing team.
- The dispensary had two refrigerators to store medicines but on the day of the inspection we found that these were too full and did not allow for air to circulate around the bottom of the refrigerator. This was rectified during the inspection.
- We saw that the practice provided medicines in Monitored Dosage Systems to 160 patients. The
 dispensary team had a separate room where these were completed on a weekly basis.
- The practice had a dispensary delivery service two days a week.
- Security arrangements were in place to control access into the dispensary.
- The dispensary team recorded significant events although there had not been any recent events which
 had been classed as such. The team also recorded near misses. These had been reviewed at the
 monthly dispensary team meetings where any learning was identified and shared, but these were not
 fed into the wider reporting system or practice meetings.

Explanation of any answers and additional evidence:

- 1. Staff we spoke with or those who had completed the CQC staff questionnaires told us they felt reassured and able to raise and discuss concerns in an open environment. Each department had individual leaders who all came together formally and informally to discuss concerns. Staff spoke of an open culture where people were able to talk and discuss openly.
- 2. There was evidence in meeting minutes that learning, and dissemination of information took place, however meeting minutes were not detailed enough to ensure those that did not attend the meetings had enough information.

The provider was able to demonstrate that all relevant safety alerts had been responded to. The dispensing lead reviewed all medicine safety alerts and disseminated them to the appropriate clinicians via the internal IT systems. We saw examples of actions taken on recent alerts, for example, regarding sodium valproate.

Explanation of any answers and additional evidence:

Staff had access to guidelines from the National Institute for Health and Care Excellence and used this information to deliver safe, effective and up-to-date care and treatment that met patient's needs.

Effective care for the practice population

Findings

- Health checks, including frailty assessments, were offered to patients over 75 years of age.
- Flu, shingles and pneumonia vaccinations were offered to relevant patients in this age group.
- Patients had access to appropriate health assessments and checks including NHS checks for patients aged 40 to 74. There was appropriate and timely follow-up on the outcome of health assessments and checks where abnormalities or risk factors were identified.
- We conducted a remote clinical search of patients with a potential missed diagnosis of diabetes. The
 practice had ongoing audits in place. In March 2022 a search showed 90 potential patients where all
 were reviewed, and any outstanding monitoring was completed in March 2023. A further audit was
 carried out in August 2023 where 68 patients were found, of which 27 were new diagnoses. 41 needed
 repeat bloods and 7 were under active review. This was ongoing work and would have a further audit
 completed in three months.
- All patients with a learning disability were offered an annual health check. The practice had 97 patients
 registered with a learning disability, 71% of which had received an annual health check. Work was
 ongoing and invitations continued to be sent out for all patients to have an annual health check.
- End of life care was delivered in a coordinated way which considered the needs of those whose
 circumstances may make them vulnerable. In June 2022 the practice received a Lincolnshire Care
 Award for cancer patients. They proved that staff had gone above and beyond for their patients. To
 qualify for the award, they had invited patients to cancer care reviews, carried out these reviews
 effectively, provided support for families, and promoted a standardised service.
- DNACPR care plans were in place for patients on end-of-life treatment and contained information specific to the wishes of individuals involved.
- The practice had 2 care co-ordinators who were responsible, along with the patient's named GP to provider specialist care for the frail elderly.
- The practice assessed and monitored the physical health of people with mental illness, severe mental illness, and personality disorder. The practice had 64 patients on the register of which 69% had received a review. Work was ongoing and invitations continued to be sent for all patients to have a review.
- Patients who experienced dementia, were referred to appropriate services. The practice had 146 patients on the register of which 82% had received a review.

Management of people with long term conditions

Findings

As part of the inspection a number of set clinical record searches were undertaken by a CQC GP Specialist Advisor (SpA) without visiting the practice. These searches were visible to the practice.

The following results were identified: -

- Patients with long-term conditions were offered an effective annual review to check their health and
 medicines needs were being met. For patients with the most complex needs, the GP worked with other
 health and care professionals to deliver a coordinated package of care.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.

- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins.
- · Patients with suspected hypertension were offered ambulatory blood pressure monitoring.
- Patients with COPD were offered rescue packs. The remote clinical searches identified a total of 113 patients with asthma who have had 2 or more courses of oral steroids to manage acute asthma in the last 12 months. We examined 5 patient records and found 5 of the 5 patients did not have a steroid card when one was deemed appropriate. When we spoke with the management team, we found that this was due to a coding issue, as they were all given one in the medicine bag on collection. They told us that they would undertake an audit of all the patients to ensure they had received the appropriate information.

Any additional evidence or comments

The practice was aware that their immunisation scores were slightly below the expected minimum requirement and worked hard to improve these scores. We saw that they had carried out an Initial audit and data review in January 2023. Achievement was well below the 95% achievement rate with 3 targets below the minimum 90%, though it was noted that there were no exclusion codes that could remove patients whose parents declined. Recall processes were reviewed and updated. Catch-up immunisations were offered, and current processes had now ensured all eligible children had had active recalls and an attempt to have clinician discussion for non-responders. It was envisaged that the impact of this work would be reflected in the vaccination uptake for 2023/4.

The practice was aware that their cervical cancer screening score was slightly below the expected minimum requirement and worked hard to improve these scores. Although CQC could not verify the information, the practice had provided more recent data regarding 50-64 years of age and had achieved 80% which was the minimum target.

The practice had a comprehensive programme of quality improvement activity and routinely reviewed the effectiveness and appropriateness of the care provided.

Examples of improvements demonstrated because of clinical audits or other improvement activity in past two years:

The practice had an ongoing programme of both clinical and non-clinical audits that were used to monitor quality and make improvement when actions were identified.

A summary of audits from August 2021 to 2023 was in place and repeat prescribing audits had been completed for INR/Warfarin prescribing, chronic kidney disease and potential missed diagnosis of diabetes.

Clinical staff performance in recording consent was measured by an audit. Twenty records were reviewed for each of the 5 clinicians of which 4 obtained 100% and 1 clinician 95%.

Non-clinical audits were also carried out in relation to cytology, palliative care, workflow administration, 2 Week Wait referrals and child protection.

One of the practice registrars had put together a patient/ parent information leaflet for sepsis during a time when scarlet fever was prevalent, and parents were concerned about their children.

Explanation of any answers and additional evidence:

1. Mandatory training was set by the partnership and was monitored by the operations manager which was then reviewed by department managers at regular management meetings. Progress was

monitored on the clinical management system and discussed at meetings to ensure all meet current patient need and service demand.

Once a month the practice had TARGET (Time for Audit Research Governance Education and Training) meetings. All these things were important in ensuring that surgery staff could do their jobs as effectively as possible. They closed the surgery one afternoon a month (except August and December) to allow staff protected time to learn, develop and review their practice. Arrangements were in place for patient care during this time.

- 2. All staff were encouraged to discuss their training needs and aspirations to learn new things in order to have the ability to continue to provide high quality care for patients and support the business to continue to improve their outcomes.
- 3. We were provided with a timetable showing when some staff appraisals had taken place and where the remaining appraisals were due to take place in the next three months.
- 4. The practice told us they were assured of the competence of staff employed in advanced clinical practice, for example, advanced nurse practitioners, musculoskeletal practitioners and the clinical pharmacist, however they did not have a formal written process in place. Previously they had informal discussions, and the duty doctor was visible each day for any queries and support. Since the inspection was announced this had been discussed at a partner meeting and a formalised approach would commence from September 2023. We were told and we saw evidence that this would include monthly meetings with each practitioner and a clinical partner, random case analysis, discussion and learning points identified. A protocol for supervision and competency oversight of clinical staff including staff with a prescribing qualification was now in place.
- 5. We saw from a significant event that there was a clear and appropriate approach for supporting and managing staff when performance was poor.

Coordinating care and treatment

1. Dr A M Wright and partners, Bourne Galletly Medical Practice had a wellbeing centre within the practice. They had set up a team which consisted of 2 social prescribers and a well-being coach. Any member of staff could refer a patient to this team, via the patient record system. They endeavoured to contact the patient within 24 hours and introduce the service and what they were able to offer. A telephone or face to face appointment was then set up, at the practice or at the patients' home if needed. Patients worked through a wellbeing plan based on 'what matters most' to the patient and there were a further 6-12 contacts over a 3-month period. In June 2022 the team had put together a 35-page local activities booklet that they maintained and shared with patients along with a cost-of-living crisis guide.

The practice had a counselling service that took place within the practice, and we were told that currently they had 7 counsellors with a turnaround time of 2-3 weeks for first appointment. They also had a debt counsellor visit the practice once a fortnight to support any patients who needed advice and support on any monetary issues.

Caring

We rated the practice as **outstanding** for providing caring services because:

- People were truly respected and valued as individuals and were empowered as partners in their care, practically and emotionally, by an exceptional and distinctive service.
- Feedback from people who used the service, those who were close to them, and stakeholders was continually positive about the way staff treated people and was higher than local and national averages. People thought that staff went the extra mile, and their care and support exceeded their expectations.
- The practice demonstrated a truly patient-centred culture and staff were committed to delivering excellent care to meet the needs of individuals.
- The practice adopted a holistic approach to caring by addressing all the needs of the patient, including their physical, mental, and emotional health, while taking social factors into consideration.
- The practice had achieved higher than national and local averages in the national GP Patient survey and had maintained these high standards for several years.
- We found numerous examples of how the practice had gone to significant efforts to support vulnerable individuals to access health and social care, and how they had worked pro-actively with other organisations to support patients.

Kindness, respect and compassion

We were told by staff that there was a strong, visible person-centred culture. Staff were highly motivated and inspired to offer care that was kind and promoted people's dignity. Relationships between patients, those close to them and staff were strong, caring, 	

- respectful and supportive. The feedback we reviewed, both from patients and staff, indicated that these relationships were highly valued by staff and promoted by leaders.
- Patient's emotional and social needs were seen as being as important as their physical needs.
- We were told that the practice had a 'Galletly Christmas Donations scheme' which had been running for many years. The aim was to promote how dangerous loneliness can be in our elderly population. The Patient Participation Group (PPG) joined them in coordinating the delivery of Christmas gifts to older patients with a personalised signed card from their named GP. They had received many thank you cards each year from grateful patients.
- During our inspection we observed that staff members displayed a kind and caring approach towards patients. We saw evidence that the lead for carers' supported patients who were socially isolated, particularly, during the pandemic. The practice recognised carer fatigue and depression was a real issue and ensured those patients had the appropriate social care support when needed. For example, appointments and activities within the wellbeing centre.

- 1. The practice had not carried out a recent patient survey however they did use several areas to seek feedback, for example,
 - Iwantgreatcare, which is another platform patients can add comments about care and treatment received. This platform was regularly reviewed, and comments were shared with staff. Staff had received an overwhelming number of positive comments over the last 8 years.
 - The NHS.uk website was monitored, and the practice responded to all comments in a timely manner. In the past 12 months 12 reviews had been received of which 7 were very positive, 1 was mixed and 4 were negative. Negative reviews were in relation to phone access, prescription issue and staff attitude.
 - o Google reviews were monitored, and the practice responded to all reviews which were often shared with staff. Results were documented and discussed but themes and trends were not available at the time of the inspection.
 - Friends and family. The practice sent out a text to all patients who have attended an appointment each day (who have consented to being contacted by text) with standard questions. The information was collated and shared monthly. For June 2023 the practice had 332 responses. 291 said their appointment was very good, 17 good, 9 neither good nor poor, 6 poor and 7 very poor. Results were discussed but themes and trends were not available at the time of the inspection.
 - The latest GP National patient survey data was reviewed, checked for comparison against other GP practices in the area and was discussed at a partnership meeting on 1st August 2023.

active partners in care and treatment received. Staff were fully committed to working in partnership with
patients and their families to ensure they received a holistic approach. For example, if they required any

- support, with their consent, a referral was done to the wellbeing centre for review and onward care by the social prescribers or the wellbeing coach.
- The practice displayed information about local services and available support.
- The practice kept regular contact with patients, listened to what was needed and adjusted services accordingly. This included choice of appointment type that met the patient's needs, including throughout the pandemic. For example, all clinic rooms were on the ground floor, there was wide corridors to enable those patients in wheelchairs to have easy access. Patients who experienced hearing problems were given face to face appointments and were collected from the waiting room at their appointment time. There was also hearing loops with printed cards with directions to each waiting room. Waiting rooms were coloured coded and there was clear signage to support those patients who had dementia.

We were told and we saw on the day of the inspection that patients were treated with dignity by all those involved in their care, treatment and support. Consideration of people's privacy and dignity was consistently embedded in everything that staff did, including awareness of any specific needs as these were recorded and communicated.

People who used services, those close to them and staff all understood the expectations of the service around privacy and dignity.

Staff found innovative ways to enable people to manage their own health and care when they can and to maintain independence as much as possible. This included the supply of blood pressure monitors for those who needed them, referrals to the wellbeing centre for support with issues such as loneliness, mobility issues, keeping fit, weight loss, financial guidance.

The chairs in the waiting areas were situated away from the reception desk to maintain confidentiality.

- The practice had achieved outstanding results in the national GP Patient survey and had maintained these high scores for several years.

- There were innovative approaches to providing integrated person-centred pathways of care that involved other service providers, particularly for people with multiple and complex needs.
- The practice had educational resources to ensure the patient population had the appropriate knowledge and understanding when accessing the surgery.
- We found that patients individual needs and preferences were central to the delivery of services.
- Facilities and premises were innovative to meet the needs of a range of people who used the service.
- Patients could access care and treatment in a timely way.
- The practice embraced social prescribing for the community to ensure patients received timely intervention when they needed it most, signposted them to services that could help them and ensured support was offered locally so the patient population could easily attend appointments.

- People's individual needs and preferences were central to the delivery of tailored services.
- There were innovative approaches to providing integrated person-centred pathways of care that involve other service providers, particularly for people with multiple and complex needs.
- The services were flexible, provide informed choice and ensured continuity of care.
- The practice adapted delivery of services to meet the needs of the patient population. They had changed to a demand led system providing a GP/ANP patient triage system, with no pre-bookable GP/ANP appointments which had enabled them to have more appointments available to meet the increasing demand.
- Facilities and premises were fit for purpose and met the needs of a range of patients. The practice
 building had been extended twice in order to meet the growing population of Bourne in Lincolnshire. We
 found an informative five-minute video on the practice website that gave people a virtual tour of the
 practice, where to enter, sign in for appointments and the different waiting areas. This meant patients
 were provided with a sense of comfort and were able to become familiar with their surroundings before
 stepping foot inside.
- The practice provided a purpose-built level 3 surgical theatre which offered community based surgical
 procedures through the Primary Care Community Surgical Scheme in Lincolnshire. All procedures were
 performed by suitably qualified General Practitioners and hospital consultants.

- Patients had a named GP who supported them in whatever setting they lived.
- The practice was responsive to the needs of older patients and offered home visits and urgent appointments for those with enhanced needs and complex medical issues.
- 70% of patients were signed up to use the NHS App to book appointments, those who did not have internet access or struggled with the technology could still ring the practice.
- The practice adjusted the delivery of its services to meet the needs of patients with a learning disability.
 They also provided a service for patients with Profound Intellectual and Multiple Disabilities (PIMD) in
 collaboration with residential care staff. The quality of health care for people with PIMD was important
 due to their limited ability to communicate their needs.
- Longer appointments or home visits took place and were dependent on the patient's needs.
- There was a medicines delivery service for housebound patients.
- Patients who experienced hearing loss were offered face to face appointments on the day of request. A hearing loop was in place and printed cards were available to direct patients to the correct waiting room.
- The practice had 7 care homes where patients who were registered with them lived.
- The practice had a dedicated emergency phone line which the emergency services, district nurses or care home staff could use if they wanted to speak to a clinician or get some advice on any patients who were registered at the practice.
- The practice liaised regularly with the community services to discuss and manage the needs of patients with complex medical issues.
- All children under the age of 6 years of age had direct access to the acute illness clinic as required.
 These clinics enabled children to access medical advice quickly and easily for a wide range of illnesses.

- These were delivered by highly trained nurses who were able to offer both advice and provide prescriptions if necessary.
- All parents or guardians calling with concerns about a child were offered a same day appointment when necessary.
- The practice was open until 8pm on a Tuesday and Thursday.
- Pre-bookable appointments were also available to all patients at additional locations within the area, as
 the practice was a member of a GP federation. Appointments were also available Saturday and
 Sunday.
- The practice held a register of patients living in vulnerable circumstances including homeless people, Travellers and those with a learning disability.
- People in vulnerable circumstances were easily able to register with the practice, including those with no fixed abode such as homeless people and Travellers.
- The practice was accredited as a Veteran Friendly Practice by the Royal College of General Practitioners.
- In June 2023 the practice introduced the Galletly Intergenerational Music to bring together children and elderly patients in care homes. The aim was that both groups, and their carers could integrate into their community and to improve the wellbeing of our elderly patients. Positive feedback had been received and requests for further sessions to be held going forward had been requested.
- The practice had a Health and Wellbeing Coach who had set up seated exercise classes for the elderly
 during the pandemic. The role was now well established, with a large focus being on health promotion
 in their elderly population. The practice also worked in partnership with the local leisure centre and
 OneYou (Lincolnshire Free Health and Wellbeing Programmes) who also offered free exercise so
 patients could access Aquafit, gym work outs and specialist classes for free for 12 weeks.
- The practice advertised and all staff and patients were aware of 'Treatment Room 15'. This room had been identified as a safe space for anyone needing immediate help. Patients can approach any member of staff, call or write to the practice and ask for an appointment in treatment room 15. It is designed to protect patients at risk of domestic abuse.
- The practice ran educational sessions with the help of LIVES volunteers on basic first aid and
 resuscitation before COVID19 and the PPG have asked them to set another morning up. They received
 positive feedback from families who joined this training session for emergency first aid.
- The practice social prescribing and health and wellbeing team worked to support parents who were struggling, liaising with various services including safeguarding agencies. They strongly promoted smoking cessation through groups and information leaflets. Their social prescribers also ran walking groups which created friendship groups for young adults. This was well received and had an average uptake of 10 people. They also had a Department of Work and Pensions advisor who regularly ran fortnightly clinics with the social prescriber to give advice on finances, applications for PIP and other benefits. This team had produced a 35-page local activities booklet that they maintained and shared with patients.
- The practice was introducing a new weight Management service with their Health and Wellbeing Coach.
 20 patients were contacted and offered a 12-week course based at the practice. Initial feedback was positive, but a survey would be carried out at the end of the first 12-week course for actions and learning.
- The practice worked closely with a local charity 'Don't Lose Hope'. The practice facilitated in house counsellors who were coming to the end of their training who needed case studies to qualify. Patients were aware of this, and suitable patients were referred to the team to get access to these talking therapies. It meant that the waiting time to be seen by a trained professional was 2-3 weeks for first appointment.
- The practice took part in the Rainbow Badge Scheme to support Lesbian, gay, bisexual, and transgender staff and patients (LGBTQ+). They were well represented and understood at the practice. Badge wearers were making it obvious that they wish to be available for anyone with questions or concerns about their sexuality or gender identity.

- The practice had been a 'safe surgery' since 2021 which meant they were committed to tackling the barriers faced by migrants in accessing healthcare. They ensured that lack of ID or proof of address, immigration status or inability to speak English was not a problem for patients who needed help and support.
- The practice had staff who were able to speak more than one language, for example, Polish, Spanish, Russian, Urdu, Portuguese but staff could also access Language Line if required.

- 1. Patients could access services and appointments in a way and at a time that suited them. Technology was used innovatively to ensure people had timely access to treatment, support and care. This could be through text messaging and video conferencing.
 - The practice offered a GP led triage system which aimed to ensure that all patients received care and treatment or were signposted to other healthcare providers. The practice provided flexibility in their offered appointments which included: online booking, electronic consultation, in-person booking at the reception desk, and telephone appointments at a time that best suited the patient, if needed.
 - Extended hours clinics were available Monday to Thursday 6.30pm to 8pm or telephone consultations with a GP or ANP for routine appointments on Saturday mornings from 9am to midday.
 - Longer appointments were available with the practice nurse. These helped patients who were on multiple disease registers to have a holistic review. Patients and carers found this convenient as it reduced the need to have multiple appointments.
- 2. The practice was in the process of making changes to the website in order to make it highly accessible and usable to ensure as many patients as possible could find what they need quickly and easily to improve digital accessibility. For example, writing content that's easy to understand, setting page titles, use of headings correctly, writing good link text, using alt-text for images and ensuring that videos were accessible.

- We observed proactive management and strong clinical leadership. GPs had defined lead managerial responsibilities to work alongside the management team.
- Leaders at all levels demonstrated high levels of experience. Most of the partners at the practice were longstanding and had a wealth of knowledge and experience in providing safe and effective patient care and treatment.
- There was a systematic and integrated approach to monitoring, reviewing and providing evidence of progress against the strategy and plans.
- We were told by staff who completed the CQC staff questionnaire that there was an open culture within the practice where any issues could be raised at team meetings. We saw evidence of this in meeting minutes. In addition, there was an open-door policy where staff could speak with senior management and /or team leaders.
- The practice continually looked forward and adjusted its plans and priorities. We looked at GP partner meetings where workforce planning and capacity were regularly discussed.
- The provider was aware of future challenges to quality and sustainability and actively sought to resolve these. For example, the provider had plans to employ more clinical staff and had been successful in securing two more GPs who would commence work at the practice over the coming months.
- We saw evidence of a strong culture of learning and development where all staff were encouraged to develop, thus enhancing services to patients. For example, upskilling of staff and then promotion, acute illness and prescribing courses.

We are a happy family of staff and value the contributions we all make towards keeping you and your family healthy'.
- The practice continually looked forward and adjusted its plans and priorities. The practice aimed to provide all their patients with the highest quality care by a well-trained and motivated team. They recognised the special expertise of their staff members and were committed to passing on expertise in respect of training and education of GP registrars and other staff.

Leaders had an inspiring shared purpose and strove to deliver and motivate staff to succeed.
There were high levels of satisfaction across all staff, including those with particular protected
characteristics under the Equality Act. We saw evidence there was a strong organisational
commitment and effective action towards ensuring that there was equality and inclusion across
the workforce.

We were told that during the COVID-19 pandemic the practice ensured that staff members were always informed. The partnership team met every day at 7am to discuss updates and provided their staff with updates and briefings immediately afterward advising them of the measures being taken to keep them safe. As the Pandemic continued with various forms of lock down, they prioritised staff who had birthdays and other significant events that would normally be celebrated in groups. They undertook to sending gifts to people on these occasions; for example, "dining kits" so people could celebrate a birthday at home. Throughout the pandemic they arranged for Easter gift vouchers and Christmas hampers for every member of the team. As measures eased, they provided a hairdresser and manicurist who attended the Practice to give haircuts to any member of the team. They subsequently also provided manicures and hand massages. We were told that this support was warmly welcomed and appreciated by the team with many positive comments.

More than 52 CQC staff questionnaires were completed and returned prior to the inspection. Staff spoke of a culture that supported their wellbeing and how proud they were to work at this practice. Staff well-being was promoted and key to maintaining a positive and motivated staff team.

Of those who completed the staff questionnaire:

100% of staff had good working relationships with their direct line manager.

100% of staff said they felt able to approach GP's and practice management.

100% said there was a strong sense of teamwork in the practice.

All staff we spoke with and those who completed the staff questionnaires expressed very positive views about and said that the management were visible, accessible, accountable and made time to listen. Staff told us that the management structure both administration and clinical promoted excellent care and treatment for their patients.

Explanation of any answers and additional evidence: -

1. The practice was proactive in response to patient concerns about access. In July 2023 they had changed to AccuRx to give patients online access. This had been advertised on the practice website, via social media and when patients attended the practice in person. At present only partners at the practice ran AccuRx and they were maintaining a spreadsheet of data and planned a review in September 2023 to assess how they can roll out this platform for wider use in the practice. Initial feedback from both staff and patients was positive. (Accurx is a software platform which enables the practice to contact patients easily and manage their care remotely).

The practice had introduced Patient Partner in response to complaints about call waiting times. Patient partner is an automated telephone appointment booking system which patients can use around the clock. It enables patients to book, cancel or amend appointments at any time without the need to speak to a receptionist. It had been designed to make it easier for patients to call at any time to manage their appointments, freeing up telephone lines for other queries and urgent problems.

A staff member commented that 5-minute telephone calls were too short with too much complexity since COVID-19. Appointments were redesigned and changed to 10-minute telephone calls. The practice also put out further adverts to increase the number of GPs and Advanced Nurse Practitioner's.

- 2. The practice had an active Patient Participation Group (PPG). We saw the recent August PPG newsletter, which was seeking further PPG members, advertising a wellbeing event in September along with the NHS awareness programmes for the coming months. PPG meeting minutes were also available
- 3. More than 52 CQC staff questionnaires were completed and returned prior to the inspection. Staff spoke of a culture that supported their wellbeing and how proud they were to work at this practice. All staff reported that they were encouraged to continue to develop and in turn improve outcomes for patients. They spoke of an open culture and how they felt valued and listened to. They were encouraged to provide feedback and suggestions for improvement.

Feedback

We were in contact with the chairperson on the PPG who told us that they met in the practice every two months. They currently had 7 members and a senior partner from the practice also attended to update them on practice issues. They felt the practice responded well to any issues raised and had recently increased the length of appointments to allow more time for discussion. The PPG also liaise with others in Lincolnshire with a firm interest in representing South Lincolnshire and sharing expertise.

Prior to COVID-19 and the evolution of social prescribing, the PPG were forward-thinking and created a booklet that they remain very proud of. The booklet included community help available and took them weeks to gather information and get published. It was a very well received and is an appreciated resource for patients and GP's alike.

Continuous improvement and innovation

There were evidence of systems and processes for learning, continuous improvement and innovation.

Examples of continuous learning and improvement

- Staff had dedicated learning and development time.
- The practice premises had many practice-led services to support the delivery of care and treatment for the practice. This included musculoskeletal services, health and wellbeing, counselling, phlebotomy and a baby clinic.
- There was a strong focus on education and training for practice staff and for GP registrars and medical students.
- The practice had future plans for further services which included:
 - o Development of long-term condition groups as part of a primary care hub.
 - Moving to 7 day a week extended access.
 - Extending the day surgery to provide more local services.
 - o Development of a respiratory infection hub (business case had already been submitted).
 - Increasing the clinical team to include a community psychiatric nurse and continued GP recruitment.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique, we can be 95% confident that the practices performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands. The percentage of practices which show variation depends on the distribution of the data for each indicator but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

The following language is used for showing variation:

Note: for the following indicators the variation bands are different:

- Child Immunisation indicators. These are scored against the World Health Organisation target of 95% rather than the England average. Note that practices that have "Met 90% minimum" have not met the WHO target of 95%.
- The percentage of respondents to the GP patient survey who responded positively to how easy it was to get through to someone at their GP practice on the phone uses a rules-based approach for scoring, due to the distribution of the data. This indicator does not have a CCG average.
- The percentage of women eligible for cervical cancer screening at a given point in time who were screened adequately within a specified period (within 3.5 years for women aged 25 to 49, and within 5.5 years for women aged 50 to 64). This indicator does not have a CCG average and is scored against the national target of 80%.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
