Overall rating: Good

At the last inspection on 3 December 2019 the practice was rated as requires improvement overall and requires improvement for providing safe and effective services. Caring, responsive and well-led were rated as Good.

We issued requirement notices in respect of breaches Regulation 12 (safe care and treatment), Regulation 15 (Premises and equipment), Regulation 17 (Good governance) and Regulation 18 (Staffing).

At this inspection we found improvements had been achieved and the regulatory breaches had now been met.

Please note: Any Quality Outcomes Framework (QOF) data relates to 2019/20.

Safe

Rating: Good

At the last inspection, December 2019, the practice was rated requires improvement for safe services. This was because the system for managing patient blood results in a timely manner was not comprehensive and the fire risk assessment had not been addressed in relation to fire detection and warning systems.

At this inspection 14 and 15 September 2021, we have rated the practice Good for providing safe services because:

- The fire risk assessment now covered all safety measures for fire detection and prevention.
- The system for managing blood results had been reviewed and identified areas for improvement which had been implemented.

Explanation of any answers and additional evidence: At our previous inspection December 2019 an electronic fire alert system was not in place. The fire risk assessment identified that no fire blankets were in place and that fire doors were also not in place. Smoke detectors were installed but there were no records of the checks undertaken kept. At this inspection September 2021 we found the portable appliance testing and equipment calibration were due during lockdown and the practice had arranged for testing to be completed October 2021. An electronic fire system was now in place and there were two outstanding actions from the fire risk assessment to be completed by November 2021.

<p>Explanation of any answers and additional evidence:</p> <p>At the last inspection December 2019 we found blank prescription pads were not kept securely. Uncollected prescriptions were checked every three months and the provider told us they would change the system to a monthly check.</p> <p>At this inspection September 2021 electronic prescription pads were locked away for emergency use. However, we found uncollected prescriptions had not been checked monthly.</p> <p>The practice had plans in place to review psychotropic medicines with secondary care teams prescribing the medicines.</p> <p>As part of the inspection a number of set clinical record searches were undertaken by a CQC GP specialist advisor without visiting the practice. These searches are visible to the practice. The results showed there was no significant backlog for medicine reviews.</p>

At the previous inspection 3 December 2019 we rated effective as requires improvement because the system for ensuring staff training was not comprehensive and the practice did not carry out effective quality improvement activity to review the effectiveness and appropriateness of the care provided.

- There was now a comprehensive training system in place.
- The practice carried out effective quality improvement activity to review the effectiveness and appropriateness of the care provided.

Explanation of any answers and additional evidence: At the last inspection, December 2019, the system in place to receive and disseminate the information to keep clinicians up to date with current evidence-based practice was under review. At this inspection, September 2021, we found structured meetings were now in place and meeting minutes recorded. The lead GP mentored clinical staff and completed clinical consultation audits for all clinicians. Audits had been undertaken to review outcomes. For example, minor surgery, diabetes with chronic kidney disease (CKD) and asthma. Second and third cycle audits had been completed which showed improvements were made.	

Older people

Population group rating: **Good**

Findings

- The practice used a clinical tool to identify older patients who were living with moderate or severe frailty. Those identified received a full assessment of their physical, mental and social needs.
- The practice followed up on older patients discharged from hospital. It ensured that their care plans and prescriptions were updated to reflect any extra or changed needs.
- The practice carried out structured annual medicines reviews for older patients.
- Staff had appropriate knowledge of treating older people including their psychological, mental and communication needs.
- Health checks, including frailty assessments, were offered to patients over 75 years of age.
- Flu, pneumonia and covid vaccinations were offered to relevant patients in this age group.

People with long-term conditions

Population group rating: **Good**

Findings

- Patients with long-term conditions were offered a structured annual review to check their health and medicines needs were being met. For patients with the most complex needs, the GP worked with other health and care professionals to deliver a coordinated package of care.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- The practice shared clear and accurate information with relevant professionals when deciding care delivery for patients with long-term conditions.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins.
- Patients with suspected hypertension were offered ambulatory blood pressure monitoring.
- Patients with atrial fibrillation were assessed for stroke risk and treated appropriately.
- Patients with COPD were offered rescue packs.
- Patients with asthma were offered an asthma management plan.
- The practice took part in the Healthy Lung project which led to earlier lung cancer diagnosis for patients.

Any additional evidence or comments

Our clinical searches and record reviews did not identify any significant concerns. The areas of improvement identified were supporting the advanced nurse practitioners with reviews.

Families, children and young people

Population group rating: Good

Findings

- The practice had not met the minimum 90% for five of five childhood immunisation uptake indicators. The small number of patients in this population group affected the overall percentages.
- The practice contacted the parents or guardians of children due to have childhood immunisations.
- The practice had arrangements for following up failed attendance of children's appointments following an appointment in secondary care or for immunisation and would liaise with health visitors when necessary.
- The practice had arrangements to identify and review the treatment of newly pregnant women on long-term medicines. These patients were provided with advice and post-natal support in accordance with best practice guidance.
- Young people could access services for sexual health and contraception.
- Staff had the appropriate skills and training to carry out reviews for this population group.

- Patients could book or cancel appointments online and order repeat medicines without the need to attend the surgery.
- Telephone consultations and eConsult were offered.
- Extended hours services were also in place to meet the needs of the working population.

- Cervical cancer screening was below the 80% coverage target and the provider had continued to offer flexible appointments, opportunistic screening, monitoring of non-attendance and putting flags on the records of patients who had not attended so they could be reminded.
- The cancer screening rates for breast and bowel had improved from our last inspection.

- All patients with a learning disability were offered an annual health check.
- End of life care was delivered in a coordinated way which took into account the needs of those whose circumstances may make them vulnerable.
- The practice had a system for vaccinating patients with an underlying medical condition according to the recommended schedule.

People experiencing poor mental health (including people with dementia)

Findings

- The practice assessed and monitored the physical health of people with mental illness, severe mental illness, and personality disorder by providing access to health checks, interventions for physical activity, obesity, diabetes, heart disease, cancer and access to 'stop smoking' services.
- Same day and longer appointments were offered when required.
- There was a system for following up patients who failed to attend for administration of long-term medicines.
- When patients were assessed to be at risk of suicide or self-harm the practice had arrangements in place to help them to remain safe.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique we can be 95% confident that the practice's performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

- Child Immunisation indicators. These are scored against the World Health Organisation target of 95% rather than the England average. Note that practices that have "Met 90% minimum" have not met the WHO target of 95%.
- The percentage of respondents to the GP patient survey who responded positively to how easy it was to get through to someone at their GP practice on the phone uses a rules based approach for scoring, due to the distribution of the data. This indicator does not have a CCG average.
- The percentage of women eligible for cervical cancer screening at a given point in time who were screened adequately within a specified period (within 3.5 years for women aged 25 to 49, and within 5.5 years for women aged 50 to 64). This indicator does not have a CCG average and is scored against the national target of 80%.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
