The last inspection on 9 May 2017 was rated as good in the key question safe. This inspection is rated requires improvement in safe although we found no breaches of regulations. Review of patient records in relation to the clinical searches identified that care records were not always managed in line with current guidance. Immediately after the inspection the practice had a plan in place to rectify this.

- We saw examples of actions taken on recent alerts regarding sodium valproate. However another alert showed 10 patients prescribed both Clopidogrel and omeprazole/esomeprazole. Of the five records reviewed there was no evidence that any of the patients had been informed of the risks associated with this drug combination.
- Following the inspection the practice told us that the clinicians had made this a priority and had started to contact patients with the relevant information.

Effective

Effective care for the practice population

Findings

- The practice used a clinical tool to identify older patients who were living with moderate or severe frailty. Those identified received a full assessment of their physical, mental and social needs.
- Health checks, including frailty assessments, were offered to patients over 75 years of age.
- Flu, shingles and pneumonia vaccinations were offered to relevant patients in this age group.
- The practice had systems to inform eligible patients to have the meningitis vaccine, for example before attending university for the first time.
- Patients had access to appropriate health assessments and checks including NHS checks for patients aged 40 to 74. There was appropriate and timely follow-up on the outcome of health assessments and checks where abnormalities or risk factors were identified.

- All patients with a learning disability were offered an annual health check.
- End of life care was delivered in a coordinated way which took into account the needs of those whose circumstances may make them vulnerable.
- The practice had a system for vaccinating patients with an underlying medical condition according to the recommended schedule.
- The practice demonstrated that they had a system to identify people who misused substances.
- The practice assessed and monitored the physical health of people with mental illness, severe mental illness, and personality disorder
- Patients with poor mental health, including dementia, were referred to appropriate services.

Management of people with long term conditions

Findings

- Three out of five patients reviewed potentially had a missed diagnosis of diabetes but had not been coded or discussed with the patient. Two patients had abnormal HbA1C but had been filed with no action.
- In the last three months only 31 medication reviews had been carried out. None of these were of patients over the age of 75 years. The medication reviews that were done were not of good quality, for example drug monitoring was not checked. Immediately after the inspection the practice told us that they had increased clinical sessions and they had started to carry out missed medication reviews and monitoring of patients. A PCN pharmacist was due to start at the practice and would be part of this review and monitoring process.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma.
- The practice shared clear and accurate information with relevant professionals when deciding care delivery for patients with long-term conditions.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins.
- Patients with suspected hypertension were offered ambulatory blood pressure monitoring.
- Patients with COPD were offered rescue packs.
- Patients with asthma were offered an asthma management plan.

- We saw evidence that the practice consistently worked to improve the uptake of cervical cancer screening. One of the members of the patient group has their own radio show and runs a womens group and at every opportunity attempts to educate and encourage women to attend for screening.
- Dedicated clinics were held to encourage women to attend for cervical screening
- The practice sent texts and telephoned patients who did not attend their appointments.

- The practice carried out an audit on patients with an HBA1C 42-47 in the previous 12 months. This was to identify pre-diabetic patients and to ensure that they had blood monitoring and had been offered and referred to a diabetes education programme.

This allowed the provider to review the needs of the team and training requirements and ensure that resources were allocated to enable training and development to take place. Staff were supported in further training such as some receptionists had trained in phlebotomy. Staff told us they were given protected time to attend training courses.

The practice told us that they would look into why this had happened. 	

Responsive

Rating: Good

The above rating was awarded to the practice at the inspection undertaken 9 May 2017. However as part of this inspection we looked at the systems in place to enable patients' timely access to care and treatment. This is a national initiative.

Access to the service

People were able to access care and treatment in a timely way.

The COVID-19 pandemic has affected access to GP practices and presented many challenges. In order to keep both patients and staff safe early in the pandemic practices were asked by NHS England and Improvement to assess patients remotely (for example by telephone or video consultation) when contacting the practice and to only see patients in the practice when deemed to be clinically appropriate to do so. Following the changes in national guidance during the summer of 2021 there has been a more flexible approach to patients interacting with their practice. During the pandemic there was a significant increase in telephone and online consultations compared to patients being predominantly seen in a face to face setting.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique, we can be 95% confident that the practice's performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

The following language is used for showing variation:

Note: for the following indicators the variation bands are different:

- Child Immunisation indicators. These are scored against the World Health Organisation target of 95% rather than the England average. Note that practices that have "Met 90% minimum" have not met the WHO target of 95%.
- The percentage of respondents to the GP patient survey who responded positively to how easy it was to get through to someone at their GP practice on the phone uses a rules-based approach for scoring, due to the distribution of the data. This indicator does not have a CCG average.
- The percentage of women eligible for cervical cancer screening at a given point in time who were screened adequately within a specified period (within 3.5 years for women aged 25 to 49, and within 5.5 years for women aged 50 to 64). This indicator does not have a CCG average and is scored against the national target of 80%.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
