

## Edinburgh Rugby x Glen Moray Father's Day Competition Terms and Conditions

3. To enter the competition supporters are required to answer the relevant competition question set by Edinburgh Rugby before **10am on Wednesday 24 June 2020**.
4. By entering this competition, an entrant is indicating his/her agreement to be bound by these terms and conditions.
5. Closing date for entry will be **10am on Wednesday 24 June 2020**. After this date the no further entries to the competition will be permitted.
6. No responsibility can be accepted for entries not received for whatever reason.
7. The promoter reserves the right to cancel or amend the competition and these terms and conditions without notice. Any changes to the competition will be notified to entrants as soon as possible by the promoter.
