## **1. VALUATION INSTRUCTION:**

I was instructed by **Section** to determine the probable market value of **Section No. E5 on Erf 255 Osona Village.** 

## 2. DEFINITION OF MARKET VALUE:

The definition of Market Value as laid down by the International Valuation Standards are as follows:

"The estimated amount for which a property should exchange on the date of valuation between a willing buyer and a willing seller in an arms-length transaction after proper marketing where-in the parties has each acted knowledgeably, prudently and without compulsion".

#### 3. DATE OF INSPECTION:

I have inspected the subject property on Monday the 29th January, 2024.

#### 4. DATE OF VALUATION:

I have completed the valuation report on Tuesday the 30<sup>th</sup> of January, 2024.

## 5. PURPOSE OF VALUATION:

The purpose of this valuation is to determine the probable market value of the subject property.

## 6. DESCRIPTION OF PROPERTY:

Erf 255 Osona Village is situated in the municipal area of the Municipality of Okahandja and is 2 942 m<sup>2</sup> in extent.

The subject property is also situated in "Osona Extension 1" in the Osona Village Development and has a zoning of " General Residential" with a density of 1: 150.

The subject property is also situated in the housing complex currently known as **"Eden Garden Court".**

## 7. DESCRIPTION OF IMPROVEMENTS:

The Complex consist of ± 16 section title dwelling units, each with its own "Erf".

<u>Section No. E5</u> consists of a dwelling with a lounge/ kitchen with BIC & BIS, 3 bedrooms with BIC and 2 bathrooms.

Other improvements consist of a steel carport, paving and boundary walls.

#### 8. CONSTRUCTION OF IMPROVEMENTS:

<u>The improvements</u> are built with cement brick walls, corrugated iron roof sheeting, rhino board ceilings, aluminium frame windows with ceramic tiles on the floors.

<u>All the improvements</u> are in an average condition and need some minor renovations on the inside and outside.

## 9. VALUATION OF PROPERTY:

When valuing real estate, the Valuer must concern himself with placing a value on the rights attached to the property and the benefits of occupation and/ or ownership thereof.

In the valuation process, cognisance must be taken for the purpose, use and future income, which the property is most likely to produce. At the same time the property must be compared with available substitutes and/ or alternative investment opportunities.

<u>The object of the valuation process</u> is to arrive at a figure, which will reflect the point of equilibrium between supply and effective demand at the time of valuation.

Property's utility value or capacity to satisfy the needs and wants of humans creates value. Contributing to the value of a particular property is general uniqueness, durability, price, fixity of location, relatively limited supply and the specific utility of a given site.



I will make use of the **<u>Comparable Sales Method</u>** to determine the probable market value of the subject property.

<u>The Comparable Sales Method</u> is used where there is evidence of actual recent sales where the sales are analysed to produce rates which are then applied to value the subject property.

The following comparable properties were sold recently in the vicinity of the subject property:
