Terms and Conditions

1. Introduction

- 1.1. These Terms apply to the Membership Card provided to you by Fullerians RFC and govern the relationship between Fullerians RFC ("we", "us" or "the club") and members of the club ("you" or "your") run by Fullerians RFC in respect of the Membership Card scheme ("the scheme").
- 1.2. It is within the discretion of the club that certain products may be excluded from the Membership Card scheme. In such circumstances, details of such excluded products will be available on our website fullerians.co.uk ("the Website").
- 1.3. By using the Membership Card you indicate that you accept these Terms and that you agree to be bound by them. If you do not agree to be bound by these Terms, you may not use your Membership Card. If there is anything you do not understand, please contact our club treasurer by email at treasurer@fullerians.co.uk
- 1.4. Fullerians RFC reserve the right to change these Terms from time to time. Any such changes will take effect when posted on fullerians.co.uk and your continued use of the Discount Card shall constitute your acceptance to be bound by the latest Terms.

2. General

- 2.1. To be eligible for a Fullerians Membership card you must be a current member of Fullerians RFC. See the website for details on becoming a member of the club.
- 2.2. At the club's discretion membership cards may also be offered to certain non-members, such as some employees or sponsors
- 2.3. Membership cards will be provided to every individual or family group that purchases a membership for any given 12-month period from 01 September to 31 August.
- 2.4. When you receive your Membership Card, you will get access to the Members prices at the club as well as exclusive offers and special promotions.
- 2.5. A Membership Card can only be registered in the name of a member who is aged 17 or over.
- 2.6. Only one Membership Card can be registered per member. Individuals residing in the same address can use the same Membership Card with the card holders' authorisation. For example, a member under the age of 17 who is living with an adult member may use the adult member's card, if they have their permission to do so.
- 2.7. You can use your card under the scheme to receive discounts against purchases made at the club and discounts and/or offers at local businesses who support the scheme.
- 2.8. Any purchases made at the club must be only for the use and/or consumption of the membership card holder(s) and their guests.
- 2.9. The club reserves the right to limit the number of items included in any single transaction under this scheme.

3. Loss, Theft or Damage



- 3.1. You should immediately report any loss, theft, fraudulent or unauthorised use of your membership Card by emailing treasurer@fullerians.co.uk
- 3.2. In the event of loss, theft, fraud or other unauthorised use of your Discount Card, or if your Membership Card is damaged or malfunctions, we may, at our sole discretion, replace your Membership Card. We cannot be liable for the misuse, loss or damage of your Discount Card.
- 3.3. We reserve the right to charge a fee of 5GBP for each replacement Discount Card.
- 3.4. If you subsequently find or retrieve a Discount Card which you had previously reported lost or stolen, you must notify treasurer@fullerians.co.uk immediately in accordance with clause 3.1 above.

4. Variation and Cancellation

- 4.1. Membership Cards shall always remain our property, and may be renewed, cancelled or annulled as per Clause 4.3.
- 4.2. If at any time you wish to cancel your membership you must return your Membership Card to the club treasurer.
- 4.3. We reserve the right, at any time and without notice, to:
 - 4.3.1. amend or waive any provision of these Terms from time to time; and/or
 - 4.3.2. terminate the Membership Card Scheme; and/or
 - 4.3.3. decline to issue Membership Cards; and/or
 - 4.3.4. on reasonable grounds, withdraw or cancel Membership Cards, where reasonable grounds shall include (but not be limited to):
 - 4.3.4.1. any abuse or attempted abuse of the scheme; and/or
 - 4.3.4.2. any use or attempted use of a Membership Card in a manner which is contrary to these Terms; and/or
 - 4.3.4.3. any reasonable suspicion of dishonesty we may have on your part in connection with the Membership Card Scheme.
