## PART 1 <br> DETAILS, INTERPRETATION AND LIMITATION OF LIABILITY

## 1

## Defined Terms

1.1 In these Articles, unless the context requires otherwise:

2006 Act means the Companies Act 2006 as modified by statute or re-enacted from time to time.

Articles means these articles of association, as may be amended from time to time.
bankruptcy includes individual insolvency proceedings in a jurisdiction other than England and Wales or Northern Ireland which have an effect similar to that of bankruptcy.

Board means the board of directors of the Club established from time to time in accordance with Article 19, the members of which are the directors of the Club for the purposes of the 2006 Act.

CASC means a Community Amateur Sports Club registered with HMRC under the CASC Regulations.

CASC Regulations means Part 13 Chapter 9 of the Corporation Tax Act 2010 and the Community Amateur Sports Clubs Regulations 2015 (as modified by statute or reenacted from time to time).

Chair means the person appointed from time to time in accordance with these Articles as the chair of the Club.
chair of the meeting has the meaning given to it in Article 34.3.
clear days means a period of days exclusive of the day on which the notice is served and of the day for which it is given.

Club means the above-named company.

Constituent Body means the Constituent Body of the RFU to which the Club is from time to time affiliated and which at the date of incorporation is Essex County Rugby Football Union Ltd (a society registered under the Co-Operative and Community Benefit Societies Act 2014 with registered number 2959R).

Discipline Committee means the committee appointed in accordance with Article 8.
Disciplinary Policy means the Club's policy relating to disciplinary procedures and matters as determined from time to time by the Board and in accordance with the Rules.
director means a director of the Club, and includes any person occupying the position of director, by whatever name called.
document includes, unless otherwise specified, any document sent or supplied in electronic form.
electronic form has the meaning given to it in Section 1168 of the 2006 Act.
Game means the game of rugby.
general meeting means an annual general meeting or a general meeting of the Club.
hard copy form has the meaning given to it in Section 1168 of the 2006 Act.
Honorary Life Member means a person elected in accordance with Article 28.1.
Member means the persons admitted to the membership of the Club in accordance with Article 27 and any Rules from time to time in force.

Membership Fee means the fees charged for an annual membership or such fees as determined by the Board in accordance with Article 27.8, including any reduced or waived fees under Article 27.3

Non-Voting Members means all members of the Club other than the Voting Members and who shall not be members for the purposes of the 2006 Act.
ordinary resolution has the meaning given to it in Section 282 of the 2006 Act.
Other Principal Officers means the persons appointed from time to time in accordance with Article 22.
participate has, in relation to a directors' meeting, the meaning given to it in Article 12.

President means the person appointed from time to time in accordance with these Articles as the president of the Club.

Principal Officers means the President, the Chair, the Secretary, the Treasurer and the Other Principal Officers.
proxy notice has the meaning given to it in Article 40.1.
the RFU means the Rugby Football Union (a society registered under the Co-operative and Community Benefit Societies Act 2014 with registered number 27981R which is the governing body of rugby union within England) of Rugby House, Twickenham Stadium, 200 Whitton Road, Twickenham, Middlesex TW2 7BA.

Rules means the rules and regulations of the Club made by the Board or by the Club in general meeting, as amended from time to time.

Secretary means the person appointed from time to time in accordance with these Articles as honorary secretary of the Club and who shall also be the company secretary for the purposes of the 2006 Act.
special resolution has the meaning given in Section 283 of the 2006 Act.
subsidiary has the meaning given in Section 1159 of the 2006 Act.
Treasurer means the person appointed from time to time in accordance with these Articles as honorary treasurer of the Club.

Vice-Chair means such person appointed from time to time in accordance with the Rules as the vice-chair of the Club.

Voting Members means the members of the Club who, under these Articles, are entitled to receive notice of, attend and vote at general meetings and who are members of the Club for the purposes of the 2006 Act, save that any Members who have failed to pay their Membership Fee on the day before the notice for a general meeting shall not be entitled to vote at that general meeting.

World Rugby means the world Governing Body of the Game which at the date of incorporation is World Rugby (formerly known as the International Rugby Board) of which the RFU is a member.
working day has the meaning given to it in Section 1173(1) of the 2006 Act.
writing means the representation or reproduction of words, symbols or other information in a visible form by any method or combination of methods, whether sent or supplied in electronic form or otherwise.
1.2 Unless the context otherwise requires, other words or expressions contained in these Articles bear the same meaning as in the 2006 Act.
1.3 Words importing the singular number shall include the plural number and vice versa. Words importing the masculine gender only shall include the feminine gender. Words importing persons shall include corporations.
1.4 For the purposes of Section 20 of the 2006 Act, the relevant model articles shall be deemed to have been excluded fully and replaced with the provisions of these Articles.

## 2 Objects

The main purposes of the Club are to provide facilities for and to promote participation in the amateur sport of rugby union for, in particular, gay and bisexual men in the

London area. (Objects). In furtherance of these primary Objects, the Club also has the following supplementary objects:
2.1 to acquire and undertake all properties and liabilities and to carry out the powers, obligations, duties and general objects of the present unincorporated association known as Kings Cross Steelers Rugby Football Club and to indemnify Kings Cross Steelers Rugby Football Club, its officers, members, and members of any of its sub-committees against all costs, claims, demands, actions and proceedings relating to the assets and undertaking of Kings Cross Steelers Rugby Football Club and in respect of all liabilities, obligations and commitments (whether legally binding or not) of Kings Cross Steelers Rugby Football Club and also in respect of the costs and expenses and outgoings from or attributable to the transfer of assets and undertaking;
2.2 to provide other ordinary benefits of an amateur sports club as set out in CASC Regulations including without limitation provision of: suitably qualified coaches; coaching courses; insurance; medical treatment and post-match refreshments;
2.3 to obtain funding for the activities of the Club by collecting entrance fees, membership subscriptions, and match fees, by obtaining sponsorship and other available funding;
2.4 to promote the Game within the Club;
2.5 to affiliate to the RFU (through the membership of the Club's nominee to the RFU, such nominee to be the Secretary or another officer of the Club approved by the RFU) and to affiliate to the Constituent Body designated to it by the RFU;
2.6 to sell or supply food and/or drink and provide other activities as an incidental social adjunct to the sporting purposes of the Club;
2.7 to comply with and uphold the rules and regulations of the Constituent Body, the RFU and World Rugby as amended from time to time and the rules and regulations of anybody to which the RFU is registered or affiliated;
2.8 to acquire, establish, own, operate and turn to account in any way for the Members' benefit the rugby union facilities of the Club together with buildings and easements, fixtures and fittings and accessories as shall be thought advisable;
2.9 to make rules, regulations, bye-laws and standing orders concerning the operation of the Club including without limitation regulations concerning disciplinary procedures that may be taken against the Members;
2.10 to discipline the Members where permitted by these Articles and the Rules and to refer its Members to be disciplined by the RFU or the Constituent Body (as appropriate) where so required by the rules and regulations of the RFU or the Constituent Body (as the case may be);
2.11 to make donations or offer support to rugby union clubs which are charities or CASCs;
2.12 to make donations or offer support to such charitable initiatives as the Board sees fit; and
2.13 to do all such other things as the Board thinks fit to further the interests of the Club or to be incidental or conducive to the attainment of all or any of the objects stated above.
2.14 In pursuance of the objects set out in this Article 2, the club may associate or affiliate with:
(a) such sporting organisations as may appear to be necessary or desirable by the Board; or
(b) non-sporting organisations,
provided that such association or affiliation shall be subject to the approval of the Members at a general meeting. Members shall be informed in writing of any association or affiliation to external organisations.

## 3 Powers

3.1 The Club shall have the powers to do all such lawful things as are consistent with the furtherance of its Objects (Powers).
3.2 The income and property of the Club shall be applied solely towards the promotion of the Objects and no portion thereof shall be paid or transferred directly or indirectly, overtly or covertly by way of distribution, bonus or otherwise by way of profit to the members of the Club or third parties other than other CASCs or registered charities. No Member shall be paid a salary, bonus fee or other remuneration for playing for the Club.
3.3 Nothing in Article 3.2 shall prevent the payment in good faith by the Club:
(a) to any director, committee or sub-committee member of reasonable and proper out-of-pocket expenses incurred in the exercise of their powers and the discharge of their responsibilities in relation to the Club;
(b) of reasonable remuneration to a member of the Club (not being a director) for the supply of goods or services (excluding remuneration for playing for the Club);
(c) of interest on money lent by a member of the Club or its directors at a commercial rate of interest;
(d) of reasonable and proper rent for premises demised or let by any member of the Club or by any director;
(e) of any premium in respect of the purchase and maintenance of indemnity insurance in respect of liability for any act or default of the directors (or any of them) in relation to the Club; and/or
(f) any other payments as are permitted by these Articles or as authorised by the Voting Members at a general meeting.

## 4 Liability of Members

4.1 The liability of each Member is limited to $£ 1$, being the amount that each Member undertakes to contribute to the assets of the Club in the event of its being wound up while he is a Member or within one year after he ceases to be a Member, for any of the items set out in Article 4.2.
4.2 The items for which the Members undertake to contribute are:
(a) payment of the Club's debts and liabilities contracted before he ceases to be a Member;
(b) payment of the costs, charges and expenses of winding up; and
(c) adjustment of the rights of the contributories among themselves.

## PART 2

## DIRECTORS

## DIRECTORS' POWERS AND RESPONSIBILITIES

## 5 Directors' General Authority

5.1 Subject to these Articles, any Rules made pursuant to them and the 2006 Act, the Board is responsible for the management of the Club's business, for which purpose it may exercise all the Powers of the Club.
5.2 No Rule made by the Club in general meeting pursuant to Article 18.3 shall invalidate any prior act of the Board which would have been valid if such Rule had not been made.

## 6 Directors May Delegate

6.1 Subject to these Articles, the Board may delegate any of the powers which are conferred on it under these Articles:
(a) to such person or committee;
(b) by such means (including by power of attorney);
(c) to such an extent;
(d) in relation to such matters or territories; and
(e) on such terms and conditions,
as it thinks fit.
6.2 All acts and proceedings delegated under Article 6.1 shall be reported to the Board in due course.
6.3 If the Board so specifies, any such delegation may authorise further delegation of the Board's powers by any person to whom they are delegated.
6.4 The Board may revoke any delegation in whole or part, or alter its terms.

## 7 Committees

7.1 Committees to which the Board delegates any of its powers must follow procedures which are based as far as they are applicable on those provisions of these Articles which govern the taking of decisions by the Board.
7.2 The Board may make rules of procedure for all or any committees, which prevail over rules derived from these Articles if they are not consistent with them.
7.3 The quorum for meetings of any committee formed pursuant to the provisions of the Articles shall be two.
7.4 At each annual general meeting any committee to which the Board has delegated any of its powers shall be dissolved. Notwithstanding this Article 7.4, the Board may reselect any committee thereafter.

## 8 Discipline Committee

8.1 The Rules shall provide for the appointment of a Discipline Committee.
8.2 The Discipline Committee shall be primarily responsible for investigating complaints against any club member's behaviour.

## DECISION-MAKING BY DIRECTORS

## 9 Directors to Take Decisions Collectively

Any decision of the Board must be either a majority decision or a decision taken in accordance with Article 10.

## 10 Unanimous Decisions

10.1 A decision of the Board is taken in accordance with this Article when all eligible directors indicate to each other by any means that they share a common view on a matter.
10.2 Such a decision may take the form of a resolution in writing, copies of which have been signed by each eligible director or to which each eligible director has otherwise indicated agreement in writing.
10.3 References in this Article to eligible directors are to directors who would have been entitled to vote on the matter had it been proposed as a resolution at a meeting of the Board.
10.4 A decision may not be taken in accordance with this Article if the eligible directors would not have formed a quorum at such a meeting.

## 11 Calling a Meeting of the Board

11.1 The Board may meet together for the dispatch of business, adjourn and otherwise regulate their meetings as they think fit, provided that at least four (4) such meetings shall be held in each year.
11.2 The Board shall report on their activities to the Members at the annual general meeting.
11.3 Any director may call a meeting of the Board by giving notice of the meeting to the directors or by directing the Secretary to give such notice.
11.4 Notice of any meeting of the Board must indicate:
(a) its proposed date and time;
(b) where it is to take place; and
(c) if it is anticipated that directors participating in the meeting will not be in the same place, how it is proposed that they should communicate with each other during the meeting.
11.5 Notice of a meeting of the Board must be given to each director, but need not be in writing. A director who is absent from Great Britain shall be entitled to notice of a meeting if he has provided a valid email address.

12 Participation in Meetings of the Board
12.1 Subject to these Articles, directors participate in a meeting of the Board, or part of a meeting of the Board, when:
(a) the meeting has been called and takes place in accordance with these Articles, and
(b) they can each communicate to the others any information or opinions they have on any particular item of the business of the meeting.
12.2 In determining whether directors are participating in a meeting of the Board, it is irrelevant where any director is or how they communicate with each other.
12.3 If all the directors participating in a meeting of the Board are not in the same place, they may decide that the meeting is to be treated as taking place wherever any of them is located.

## 13 Composition of the Board and Quorum

13.1 The quorum for meetings of the Board may be fixed from time to time by a decision of the directors, but it must never, subject to Article 13.3, be less than three (3), and unless otherwise fixed it is set at three (3).
13.2 Subject to Article 13.3, the Board may act notwithstanding any vacancy in their body.
13.3 If the total number of directors for the time being is less than the quorum required, the directors must not take any decision other than a decision:
(a) to call a general meeting so as to enable the Members to fill a casual vacancy arising among the directors; or
(b) to admit members to the Club.

## 14 Chairing of Meetings of the Board

14.1 The Chair shall be chair of the Board. The Chair shall preside as chair at all meetings of the Board at which he shall be present.
14.2 If at any meeting the Chair is not present within thirty (30) minutes after the time appointed for holding the meeting or he is not willing to preside, the Vice-Chair shall preside if a vice-chair has been appointed under the Rules.
14.3 If the Vice-Chair is not present within thirty (30) minutes after the time appointed for holding the meeting or is not willing to preside, or if no vice-chair has been appointed, the members of the Board present shall choose one of their number to be chair of the meeting.
14.4 The person so appointed to preside over the meeting for the time being is to be treated as the chair for the purposes of these Articles.

## 15 Casting Vote

15.1 If the numbers of votes for and against a proposal are equal, the Chair or other director chairing the meeting of the Board has a casting vote.
15.2 Article 15.1 shall not apply to give a casting vote to the Chair or other director chairing the meeting (as appropriate) if, in accordance with these Articles, the Chair or other director is not to be counted as participating in the decision-making process for quorum or voting purposes.

## 16 Conflicts of Interest

16.1 Subject to Article 16.2, if a proposed decision of the Board is concerned with an actual or proposed transaction or arrangement with the Club in which a director is interested, that director is not to be counted as participating in the decision-making process for quorum or voting purposes.
16.2 The prohibition under Article 16.1 shall not apply when:
(a) the Board approves the director counting towards the quorum and voting on the transaction or arrangement notwithstanding such interest in accordance with Section 175 of the 2006 Act;
(b) the director need not declare an interest pursuant to Section 177 or 182 of the 2006 Act; or
(c) the director's conflict of interest arises from a permitted cause.
16.3 For the purposes of Article 16.2, the following are permitted causes:
(a) a guarantee, security or indemnity given, or to be given, by or to a director in respect of an obligation incurred by or on behalf of the Club or any of its subsidiaries (if any);
(b) subscription, or an agreement to subscribe, for securities of the Club or any of its subsidiaries (if any), or to underwrite, sub-underwrite, or guarantee subscription for any such securities; and
(c) arrangements pursuant to which benefits are made available to employees and directors or former employees and directors of the Club or any of its subsidiaries (if any) which do not provide special benefits for directors or former directors.
16.4 For the purposes of this Article 16, references to proposed decisions and decisionmaking processes include any meeting of the Board or part of a meeting of the Board.
16.5 Subject to Article 16.6, if a question arises at a meeting of the Board or of a committee of the Board as to the right of a director to participate in the meeting (or part of the meeting) for voting or quorum purposes, the question may, before the conclusion of the meeting, be referred to the chair of the meeting whose ruling in relation to any director other than himself is to be final and conclusive.
16.6 If any question as to the right to participate in the meeting (or part of the meeting) should arise in respect of the Chair, the question is to be decided by a decision of the directors at that meeting, for which purpose the Chair is not to be counted as participating in the meeting (or that part of the meeting) for voting or quorum purposes.

## 17 Records of Decisions to be Kept

17.1 The Board must ensure that the Club keeps a record, in writing, for at least ten years from the date of the decision recorded, of every unanimous or majority decision taken by the Board and by the Club at general meeting.
17.2 Any such records, if purporting to be signed by the chair of such meeting, or by the chair of the next succeeding meeting, shall be sufficient evidence without any further proof of the facts therein stated.
17.3 Any such records shall be circulated to all members of the Board.

## 18 Directors' Discretion to Make Further Rules

18.1 Subject to Articles 18.6, the Board shall have the power to make, vary and revoke Rules, including but not limited to those:
(a) relating to the implementation of the Disciplinary Policy;
(b) creating regulations, standing orders and/or bye-laws for the better administration of the Club and to regulate the function, role and operation of committees to assist the Board in the better administration of the Club; and
(c) setting or adopting such other regulations or policies, including for example child protection and equity policies, as the Board thinks fit.
18.2 Subject to Article 18.5, where the Board considers it to be in the best interests of the Club, the Board shall have power to make or vary (but not revoke) any Rule that would be subject to Article 18.3.
18.3 Only the Voting Members in general meeting may from time to time make, vary and revoke Rules:
(a) setting out different categories of membership or affiliates of the Club;
(b) setting the criteria for admission to membership of the Club for the different categories of Members;
(c) relating to the appointment of the Other Principal Officers;
(d) relating to the composition of the Discipline Committee;
(e) setting out the code of conduct and standards of behaviour for the Members; and concerning charitable donations made by the Club.
18.4 The Board must not act contrary to any such decision of the Voting Members.
18.5 Any Rule made or any variation of a Rule (as the case may be) in accordance with Article 18.2 must be laid before Voting Members in general meeting for ratification within six months, and any Rule made or variation of a Rule (as the case may be) in accordance with Article 18.2 shall cease immediately to have effect should the making or varying of the Rule not be ratified in accordance with this Article 18.5; but no prior act done under the Rule as made or varied in accordance with Article 18.2 shall be invalidated by the failure of the making or varying of the Rule to be ratified in accordance with this Article 18.5.
18.6 Such Rules and policies put in place pursuant to Article 18.1, shall only be valid provided that:
(a) nothing in those Rules or policies shall prejudice the Club's status as a CASC; and
(b) such Rules and policies are compliant with these Articles and the 2006 Act.

## APPOINTMENT OF DIRECTORS AND ELECTED POSITIONS

## 19 Methods of Appointing Directors

19.1 The number of directors shall be not less than two (2) and shall be subject to a maximum of twelve (12).
19.2 The members of the Board shall be:
(a) the Chair;
(b) the Secretary;
(c) the Treasurer; and
(d) the Other Principal Officers.
19.3 The directors appointed at the Club's incorporation shall retire at the first annual general meeting but may be re-appointed in accordance with these Articles.
19.4 Each member of the Board must satisfy HMRC's fit and proper person test to be involved in the general control, management and administration of the Club and must declare (in the required form) that he is a fit and proper person prior to being elected.
19.5 Any person accepting nomination to the Board who has any financial interest or other conflict of interest in such appointment must, before accepting the nomination, state in writing to the Club all such interests. Failure to do so will lead to automatic
disqualification from Board membership. The Board has the right to veto such an election if, in its opinion, it is not in the best interests of the Club.
19.6 All acts carried out in good faith at any meeting of the Board or of any sub-committee, or by any person acting as a director, shall, notwithstanding it be afterwards discovered that there was some defect in the appointment or continuance in office of any such person be as valid as if every such person had been duly appointed or had duly continued in office.

## 20 Appointment of the President

20.1 At the annual general meeting each year, the President shall retire but shall be eligible for re-appointment in accordance with these Articles. The election for the office of President shall be conducted in accordance with Article 23. A person so appointed shall hold office from the date upon which he is elected, until the annual general meeting in the year following his election. The President shall have no power to vote at Board meetings but shall have such rights and privileges as may be set out in the Rules and as the Board or the Voting Members in general meeting shall from time to time prescribe.

## 21 Appointment of the Chair, Secretary and Treasurer

21.1 At the annual general meeting each year, the Chair shall retire but shall be eligible for re-appointment in accordance with these Articles except if he is a person to whom Article 21.5 applies in relation to the office of Chair. The election for the office of Chair shall be conducted in accordance with Article 23. A person so appointed shall hold office from the date upon which he is elected, until the annual general meeting in the year following his election or re-election. The Chair shall be a director by virtue of his office and shall have such rights and privileges as may be set out in the Rules and as the Board or the Voting Members in general meeting shall from time to time prescribe.
21.2 At the annual general meeting each year, the Secretary shall retire but shall be eligible for re-appointment in accordance with these Articles except if he is a person to whom Article 21.5 applies in relation to the office of Secretary. The election for the office of Secretary shall be conducted in accordance with Article 23. A person so appointed shall hold office from the date upon which he is elected, until the annual general meeting in the year following his election. The Secretary shall be a director and the Company Secretary by virtue of his office and shall have such rights and privileges as may be set out in the Rules and as the Board or the Voting Members in general meeting shall from time to time prescribe.
21.3 At the annual general meeting each year, the Treasurer shall retire but shall be eligible for re-appointment in accordance with these Articles except if he is a person to whom Article 21.5 applies in relation to the office of Treasurer. The election for the office of Treasurer shall be conducted in accordance with Article 23. A person so appointed shall hold office from the date upon which he is elected, until the annual general meeting in the year following his election. The Treasurer shall be a director by virtue of his office and shall have such rights and privileges as may be set out in the Rules and as the Board or the Voting Members in general meeting shall from time to time prescribe.
21.4 In relation to each office of Chair, Secretary or Treasurer (as applicable), Article 21.5 applies to a person if, immediately prior to his retirement from that office, he had been elected to that particular office:
(a) four (4) times consecutively or,
(b) three (3) times consecutively if, immediately prior to the first such time, he held that same office by virtue of a decision made in accordance with Article 24.1 for more than six (6) months of a term to which some other person was elected to that office.
21.5 A person to whom this Article 21.5 applies may not be re-appointed to that particular office if a period of eighteen months has not elapsed since he last ceased to hold such office.
21.6 In this Article 21, "consecutively" means one after another without interruption.

## 22 Appointment of Other Principal Officers

22.1 The Rules shall provide for the appointment of the Other Principal Officers subject to these Articles and provided that there may not be more Principal Officers, other than the President, than the maximum number of directors permitted by Article 19.1.
22.2 At the annual general meeting each year, each Other Principal Officer shall retire but shall be eligible for re-appointment in accordance with these Articles and the Rules. The election for each office shall be conducted in accordance with Article 23. A person so appointed shall hold office from the date upon which he is elected, until the annual general meeting in the year following his election. Each Other Principal Officer shall be a director by virtue of his office and shall have such rights and privileges as may be set out in the Rules and as the Board or the Voting Members in general meeting shall from time to time prescribe.

## 23 Elections

23.1 Any Voting Member may nominate another Member to be the President, the Chair, the Secretary, the Treasurer or one of the Other Principal Officers. Any person nominated as a member of the Board must be a Voting Member.
23.2 Any nomination must be made on the form prescribed from time to time by the Board. Any nomination must be seconded by another Voting Member. Voting Members may only nominate or second one candidate for each post and the form must be completed and returned to the Secretary not later than such date as the Board shall prescribe each year.
23.3 If there are the same number of candidates as there are vacancies for a post, those candidates shall be declared elected unopposed at the annual general meeting. In the event of there being more nominations than vacancies, there shall be an election at the annual general meeting as directed by the Board. The results of any such election must be announced at the annual general meeting.

## 24 Casual Vacancies

24.1 A casual vacancy arising among the offices of Chair, Secretary or Treasurer, or among the Other Principal Officers, shall be filled by a person elected by a majority decision of the Board or by the Voting Members in a general meeting called for such purposes by the Board, provided always that the person appointed to fill the vacancy shall hold office until such time as the person he replaced was due to retire but shall be eligible for re-appointment in accordance with these Articles.
24.2 A casual vacancy arising among the office of President shall only be filled by a person elected by a majority decision of the Voting Members in a general meeting called for such purposes by the Board, provided that the Board may decide to call any general meeting for such purposes in its sole discretion. The person appointed to fill the vacancy shall hold office until such time as the person he replaced was due to retire but shall be eligible for re-appointment in accordance with these Articles.

## 25 Termination of Director's Appointment

25.1 Without prejudice to the provisions of Section 168 of the 2006 Act, a person shall cease to be a director of the Club as soon as:
(a) that person ceases to be a director by virtue of any provision of the 2006 Act or is prohibited from being a director by law;
(b) a bankruptcy order is made against that person;
(c) a composition is made with that person's creditors generally in satisfaction of that person's debts;
(d) a registered medical practitioner who is treating that person gives a written opinion to the Club stating that that person has become physically or mentally incapable of acting as a director and may remain so for more than three months;
(e) that person is suspended from holding office or from taking part in any activity relating to the administration or management of the Club by a decision of the RFU;
(f) that person shall without sufficient reason for more than three (3) consecutive Board meetings have been absent without permission of the Board and all other members of the Board resolve that his office be vacated;
(g) that person is requested to resign by not less than two-thirds of the other members of the Board acting together;
(h) that person ceases to be a Member;
(i) that person is not re-elected to the Board by the eligible Voting Members at the annual general meeting; or
(j) notification is received by the Club from the director that the director is resigning from office, and such resignation has taken effect in accordance with its terms.
25.2 A Chair, Secretary, Treasurer or Other Principal Officer who is removed from office as a director of the Board for whatever reason shall be deemed to have resigned from office and the vacancy shall be filled in accordance with these Articles.

## 26 Directors' Remuneration

The Club shall not employ any director of the Club to provide any services outside the scope of the ordinary duties of a director and shall not pay any director any remuneration in relation to his role on the Board.

## PART 3

MEMBERS

## BECOMING AND CEASING TO BE A MEMBER

## 27 Applications for Membership

27.1 The subscribers to the Memorandum of Association of the Club; the members of the unincorporated association known as the Kings Cross Steelers Rugby Football Club as at the date of incorporation; and such other persons as are admitted to Membership by the Board in accordance with these Articles, shall be the members of the Club.
27.2 Membership of the Club shall be divided into classes as set out in the Rules. The voting rights of each category of membership (as set out in the Rules) may be determined by the Board in accordance with these Articles.
27.3 The Board may offer reduced fees or waive Membership Fees to potential members who are able to evidence financial difficulties in meeting the Membership Fees or as it may see fit.
27.4 No person shall become a member of the Club unless:
(a) that person has completed an application for membership in a form approved by the Board;
(b) that person has made the requisite payment (as set by the Board in accordance with Article 27.8), and
(c) the Board has approved the application.
27.5 The Board may in its sole discretion agree to receive any Membership Fee payable by a member of the Club in monthly instalments (or other intervals set by the Board). Any such agreement shall be made in writing. Subject to Article 30.4, membership shall be deemed to have commenced (or renewed) upon receipt by the Club of the first instalment of fees.
27.6 For the avoidance of doubt membership is open to all without discrimination and may only be refused where admission to membership for good cause such as conduct or character likely to bring the Club or sport into disrepute and no person shall be denied membership of the Club on the grounds of race, ethnic origin, nationality, creed, colour, age, disability, sex, occupation, sexual orientation, religion, political or other beliefs. A person may appeal against such decision by notifying the Board who shall put the matter to a general meeting for it to be decided by a majority vote of the Members present and voting at such meeting.
27.7 A person shall not be entitled to any privileges of the Club until two (2) days have passed since his application for membership was submitted, whether or not he is admitted as a Member before those two days have lapsed.
27.8 The Board may from time to time fix the levels of entrance fees and annual subscriptions to be paid by the different categories of members provided that the Board shall maintain an open membership and ensure that the fees and subscriptions are non-
discriminatory, fair and set at a level that will not pose a significant obstacle to people participating. In particular the Board will have regard to the CASC Regulations relating to the costs of participation and the maximum allowable cost of participation.
27.9 For the purposes of registration, the number of Members is declared to be unlimited, save that the total holders of Honorary Life Memberships shall not exceed twenty (20).

## 28 Honorary Membership

28.1 The Board may elect as an Honorary Member of the Club any person, whether an existing Member or former Member, in recognition of their service to the Club. Subject to Article 28.4, an Honorary Member shall be a Member with all the rights, duties and privileges of membership of the Club but without any obligation to pay any entrance fee or subscription. An honorary membership granted in accordance with this Article 28.1 shall commence immediately upon election.
28.2 An election in accordance with Article 28.1 shall be subject to confirmation at the next following annual general meeting save for when a person is elected in accordance with any criteria set in a Rule made pursuant to Article 18.3(b). In the event that an honorary membership which is required to be confirmed in accordance with this Article 28.2 is not so confirmed, it shall be deemed terminated at the close of such annual general meeting, but the person who had been elected by the Board as an Honorary Member shall be under no obligation to pay any entrance fee or subscription that he may have been due to pay for the period between the election and such annual general meeting.
28.3 Any honorary membership granted in accordance with Article 28.1 shall lapse at the close of a subsequent annual general meeting following their confirmation as Honorary Member by the Voting Members.
28.4 An Honorary Member shall not have any voting rights unless conferred upon them by the Board.
28.5 The Board may elect as an Honorary Life Member of the Club any person, whether an existing Member or former Member, in recognition of their service to the Club. Subject to Articles 28.7 and 28.9, an Honorary Life Member shall be a Member with all the rights, duties and privileges of membership of the Club for the duration of his life, unless otherwise terminated in accordance with 28.9, but without any obligations to pay any entrance fee or subscription.
28.6 An election in accordance with Article 28.5 shall not be valid unless and until approved by the Voting Members at the next annual general meeting.
28.7 An Honorary Life Member shall not have any voting rights, unless conferred upon them by the Board. The Board shall not determine their voting rights until their election has been confirmed or approved at the annual general meeting.
28.8 The Board may in its sole discretion confer voting rights upon any Honorary Member or Honorary Life Member on a case-by-case basis, provided that any voting rights granted in accordance with Articles 28.4, 28.7 and this 28.8 are subject to annual review by the Board. The Secretary shall cause to be published in a timely manner, whether as part of the minutes of proceedings at meetings of the Board or otherwise,
determinations of the Board regarding the voting rights for the time being of Honorary Members and Honorary Life Members.
28.9 The Board shall have power to terminate the honorary membership of any person at any time if it considers such action to be in the interests of the Club so to do.

## 29 Conditions of Membership

29.1 All Members shall be bound by and subject to these Articles and the Rules and shall respect the laws of the game of rugby union as set from time to time by World Rugby.
29.2 The Members shall pay any entrance fees and annual subscription set by the Board under Article 27.8. Any Member whose subscription fee is more than three months in arrears shall be deemed to have resigned his membership of the Club.
29.3 Subject to Article 30, the Board may terminate the membership of any person, or impose any other sanction they determine to be appropriate, in connection with the breach of any condition of membership set out in this Article 29.

## 30 Termination of Membership

30.1 It shall be the duty of the Board, if at any time it shall be of the opinion that the interests of the Club or the sport so require, by notice in hard copy form sent by prepaid post to a Member's address, to request that Member to withdraw from membership of the Club within a time specified in such notice provided any such proposed removal of a Member is only for good cause such as conduct or character likely to bring the Club or sport into disrepute. If, on the expiry of the time specified in such notice, the Member concerned has not withdrawn from membership by submitting notice in hard copy form of his resignation, or if at any time after receipt of the notice requesting him to withdraw from membership the Member shall so request in hard copy form, the matter shall be submitted to a properly convened and constituted meeting of the Board or such subcommittee to which it has delegated its powers. The Board or sub-committee and the Member whose expulsion is under consideration shall be given at least fourteen (14) days' notice of the meeting, and such notice shall specify the matter to be discussed. The Member concerned shall at the meeting be entitled to present a statement in his defence either verbally or in hard copy form, and he shall not be required to withdraw from membership unless a two-thirds majority of the Board members or sub-committee members present and voting shall, after receiving the statement in his defence, vote for his expulsion, or unless the Member fails to attend the meeting without sufficient reason being given. If such a vote is carried, or if the Member shall fail to attend the meeting without sufficient reason being given, he shall thereupon cease to be a Member and his name shall be erased from the register of members. The Board may take any action necessary and available to it to exclude the Member from the Club's premises until the meeting considering his expulsion has been held. For the avoidance of doubt, the Member shall be entitled to attend the Club's premises to attend that meeting (if it is held at them) for the purpose of making his representations. A person may appeal against such decision by notifying the Board who shall put the matter to a general meeting for it to be decided by a majority vote of the Members present and voting at such meeting.
30.2 A Member may withdraw from membership of the Club by giving seven (7) clear days' notice to the Club in writing. Any Member who withdraws their membership of the Club pursuant to this Article 30.2 shall not be entitled to a refund, however the Board may elect to refund an appropriate part of a resigning Member's subscription if it considers it appropriate taking account of all the circumstances.
30.3 A membership terminates automatically when that person dies or ceases to exist or on the failure of the Member to comply or to continue to comply with any condition of membership set out in these Articles or the Rules.
30.4 Where a Member has obtained written agreement from the Board to pay their Membership Fees in instalments in accordance with Article 27.5, his membership shall terminate automatically upon failure to make any payment within five (5) working days of its due date, or such other period as may be set by the Board.
30.5 Membership is not transferable.
30.6 Any person ceasing to be a Member forfeits all rights in relation to and claims upon the Club, its property and its funds and has no right to the return of any part of his subscription.

## ORGANISATION OF GENERAL MEETINGS

## 31 Annual General Meetings

31.1 The Club shall hold a general meeting in every calendar year before 30 July as its annual general meeting at such time and place as may be determined by the Board and shall specify the meeting as such in the notices calling it, provided that so long as the Club holds its first annual general meeting within 18 months after its incorporation it need not hold it in the calendar year of its incorporation or in the following calendar year.
31.2 The annual general meeting shall be held for the following purposes:
(a) to receive from the Board the Club's accounts and the Treasurer's report as to the financial position of the Club;
(b) to receive from the Board a report of the activities of the Club since the previous annual general meeting;
(c) to appoint the Club's auditors;
(d) to confirm the election of any Honorary Members;
(e) to approve the election of any Honorary Life Members;
(f) to announce the election (as appropriate) of the Chair, Secretary, Treasurer, Other Principal Officers and President to be appointed in accordance with these Articles;
(g) to transact any business as may be required by the Rules to be transacted; and
(h) to transact such other business as may be brought before it.
31.3 The annual general meeting (other than an adjourned meeting) must be called by notice of at least twenty-one (21) clear days.

## 32 General Meetings

32.1 All meetings of the Members, other than annual general meetings, shall be called general meetings.
32.2 A person is able to exercise the right to speak at a general meeting when that person is in a position to communicate to all those attending the meeting, during the meeting, any information or opinions which that person has on the business of the meeting. For the avoidance of doubt, such person need not be physically present at the location of the meeting.
32.3 A person is able to exercise the right to vote at a general meeting when:
(a) that person is able to vote, during the meeting, on resolutions put to the vote at the meeting, and
(b) that person's vote can be taken into account in determining whether or not such resolutions are passed at the same time as the votes of all the other persons attending the meeting.
32.4 The Board may make whatever arrangements they consider appropriate to enable those attending a general meeting to exercise their rights to speak or vote at it.
32.5 In determining attendance at a general meeting, it is immaterial whether any two or more Members attending it are in the same place as each other.
32.6 Two or more persons who are not in the same place as each other attend a general meeting if their circumstances are such that if they have (or were to have) rights to speak and vote at that meeting, they are (or would be) able to exercise them.

## 33 Quorum for General Meetings

33.1 No business other than the appointment of the chair of the meeting is to be transacted at a general meeting if the persons attending it do not constitute a quorum.
33.2 Two (2) Voting Members or one-tenth of the membership of the Club (whichever is the greater number) present in person shall be a quorum.

## 34 Chairing General Meetings

34.1 The Chair shall chair general meetings if present and willing to do so. If the Chair shall be absent, or if at any meeting he is not present within thirty (30) minutes after the time appointed for holding the same, the Vice-Chair shall preside if a vice-chair has been appointed under the Rules. If the Vice-Chair is not present or is unwilling to preside within thirty (30) minutes of the time at which a meeting was due to start, or if no vicechair has been appointed:
(a) the directors present, or
(b) (if no directors are present), the meeting,
34.2 must appoint a director or Member to chair the meeting, and the appointment of the chair of the meeting must be the first business of the meeting.
34.3 The person chairing a meeting in accordance with this article is referred to as the chair of the meeting.

## 35 Attendance and Speaking by Non-Members

35.1 The chair of the meeting may permit other persons who are not members of the Club to attend and speak at a general meeting.

## 36 Adjournment

36.1 If the persons attending a general meeting within half an hour of the time at which the meeting was due to start do not constitute a quorum, or if during a meeting a quorum ceases to be present, the chair of the meeting must adjourn it.
36.2 The chair of the meeting may adjourn a general meeting at which a quorum is present if:
(a) the meeting consents to an adjournment, or
(b) it appears to the chair of the meeting that an adjournment is necessary to protect the safety of any person attending the meeting or ensure that the business of the meeting is conducted in an orderly manner.
36.3 The chair of the meeting must adjourn a general meeting if directed to do so by the meeting.
36.4 When adjourning a general meeting, the chair of the meeting must:
(a) either specify the time and place to which it is adjourned or state that it is to continue at a time and place to be fixed by the Board, and
(b) have regard to any directions as to the time and place of any adjournment which have been given by the meeting.
36.5 If the continuation of an adjourned meeting is to take place more than fourteen (14) days after it was adjourned, the Club must give at least seven (7) clear days' notice of it (that is, excluding the day of the adjourned meeting and the day on which the notice is given):
(a) to the same persons to whom notice of the Club's general meetings is required to be given, and
(b) containing the same information which such notice is required to contain.

## VOTING AT GENERAL MEETINGS

## 37 Voting: General

37.1 Subject to Article 37.2, every Voting Member shall be entitled to receive notice of and attend general meetings, and cast one vote.
37.2 Where notice is given in hard copy form, the Club shall not be obliged to deliver such notice where a Member has only provided an overseas address.
37.3 The Rules shall provide for the manner in which votes are to be cast to elect a person to an office, save that if the election is contested, any such vote shall be conducted by means of a poll, which shall be conducted as a secret ballot.
37.4 Other than as provided for by Article 37.3, a resolution put to the vote of a general meeting must be decided on a show of hands unless a poll is duly demanded in accordance with these Articles.

## 38 Errors and Disputes

38.1 No objection may be raised to the qualification of any person voting at a general meeting except at the meeting or adjourned meeting at which the vote objected to is tendered, and every vote not disallowed at the meeting is valid.
38.2 Any such objection must be referred to the chair of the meeting whose decision is final.

## 39 Poll Votes

39.1 A poll on a resolution may be demanded:
(a) in advance of the general meeting where it is to be put to the vote, or
(b) at a general meeting, either before a show of hands on that resolution or immediately after the result of a show of hands on that resolution is declared.
39.2 A poll may be demanded by:
(a) the chair of the meeting;
(b) the Board; or
(c) two or more Voting Members present in person or proxy having the right to vote on the resolution or, if less, a person or persons representing not less than onetenth of the total voting rights of all the Members having the right to vote on the resolution.
39.3 A demand for a poll may be withdrawn if:
(a) the poll has not yet been taken, and
(b) the chair of the meeting consents to the withdrawal.
39.4 Polls shall be taken as the chair directs and he may appoint scrutineers (who need not be Members) and fix a time and place for declaring the result of the poll. The result of the poll shall be deemed to be the resolution of the meeting at which the poll was demanded.
39.5 A poll on a resolution demanded in accordance with these Articles (and for the avoidance of doubt, for the purposes of electing a person to an office if such election was contested in accordance with Article 37.3) may take into account any votes cast by Voting Members in advance. Voting Members who have cast their votes in advance must not subsequently appoint a proxy to vote on such resolution in general meeting.
39.6 A poll demanded on the election of a chair or on a question of adjournment shall be taken forthwith. A poll demanded on any other question shall be taken either forthwith or at such time and place as the chair directs not being more than thirty (30) days after the poll is demanded. The demand for a poll shall not prevent the continuance of a meeting for the transaction of any business other than the question on which the poll was demanded. If a poll is demanded before the declaration of the result of a show of hands and the demand is duly withdrawn, the meeting shall continue as if the demand had not been made.
39.7 No notice need be given of a poll not taken forthwith if the time and place at which it is to be taken are announced at the meeting at which it is demanded. In any other case at least seven (7) clear days' notice shall be given specifying the time and place at which the poll is to be taken.

## 40 Content of Proxy Notices

40.1 Proxies may only validly be appointed by a notice in writing (proxy notice) in the form set out in Annexure 1 (Form of Proxy Notice) which:
(a) states the name and address of the Member appointing the proxy;
(b) identifies the person appointed to be that Member's proxy and the general meeting in relation to which that person is appointed;
(c) is signed by or on behalf of the Member appointing the proxy, or is authenticated in such manner as the Board may determine; and
(d) is delivered to the Club in accordance with these Articles and any instructions contained in the notice of the general meeting to which they relate.
40.2 Notwithstanding Article 40.1, the Board may require proxy notices to be delivered in a particular form, and may specify different forms for different purposes. Any such forms must be circulated to Members at least fourteen (14) days in advance of the general meeting.
40.3 Proxy notices may specify how the proxy appointed under them is to vote (or that the proxy is to abstain from voting) on one or more resolutions.
40.4 Unless a proxy notice indicates otherwise, it must be treated as:
(a) allowing the person appointed under it as a proxy discretion as to how to vote on any ancillary or procedural resolutions put to the meeting, and
(b) appointing that person as a proxy in relation to any adjournment of the general meeting to which it relates as well as the meeting itself.

## 41 Delivery of Proxy Notices

41.1 A person who is entitled to attend, speak or vote (either on a show of hands or on a poll) at a general meeting remains so entitled in respect of that meeting or any adjournment of it, even though a valid proxy notice has been delivered to the Club by or on behalf of that person.
41.2 An appointment under a proxy notice may be revoked by delivering to the Club a notice in writing given by or on behalf of the person by whom or on whose behalf the proxy notice was given.
41.3 A notice revoking a proxy appointment only takes effect if it is delivered before the start of the meeting or adjourned meeting to which it relates.
41.4 If a proxy notice is not executed by the person appointing the proxy, it must be accompanied by written evidence of the authority of the person who executed it to execute it on the appointor's behalf.

## 42 Amendments to Resolutions

42.1 An ordinary resolution to be proposed at a general meeting may be amended by ordinary resolution if:
(a) notice of the proposed amendment is given to the Club in writing by a person entitled to vote at the general meeting at which it is to be proposed not less than 48 hours before the meeting is to take place (or such later time as the chair of the meeting may determine), and
(b) the proposed amendment does not, in the reasonable opinion of the chair of the meeting, materially alter the scope of the resolution.
42.2 A special resolution to be proposed at a general meeting may be amended by ordinary resolution, if:
(a) the chair of the meeting proposes the amendment at the general meeting at which the resolution is to be proposed, and
(b) the amendment does not go beyond what is necessary to correct a grammatical or other non-substantive error in the resolution.
42.3 With the consent of the chair of the meeting, an amendment may be withdrawn by its proposer at any time before the resolution is voted upon.
42.4 If the chair of the meeting, acting in good faith, wrongly decides that an amendment to a resolution is out of order, the chair's error does not invalidate the vote on that resolution.

## ADMINISTRATIVE ARRANGEMENTS

## 43 Means of Communication to be Used

43.1 Subject to these Articles, anything sent or supplied by or to the Club under these Articles may be sent or supplied in any way in which the 2006 Act provides for such documents or information to be sent or supplied by or to the Club.
43.2 Subject to these Articles, any notice or document to be sent or supplied to a member of the Board in connection with the taking of decisions by the Board may also be sent or supplied by the means by which that director has asked to be sent or supplied with such notices or documents for the time being.
43.3 A director may agree with the Club that notices or documents sent to that director in a particular way are to be deemed to have been received within a specified time of their being sent, and for the specified time to be less than 48 hours.

## 44 No Right to Inspect Accounts and Other Records

Except as provided by law or authorised by the Board or an ordinary resolution of the Club, no person is entitled to inspect any of the Club's accounting or other records or documents merely by virtue of being a Member.

## DIRECTORS' INDEMNITY AND INSURANCE

## 45 Indemnity

45.1 Subject to Article 45.2, a relevant director of the Club or an associated company may be indemnified out of the Club's assets against:
(a) any liability incurred by that director in connection with any negligence, default, breach of duty or breach of trust in relation to the Club or an associated company;
(b) any liability incurred by that director in connection with the activities of the Club or an associated company in its capacity as a trustee of an occupational pension scheme (as defined in Section 235(6) of the 2006 Act); and
(c) any other liability incurred by that director as an officer of the Club or an associated company.
45.2 This Article does not authorise any indemnity which would be prohibited or rendered void by any provision of the 2006 Act or by any other provision of law.
45.3 In this Article:
(a) companies are associated if one is a subsidiary of the other or both are subsidiaries of the same body corporate, and
(b) a relevant director means any director or former director of the Club or an associated company.

## 46 Insurance

46.1 The Board may decide to purchase and maintain insurance, at the expense of the Club, for the benefit of any relevant director in respect of any relevant loss.

### 46.2 In this Article:

(a) a relevant director means any director or former director of the Club or an associated company;
(b) a relevant loss means any loss or liability which has been or may be incurred by a relevant director in connection with that director's duties or powers in relation to the Club, any associated company or any pension fund or employees' share scheme of the company or associated Club; and
(c) companies are associated if one is a subsidiary of the other or both are subsidiaries of the same body corporate.

## 47 Dissolution

Upon dissolution of the Club any remaining assets shall be given or transferred to another registered CASC, a registered charity or the sport's governing body (namely the RFU) for use by them in related community sports.

## Notes to the proxy form

1 As a Voting Member of the Club you are entitled to appoint another person as your proxy to exercise all or any of your rights to attend and to speak and vote at the meeting.

2 The appointment of a proxy will not prevent you from subsequently attending and voting at the meeting in person. If you have appointed a proxy and attend the meeting in person, your proxy appointment will automatically be terminated.

3 A proxy does not need to be a member of the Club but must attend the meeting to represent you. To appoint as your proxy a person other than the chair of the meeting, insert their full name in the box. If you sign and return this proxy form with no name inserted in the box, the chair of the meeting will be deemed to be your proxy. Where you appoint as your proxy someone other than the chair of the meeting, you are responsible for ensuring that they attend the meeting and are aware of your voting intentions.

4 To direct your proxy how to vote on the resolutions mark the appropriate box with an " X ". If no voting indication is given, your proxy will vote or abstain from voting at his or her discretion. Your proxy will vote (or abstain from voting) as he or she thinks fit in relation to any other matter which is put before the meeting.
