Covid Safe Addendum to the Terms and Conditions of Use

In addition to the existing Health and Safety section of the Terms and Conditions, Third Party Users are required to sign this Covid Safe Addendum to confirm your agreement to support The Foundation and the School with the steps necessary to comply with the Covid Safe operating procedures.

- We're following the Covid-19 government safety advice for all participants, spectators and staff to achieve the highest standards. We assess the guidelines regularly.
- We agree to follow new operating procedures, cleaning schedules and one-way systems to help manage social distancing.
- Some staff may be wearing personal protective equipment so they can work safely.
- The Third Party Organiser (main contact or designated activity lead) must brief all activity attendees of the Health and Safety requirements and these additional Covid Safe operating procedures, which may be varied from time to time.
- The Third Party Organiser is required to record and maintain a fire safety and track and trace register of every participant and spectator and comprise of a full name and contact telephone number. (see GDPR note below)
- Only one spectator is able to accompany child participants who are under 12 years.
- Spectators are not to gather in large groups at any time and must maintain social distancing based on the current Government guidelines.
- Every Organiser, participant and attendee must use the sanitising dispensers provided before entering the school or commencing any lettings activity.
- Everyone must use the sanitising dispensers or hand washing facilities provided before and after using any of the toilet facilities.
- The number of simultaneous participants of a lettings activity will be based on a risk assessment and be subject to the limitations of the facilities being used in the school.
- Each letting activity's organisers and attendees will form an 'activity bubble'.
- Adherence to the Terms and Conditions and the Covid Safe addendum are required at all times.
- The Site, Lettings Supervisor and Lettings Assistant staff will have the final word on the interpretation of the Terms and Conditions and Covid Safe addendum. Anyone failing to follow these requirements may result in the school staff removing the participants from the activity. We will need to operate a '1 strike apdyou're out' approach.
