<u>RugbySafe</u> is RFU's overarching player safety and welfare initiative to support clubs, schools, colleges, universities and participants at all levels of the game. It aims to provide evidenced-based information, guidance and advice on best practice and how the game should be played and managed to ensure that rugby is played in a safe and enjoyable environment.

Accident Report Form	Clubs/schools should keep a record of any incidents both on and off the pitch.	A template is available on the <u>RugbySafe</u> <u>Essential Guide and FAQ</u> page.
	Each first aider should have access to an accident book/form to record any incidents that required their attendance. However, clubs/ schools retain overall responsibility for ensuring that records are maintained and appropriately stored. Activate	Activate is an injury prevention exercise programme that can be integrated into training and pre-match sessions. The exercises included in the programme are designed to improve functional and core strength, balance and agility, all of which assist a player in dealing with the physical demands of the game. The research on which the Activate programme is based suggests that the conditioning of players can significantly reduce the risk of injury, including concussion incidence by up to 59%. An overview of the Activate research highlights the key findings.	The Activate FAQ provides an overview of the programme and answers some initial questions. More information and free resources including exercise cue cards and videos are openly available to access on the Activate website. It is highly recommended that coaches and teachers attend the face-to-face session; this equips attendees with the key components of the Activate programme so that they can confidently deliver it as part of their existing sessions. The free sessions can be organised through the local RDO/CRC.

The exact requirements will vary based on location, facilities, the type of activity and the number of people taking part. Headguards	Head guards can help to protect the head from cuts and abrasions, and prevent the development of cauliflower ears and wearing a head guard should be the choice of the player/parent. Head Injury Assessment (HIA)	The Head Injury Assessment (HIA) is only used in matches where there are the appropriate facilities and systems in place to implement the process, such as international fixtures and the English Premiership. Health Care Professionals	There are a number of different therapists and Health Care Professionals (HCPs) who may support both pitchside and rehab support. Clubs, schools, colleges and universities should ensure that the HCP has the relevant qualifications, training, experience and insurance for the role. Hearing Aids	It may be appropriate for hearing aids to be worn for contact rugby activity. However, they must comply with the requirements of World Rugby regulation. The risk of injury to the player wearing the hearing aid, to other players and the impact of a broken device should be considered. Ice Treatment	Applying ice to a suspected injury is theoretically providing therapy, which is not the role of a first aider. Injury Reporting	Clubs, schools, colleges and universities should keep an internal record any incidents both on and off the pitch. However, it is vital that certain injuries are reported to the RFU. RFU Reportable Injury Events are defined as: • An injury which results in the player being admitted to a hospital (this does not include those that attend an Accident or Emergency Department and are allowed home from there). • Deaths which occur during or within 6 hours of a game finishing. Clubs, schools, colleges and universities are also required to report injuries in which artificial grass pitches or equipment such as sports goggles are involved. Mouthguards	It is strongly recommended that mouth guards are worn for any contact rugby activity (both training and matches). The use of mouthguards can help to protect the teeth and face. However, there is currently no conclusive evidence that mouth guards reduce the risk of concussion. It is recommended that mouthguards are custom-fitted as other alternatives such as self and premoulded versions generally provide a reduced level of fit and protection.
