| Match participants<br>may be exposed<br>to infection of<br>Covid-19 virus   | Illness,<br>potentially<br>severe   | <ul> <li>Separate risk assessment for participating in matches issued to players and officials of Ely City FC and sent in advance to visiting teams</li> <li>Additional seating should be provided in enlarged technical areas to ensure social distancing in the dugouts.</li> </ul>   | Moderate        |
| Access to<br>clubhouse with<br>potential for<br>person to person,<br>or surface to<br>person, infection<br>of Covid-19 virus                              | Illness,<br>potentially<br>severe   | <ul> <li>Access to the various areas of the clubhouse will be controlled with the use of well signed one way systems so as to enhance social distancing.</li> <li>People wishing to make a purchase from the bar will adhere to social distance markings on the floor and should only approach the bar area when called forward</li> <li>All drinks should be served in disposable plastic cups.</li> <li>Customers will be requested to make payment via contactless card machine whenever possible.</li> <li>Bar surface and tables will be regularly cleaned with appropriate product.</li> <li>Whenever possible doors should be left open to eliminate the need to touch handles</li> <li>All common touch points, including toilet facilities, to receive enhanced cleaning with appropriate product.</li> <li>In order to remove the risk of aerosol droplets hand dryers will be switched off and paper towels used in hand washing areas.</li> </ul> | Moderate        |

| Person to person infection of Covid-19 virus whilst spectating               | Illness, potentially severe   | <ul> <li>The initial capacity of the stadium will be 150 spectators, (not including match participants, committee members and club official matchday volunteers). When notification is received that stage 2 is to be implemented capacity will rise to 300.</li> <li>Spectators queuing to enter the ground should do so in a socially distanced manner. The club should manage this with the aid of items such as floor markings, notices and volunteers advising.         <ul> <li>It may be necessary to utilise some parking bays to create additional safe queueing space.</li> </ul> </li> <li>Spectators should be encouraged to make payment without using cash. In order to do this the gate to the side of the turnstile block will be open with a volunteer taking payment with a card reader. Any spectators using cash will be directed to the turnstile entrance.         <ul> <li>Due to the enclosed nature of the turnstile entrance only one person/same household group should be admitted at any one time.</li> <li>As soon as practicably possible the club should investigate, and implement, a means of advance ticket purchase.</li> </ul> </li> <li>On entering the ground spectators should give their name and contact details to a club official in order to keep a record for track and trace purposes. These details will be kept securely and destroyed after 21 days.         <ul> <li>As soon as practicably possible the club should investigate, and implement, a system of "checking in" for spectators to reduce the requirement for physical lists, i.e. QR code scanning.</li> <li>In order to maintain social distancing, until further notice, the stand will be closed. Any spectator with mobility issues who requires to have a seat should make themselves known to a club official who will arrange for a chair to be brought from the clubhouse so that the spectator may be seated in a suitable area.</li> <li>Any non-participants at the match, (to includ</li></ul></li></ul> | Moderate      |
| The stadium reaches capacity and there are still people waiting to be let in | Unrest or<br>disappointment<br>among those<br>not let in leading<br>to distress and,<br>or verbal or<br>physical abuse<br>to volunteers | <ul> <li>Spectators will be advised in advance using social media and other appropriate channels of reduced capacity and the need to arrive early.</li> <li>The number of spectators should be monitored carefully and when 75% of reduced capacity is reached, (112 or 225 at stage 2), a message should be sent using social media to advise that the ground is nearly full.         <ul> <li>An estimate of those waiting to get in should be made and if this exceeds, or approaches, a figure which will reach capacity any new arrivals should be politely told they will not be able to gain access on this occasion.</li> </ul> </li> </ul>  | Moderate      |

The person who retrieved the ball should then wash their hands or use a suitable cleaning gel.  | Low              |
| A person<br>develops Covid-<br>19 symptoms<br>during a match  | Illness,<br>potentially<br>severe   | If a player, coach, spectator, match or club official becomes symptomatic during a match they should immediately remove themselves from the ground and return home as soon as possible. NHS guidance on further management of symptoms should be followed.  | Moderate         |
| A person<br>develops<br>symptoms of<br>Covid-19 after<br>attending a match  | Other attendees<br>may have been<br>infected that<br>then go on to<br>infect others | <ul> <li>A record of everyone attending a match should be kept.</li> <li>If an attendee subsequently develops symptoms and tests positive for the Covid-19 virus any relevant recent attendance list should be made available to the NHS Test and Trace service.</li> </ul>   | Moderate         |
| Should the referee be required to remove players form the pitch in an unplanned manner, e.g. in the event of a thunderstorm, players and officials may be at risk of person to person infection of Covid-19 virus if no suitable space is allocated | Illness,<br>potentially<br>severe   | Before the match it will be agreed between captains and officials where teams should move to. As there are currently no spectators in the ground the following could apply:  One team could shelter in the dressing room area ensuring all available spaces are used to meet social distancing.  The other team could shelter in the clubhouse, preferably in the foyer and bar areas as the dancefloor section could pose a slip hazard.  The match officials should assess the situation and shelter where most appropriate.  Spectators will be asked to shelter in their cars if applicable until such a time as the match is deemed safe to continue or it is abandoned.  Any other non-participants present should shelter at the dancefloor end of the clubhouse, again ensuring social distancing is maintained with groups limited to six. |                  |
