Chester Hockey Club - Annual General Meeting Monday 5th September 2022

The AGM this year will be virtual, using proxy voting to determine committee posts and captains. The progress of the club during 2021-22 will be reported on-line and the opportunity to put motions forward will be available up to two weeks before the AGM.

The reason for this change is to attempt to meet our constitution rules that require 20% of the membership to take part. The substantial growth in club membership since the 1980s has led to a situation where we have been in breach of our constitution in recent times failing to be quorate at AGMs. If we fail to be quorate, the committee will seek to amend the constitution at next year's AGM a move which again requires 20% of the membership to vote upon.

The Committee have identified skills gaps within its membership and we are looking to co-opt members with legal knowledge, social media marketing as well as others to shadow current post holders to insure continuity of club progression. The club has made significant progress in recent years both on and off the pitch and we would like this situation to continue. As a voluntary organisation we need the help of many, and we would like to hear from any member who can help in anyway.
