- I/We agree that if a player leaves the Club, all kit and equipment must be returned to the Club which may be via the Team Manager/Coach.
- I/We understand that any outstanding fees or monies owed must be settled with the Club before any player can join, play for or be transferred to and from another Club.
- I/We understand that the Membership Fee is not refundable.
- I/We agree that my/our email address can be used to send communication about Club news, events and initiatives.
- I/We understand that my/our email address will not be passed to any person outside of the Club.
- I/We confirm that the player and I/we will abide by the Club 'Codes of Conduct' and the 'FA RESPECT' Campaign
