It should be noted that Gill Shields was the club Safeguarding Officer and the RFU require that as such they must be a Board member.

That leaves 5 places open for election to the board. 4 need to be elected for a two year period and 1 to be elected for 1 year so as to maintain the rotational balance.

There is also a vacancy for the vice president post.
