

3G SPORTS PITCH TERMS & CONDITIONS

It is the responsibility of the person named on this sheet to ensure that their groups comply with the following conditions:

- Adequate First Aid provision is made for the duration of the booking. In the event of an accident requiring further medical attention, please inform staff of Oxford Football Partnership.
- Booked times must be strictly adhered to.
- All play must end promptly.
- **Children's groups** - Should be supervised at all times at an adult/child ratio of supervision suitable for the requirements of the activity taking place and by at least one adult arranged by the Hirer. This includes their arrival and departure and may therefore be outside the booked times. Unless specially requested and booked, the hire does not include any equipment other than goal posts.
- **Access** - To the site must be made through the allocated gateway and pathways.
- **To help protect the surface** - The management draws your attention to the following - Only clean training-type footwear with dimples not exceeding 5mm and moulded studs are to be worn. Blades and rigid blade style of boot or metal studs will not be permitted onto the surface. Failure to comply will result in you being asked to leave the Arena.
- **Footwear** - Boots will need to be worn, AstroTurf Boots/Trainers will not be permitted.
- **No food or drink, chewing gum, smoking or dogs are allowed on the pitch or its surrounds AT ANY TIME.**
- **Players** - must not play at the side of the pitch or on surrounding grass area.
- **Payment** - all payments for bookings must be paid for either before, at the time of booking or on receipt of an invoice from Oxford Football Partnership.
- Oxford Football Partnership, reserves the right to close or prohibit the use of any of its facilities if at any time in its own opinion the facilities are or will be unfit for use. In such cases, no charges will be due and the Hirer will receive a refund of any fees pre-paid. Oxford Football Partnership will not be held responsible for any financial or other loss arising as a result of such withdrawal of facilities.
- In the case of cancellation of a booking by the Hirer, where at least 7 days' notice has not been given, the Hirer shall be liable for the hiring fee, unless the facility is re-let to the satisfaction of Oxford Football Partnership.
- **Insurance** - Oxford Football Partnership is under no liability whatsoever in respect of personal injury, loss or damage which may be incurred by those using the Artificial Sports Pitch or Community Arena, unless it is proved that Oxford Football Partnership has been negligent . Furthermore, Oxford Football Partnership, accepts no responsibility for any claims, actions, demands, proceedings or costs arising out of any claims made against the Hirer by a third party, and the Hirer shall indemnify Oxford Football Partnership against all such claims which may be brought against Oxford Football Partnership arising out of or incidental to the hire of the facilities and equipment.
- **Damage** - the Hirer agrees to pay Oxford Football Partnership, on demand the cost of repairing or making good any damage to the pitch, to the buildings or to the furniture, equipment and effects therein which may be damaged or destroyed by or in consequence of the booking.
- **Admissions** - Oxford Football Partnership, reserves the right at its absolute discretion to refuse the admission of or to evict any person from the pitch or Sports Centre.
