



DAILY COVID-19 ATTESTATION AND AGREEMENT

This form must be completed and submitted prior to entry and use of any facility owned or operated by Rugby Canada and any of its agencies, contractors or equivalent provincial sports organizations (collectively, the "Organization"). The Participant or their legal guardian, must attest to the questions below:

- I attest to the fact that I/the participant or anyone in my household does not have 1 or more of these new or worsening symptoms today or in the last 5 or 10 days. Fever >37.8° C. Cough. Difficulty breathing. Decrease or loss of taste / smell.

- 2. I attest to the fact that I/the participant_or anyone in my household does not have 2 or more of these new or worsening symptoms today or in the last 5 days. Sore throat. Feeling very tired. Runny nose/ nasal congestion. Muscle aches/joint pain. Nausea, vomiting or diarrhea.
