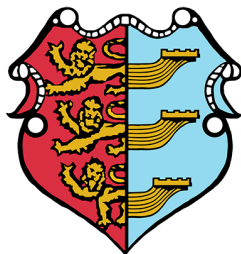

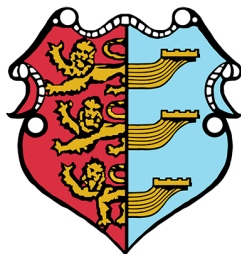
The document will be updated at such times which are deemed necessary, and in line with FA guidance and HM Government applicable guidelines at that time.

Competitive match play and training	Infection risk of Covid-19	C	4	HIGH	<ul style="list-style-type: none"> Brightlingsea Regent FC are affiliated with Essex County Football Association for 2020-21 Brightlingsea Regent FC will provide sufficient stewarding on matchdays, to enable all areas of the stadium to be effectively managed for safety and to be positioned at key locations as designated on the matchday by the Covid-19 Officer Safety briefings prior to competitive activities should be provided reminding participants of The FA 'Code of Behaviour' and the requirement to social distance during breaks in play. Pre-match handshakes will not take place. Instead players will be asked to hand-sanitise before kick-off. Team talk huddles should not take place. Team talks can take place, as long as social distancing is observed and held outdoors where possible. Warm-ups/cool-downs should always observe social distancing. During matchdays non-playing players and additional team support staff will be seated in the Danny Gee stand. All to observe social distancing and allocated a team area. The touchline grassed area will be available for warm up, with entering and exiting the pitch using access from the small double gates adjacent. All activity will be socially distanced as far as is reasonably practicable. All accessed areas will be monitored by designated stewarding, for exit and entry control. During match time. 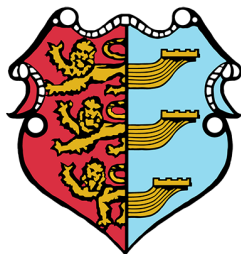

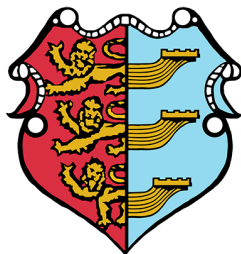

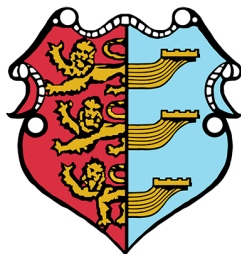
