Chairman	- There was a brief discussion about the recent request from Future Legends for their second	
update	payment to be made (see below for email extract from Nigel Bruce), with no firm decision made. - I am going to invoice the club for the second half of coaching as agreed at the AGM. To do	
	anything different would be to follow the request of the ex-Chairman, so I won't do that. However, and to be fair to the club, at the end of the summer, I will provide a dummy invoice for the whole season. If there is a shortfall then we will refund the difference to the whole club; for the avoidance of any doubt, if the invoiced figure is in excess of the amount agreed, we won't of course be invoicing the excess. 	 There are 2 possible options that the club can consider in responding to this request: Pay the requested £3,800 and await repayment from FL of any potential overpayment after training sessions have ceased and receipt/reconciliation of 'dummy' invoice (this puts the 'risk' on the club) Make an 'advance' payment to FL to cover likely training costs for July/Aug (say £2,850, 75% of request) and await reconciliation of 'dummy' invoice once training has ceased to decide whether club or FL are owed money (this shares the 'risk' between the club and FL) 	
	 Two matters were raised for further discussion at the next committee meeting: 1. Date of agm is brought forward to the end of the season so that a full discussion on the way forward for the club can be discussed and agreed whilst recollections about this season are fresh in the mind 2. That the club reverts to being run by a full committee of elected officers rather than a much smaller executive committee, in order to give all officers the opportunity to have their views/requests aired and discussed in an open and transparent way 	
	 At the end of the meeting Katherine Avery stated that she wished to step down from her role as Club Secretary, this was reluctantly accepted. I would like to express my and the club's gratitude for all the hard work that Katherine has put into the club over the last 16 months on secretarial, membership and many other (non-role related) activities
