Chairman update	- Prior to the meeting the Chairman's summary for 2020 was circulated for

- 2020 has been a strange year but RH wanted to thank all the Committee/Club Members for making PGCC a success especially NB for getting cricket underway so quickly and RG for ensuring we capitalised on grants
- Personal gratitude was expressed towards Jane Woodward and Michael Clark for their contributions to the Club. They have since stood down.
- Thank you to all the volunteers for their behind-the-scenes work Steve Durant (Bar), Ginger (Pitch) and the Facilities Manager (PA with the assistance of PN and WL)
- Seniors and Juniors have had a great season, the Club is in a good place for 2021 and 2021 will see the introduction of a second Sunday XI team
- RH believes the reduced Executive Committee has worked well for 2020 but would like to bring back the role of the Vice Chairman

#### **Club Constitution**

- RH reiterated the key changes were the removal of any future paid Life Memberships now just Honorary will be awarded and the introduction of the Temporary Pay as you Play membership for new members (restriction on the number of games before full membership is sought)
- DC queried that the Life Membership change does not affect those currently holding this status. RH confirmed that there is no change to the current Life Members – it is only future eligibility which will be based on the honour only

#### Membership categories

- It was agreed that the President position held no voting rights at the Election of Officers or AGM.
- SJ and DC confirmed that PGCC did historically allow this for a period, but it caused conflicts within the Club. However, the President can chair the AGM, however the Chairman has the casting vote
- Both documents were approved and voted by the following SP, KW, NB, NO, PA and WL to name a few
- KA will upload the new Constitution and Membership Categories to the PGCC website (completed)

# Head of Cricket update

- Prior to the meeting the Head of Cricket's reports were circulated for comment.
   These were One Club, Selection Policy, Future Legends 2021 proposal, Junior Cricket co-ordinator job description
- NB summarised 2020 one that history will record as one of the strangest as it was the government who decided when, where and how Clubs could play cricket
- PGCC started towards the end of May, earlier than other local Clubs
- Saturday 1st XI finished second in their truncated league to Knotty Green
- Saturday 2<sup>nd</sup> XI won their league on their final game against Holyport
- Sunday XI played some great cricket Will Heyes' achievement of 99 was a particular highlight
- Under 15s had very little cricket to be rectified in 2021 now that some of the
   2020 Under 13s will be eligible to play
- Well done to the Under 13s and Under 11s management and squads for the sheer number of games played and for beating teams such as Cookham Dean (regularly!!)
- Thank you to all the parental helpers for making 2020 a successful season of cricket
- The U9s is an important age group, introducing children to playing matches. We have a number of very talented U9s who showed their abilities in the mix of internal and external games arranged by manager Pawan Sharma

- 2021 season prep has already started with deep drilling to encourage grass growth, thereby making better wickets
- Looking forward we are awaiting government guidance on indoor cricket training for adults especially with the restriction of 6
- All of NB's documents were agreed at the Committee meeting on 22 November but in essence as a Club NB is keen that there are equal opportunities between Senior and Junior cricket, ground usage and coaching
- DC queried the criteria for Juniors playing in Senior games as he feels the criteria is too prescriptive. DC feels that a Junior playing in a Senior game will be treated on an equal parr with the other Seniors and match day/opposition will dictate how the Juniors are used (as would the Seniors)
- NB confirmed the wording is an intent rather than a directive. NB wants to avoid the Juniors being fillers.
- NB wants to ensure that the Juniors are recognised for their strengths too
- DC recognised that in the past Seniors (even non-playing Seniors) have been used as fillers. Last year this did not happen as there was a lot of member availability
- NB accepts the Junior needs to be treated as an equal member of the squad and the captain has the right to manage the Junior in the same way he would manage a Senior
- SP confirmed that the policy expressed ambition, rather than it being a hard policy
- SP asked why there was no Junior selection policy
- NB confirmed that one of the tasks he would ask the Junior cricket co-ordinator to do would be to draft one. Different criteria are used for Junior matches, but NB and the Junior cricket co-ordinator will develop a policy for a future Committee meeting.
- NB confirmed the Selection Committee would be the 4 Senior Captains, himself, and Steve Curlewis. It was agreed the Captains would have the final say in any disagreement in a team selection
- DC asked if a Junior Manager would have input as to who was to play for the Senior team. NB confirmed no and that he and Steve would assist/bridge that
- PN endorsed that NB and Steve Curlewis know the Juniors well enough to identify players
- SP reiterated that the document formalises the reality of what happened in 2020
- MH queried the '3 consecutive games' for a Junior. NB confirmed that was only where possible. He said some Juniors would take to Senior cricket like a duck to water, others would need more time to settle. If 3 consecutive games are not practical, then that is fine
- MH, SP and DC suggested that the wording could be further refined to clarify one or two points. All to speak to NB to make modifications
- NBs documents were endorsed by SP, MH, DC, KW, CH, NO and PN

#### Treasurer update

- RG circulated the Club financials prior to the meeting
- Total income for the year ending 31 October 2020 was £36.5K, bar costs £5.5K, gross profit £31K, total expenses £36.5K, net overall deficit £-5.5K
- At present there is £14.5K in the bank, some off-season expenditure is due
- Compared to 2019 our total income was £60K main difference is the reduction in bar sales £40K in 2019 v £10K in 2020
- We did better on grants received this year £18K (RBWM, Prince Phillip Trust, Heathrow Community Trust and Mobbs Memorial

- With the increased focus on ensuring subs were paid we collected £6K in 2020 on half subs due to Covid compared to £7K in 2019 where there was no reduction in fees
- Biggest Club costs artificial wicket, two new nets, coaching, pitch, and outfield work
- RG feels it has been a satisfactory year despite £5K deficit but this is smaller compared to the previous year of £9K
- RG feels there will be £10K in the bank at the start of 2021 remaining outgoing costs are minimal therefore Club is in a good shape
- SP asked if the new app intended for 2021 will recognise that subs have been paid. NB agreed to check
- RG also confirmed that Pitchero has a good facility for collecting membership fees, which is RGs preferred approach for 2021
- DC asked how much we paid Gary Hales. RH and RG confirmed it was approximately £4K, roughly £150 per week. Gary has spent a significant amount of time up at the Club this year

	- CHY did ask that with the reduced subs for 2020 payment was a great success. Why cannot this be continued into 2021
	- RG confirmed that £100 is reasonable. If any Club member was suffering from financial hardship, they can speak directly to the Chairman for a confidential chat about reducing membership fees
	- NB confirmed it would put us around top of the lower band of membership fees. Some Clubs carried on charging full rate during Covid. Also, it should be noted
	that the membership fees for 2021 includes a new Club top and more coaching therefore better value for money than previous years
	- KW confirmed that Boyne Hill and Cookham Dean charge higher membership
	fees but agreed that where needed members should be able to pay in quarterly
	payments for example if this helps
