





THE OXTED AND LIMPSFIELD CRICKET CLUB "100 STYLE" FUND RAISING SCHEME (a Small Society lottery)

PURPOSE AND PRINCIPLES (April 2021)

The scheme will be known as "The Oxted and Limpsfield Cricket Club (OLCC) 100 Club Fund Raising Scheme", and its purpose, unsurprisingly, is to raise funds for the Cricket Club.

Members and Associates are invited to participate by depositing £5 each month into the Club's bank account. By making such a deposit then for the purposes of this scheme, it is deemed that you have accepted and will adhere to the rules below.

The scheme year will commence on 1st June each year.

50% of the money raised will be used to help meet club running costs for both junior and adult sections including maintaining the cricket grounds, pavilions, machinery, tools, training gear and playing kit. The remaining 50% of the money raised will be returned to winning participants as prize money.

During the course of a calendar year, there will be three draws at four monthly intervals, at or around the end of September, January and May. Assuming the minimum of 20 entries is reached, the top prize in each draw will be £100, second £50, third £30 and fourth £20. Should the minimum of 20 entries not partake in any particular draw, then the fourth, third and second prizes will be reduced proportionately in that order. There must be a minimum of 11 entries for a draw to be held.

Participants may opt out (or in) at the conclusion/commencement of each four monthly period.

Should there be an average of more than 21 entries subscribing over the three draws of any scheme year resulting in an excess within the prize fund at the end of the scheme's year, there would be a "Bumper Annual Draw" immediately after the May draw (for example, 50 participants @ £60 per annum = £3,000 raised, divided equally £1,500 for club, £1,500 for prize fund. 3 draws at £200 prizes = £600 awarded in prizes during the scheme year. This would leave £900 with half as first prize, a quarter as second, 15% as third and 10% as fourth). Only people who have entered for all 3 draws will be eligible for the Bumper Annual Draw.

RULES (April 2021)

- 1. "The OLCC "100 Club" Fund Raising Scheme", is a Small Society Lottery and is open to all club members and associates over the age of 16.
- 2. For a subscription of £5 per month, a chance in your name will be entered into each draw. You can subscribe for more than one share should you wish but only complete chances may be subscribed to.
- 3. Monthly subscriptions of £5 should be made commencing June 2021, by using the Club 100 tab in the Club Shop on our website. Should anyone wish to join the 100 Club between draws, they may do so as long as they pay the £20 to cover the four months qualifying period. Longer term subscriptions may also be paid in advance, either four monthly at £20, or annually at £60, by depositing into the same club bank account.

- **4.** Whilst not encouraged, late entries made by a bank deposit into the club account will be accepted up to the day before a draw is made.
- **5.** A draw will be made every four months, (ends of September, January and May) with 1st, 2nd, 3rd and 4th prizes awarded in each draw.
- **6.** Assuming a minimum of twenty (20) entrants, prizes each four monthly draw will be awarded as follows 1st prize £100, 2nd prize £50, 3rd prize £30 and 4^{th} prize £20. If in the opinion of the 100 Club Officers the number of participants justifies an increase in prize money the 100 Club Officers may do so to a maximum of 50% of the money raised.
- 7. In the event of an average of more than 21 entries subscribing over the three draws of any scheme year resulting in an excess within the prize fund at the end of the scheme's year, there would be a "Bumper Annual Draw" immediately after the May draw (for example, 50 participants @ ± 60 per annum = $\pm 3,000$ raised, divided equally $\pm 1,500$ for club, $\pm 1,500$ for prize fund. 3 draws at ± 200 prizes = ± 600 awarded in prizes during the scheme year. This would leave ± 900 with say half as first prize, a quarter as second, 15% as third and 10% as fourth). Only people who have entered for all 3 draws will be eligible.
- **8.** Should, at any four monthly draw there not be a minimum of twenty (20) qualifying entries, then 2^{nd} , 3^{rd} and 4^{th} prize values will be reduced proportionately, at the same time ensuring the value of prizes remains at 50% of the subscriptions paid, with a top prize of £100.
- **9.** Should at any time there be less than eleven (11) entries for a draw, then that draw will be cancelled and participants will be entitled to a refund of their entry subscription.
- **10.** Members' names will only be entered into the draws if their subscription is up to date at the time of the then current draw.
- **11.** A draw to determine the allocation of ball numbers to entrants will be made at the inaugural draw. Those numbers remain with those entrants until they 'retire' from the scheme. Additional entrants will be allocated the next available number on a chronological (or by using a "retired number") basis, at the time of their entrance.
- **12.** The draw shall be made by Officers of the Club at the end of every fourth month, ie end of September, January and May. Where possible, the draw will be made when there is a gathering of additional club members and associates.
- **13.** All winnings will be paid by electronic bank transfer. All participants will be notified by e-mail of the winning names.
- **14.** It is a condition of the scheme that winners accept their prizes. Should winners wish their winnings to be deposited elsewhere other than to themselves, this can be arranged following their written instruction, e-mail notification is acceptable for this purpose.
- **15.** Unless otherwise advised, a member paying by monthly subscriptions, will be deemed to have resigned from participation in the scheme if his/her subscription remains unpaid for a period of four months, and any part paid subscriptions for that draw period will be refunded.

- **16.** If a winner cannot be contacted, the winnings will be placed into club funds after the expiration of six months.
- **17.** The "100 style" Club will be run by the appointed OLCC Cricket Club's 100 Club Officer and Hon. Treasurer. In the case of any dispute or appeals, the decision of the OLCC Committee, as elected, shall be final.
