- Changing room facilities, toilets, sinks and touch points will be cleaned and sanitised before and after each session. (Covid Officer / groundstaff / volunteers).
- A maximum of 11 people in the changing room at any one time. Players to be advised to stagger getting changed and enter the pitch area as soon as dressed for play to enable others to then get ready. The home team will also have the use of the board room to spill into at this time due to hospitality being paused.

- Players / officials to bring own individual water bottles / drinks and not to be shared with others at any time.
- Dug outs solely for managers and physio at this time. Designated seating areas will be available for subs.

Post Match / training

 Change and leave the changing room facilities in a quick and efficient manner. Use of changing rooms again to be staggered and no more than 11 at one time. Showers to be
