## 3 AIMS AND OBJECTIVES

The aims and objectives of the Club are:

- To offer competitive and social cricket, training and coaching to all its members.
- To promote the Club within Willoughby, the local area and cricket communities.
- To manage the associated grounds and facilities at the Club.
- To ensure a duty of care to all members of the Club.
- To provide all of its services in a way that is fair and equitable to everyone.
- To ensure that all present and future members receive fair and equal treatment.


## 4 OFFICE

The office of the Club shall be the current address of the Honorary Secretary.

## 5 HEADQUARTERS

The Headquarters of the Club shall be The Pavilion "The Green" situated at Pye Court, Willoughby. The building shall be used solely for the purposes of a Cricket Pavilion incidental to the use of cricket by W.C.C. as a village cricket ground and for no other purpose, between the hours of 08.30 and 22.30 Sunday to Friday inclusive and 08.30 and 23:00 on Saturday.

The building shall not be used at any time for social functions for members of the public and shall not be used for music, dancing, or any like activities including the playing of amplified or dance band music.

## 6 MEMBERSHIP AND MATCH FEES

Membership of the Club shall be open to anyone interested in the sport on application regardless of sex, age, disability, ethnicity, nationality, sexual orientation, religion or other beliefs. However, limitation of membership according to available facilities is allowable on a non-discriminatory basis The Club may have different classes of membership and subscription on a non-discriminatory and fair basis. The Club will keep subscriptions at levels that will not pose a significant obstacle to people participating.

Membership classes are:

- Full Member Male and female playing members 18 years old or over on $1^{\text {st }}$ April of that playing year.
- Student Member - Male and female playing members 15 years old or over on 1st September of the previous year (usually school year 11) and in full-time education.
- Junior Member - Male and female playing members under 15 on 1st September of the previous year (usually school year
- Associate Member - A social, non-playing member.
- Honorary Member - A member that has made a significant contribution to the Club or holds one of the Club's honorary positions i.e. Chairman, Secretary and Treasurer.
- Life Member - A member that has made an extraordinary contribution to the Club.

The Club Committee may refuse membership, or remove it, only for good cause such as conduct or character likely to bring the Club or sport into disrepute. Appeal against refusal or removal may be made to the Management Committee in writing via the Honorary Secretary.

No person shall be admitted to membership or be admitted as a Candidate for membership or to any of the privileges of membership without an interval of at least two days between nomination or application for membership and admission - nor may any person becoming a member without prior nomination or application be admitted to the privileges of membership without an interval of at least two days between becoming a member and admission.

A Full, Student, Junior or Associate member of the Club must:

- Be nominated by another Full, Student, and Associate member of the Club who shall vouch for the candidate's fitness for membership
- Have his or her name and address prominently displayed on the Club premises in a part frequented by members for at least two days before election
- Pay his or her first subscription or be elected to membership either by the Club in general meeting or by the Committee

The committee will set the match fees for each class of member and game type before the start of each season.

or more posts or where a designated member is unable or unwilling to serve, further members may be elected by the committee to make up the total of at least 15.

## 13 APPLICATION OF INCOME AND FUNDS

The Club is a not for profit organisation.
The income and funds of the Club shall be applied toward:

- Maintenance of "The Green".
- Maintenance of the Pavilion and Shed.
- Purchase and maintenance of playing and training equipment.
- Training of volunteers to perform their roles e.g. coaching, groundsman and first aid courses.
- Any other necessary capital expense.

Donations and/or subscriptions to any Charities or Persons etc. shall be permitted with the consent

The Trustees shall be appointed by the Club in general meeting and the property of the Club (other than cash which shall be under the control of the Treasurer) shall be vested in them to be dealt with by them as the Committee shall from time to time direct by resolution (of which an entry in the minutes shall be conclusive evidence). The trustees shall be ex-officio members of the committee.

The trustees shall be indemnified against risk and expense out of the club property and if this is insufficient by all members of the club. The trustees shall hold office until death or resignation or until removed from office by a resolution of the Club in general meeting who may for any reason which may seem sufficient to a majority of members present and voting at any meeting remove any trustee or trustees from the office of trustee. ## 21 VICE-CAPTAINS

Team captains will select their Vice-Captains if not elected at the AGM and notify the Club Press Officer in the week following the A.G.M. so all members can be informed of their appointments.

## 22 AVERAGES

Qualification for the Batting and Bowling Averages is published in the policy document WCC Averages

NOTE: Should the position arise whereby no three batsmen or no three bowlers achieve their respective qualification the decision shall be that of the Chairman and Committee of the Season in question.

In the event that players represent both the $1^{\text {st }} \mathrm{XI}$ and $2^{\text {nd }} \mathrm{XI}$ their aggregate innings and overs shall be considered for the team they represented most ,and should that be equal, the one which they have the better average.

## 23 TAVERNERS

To assist with the selection of the numerous annual club awards there shall be a Taverners Committee, the Chairman and members of which shall be appointed at each A.G.M.

## 24 LICENSING HOURS

The opening hours of the Bar for the supply of intoxicating liquor shall comply with the terms and conditions of the Club Premises Certificate / Liquor Licence granted by the Local Authority. These are posted at the bar.

## 25 VISITORS

The Club may, at the discretion of the committee, supply intoxicating liquor for consumption of the Club premises to any person visiting the Club at the invitation of the Club in general meeting or of the Committee on behalf of the Club for the purpose of playing cricket or supporting or assisting in a game of cricket.

## 26 CONSTITUTION

## 27 POLICIES AND PROCEDURES

Club Policies and Procedures can be issued, amended and put into immediate use with the consent of not less than two thirds of the committee members present at a management committee meeting.
