Introduction

Ripon RUFC has a car parking facility that is available for members, players, visitors and persons hiring the rugby club for events. Whilst most members live locally the car park is regularly used and required during match days and other events.

Members of the Club are actively encouraged to walk or cycle to the Club. If this is not possible, they are encouraged to car share or be dropped off at the Club.

When the car park is full, we utilise our local partners facilities at Ripon Cricket Club and Ripon City AFC. On street parking is available on Studley Road, Ripon, which is the most suitable place to park on the road and the least intrusive for the local community.

Car Park Guidelines

These guidelines have been produced to help ensure the safety of all members, and visitors, and we are grateful for your full cooperation. This document forms part of the risk assessment for the safety of everyone entering or leaving the car park. With a large junior section, parents and carers are reminded their responsibilities for supervising their children.

The following is an outline of the key requirements of the guidelines:

- A 5-mile-per-hour speed limit applies throughout our site
- All drivers must exercise due care and attention when driving and manoeuvring in the car park
- All members and visitors are encouraged, where possible, to walk to the Club
- The disabled bay is only to be used by registered disabled badge holders.
- There is to be no parking on designated walkways or double yellow lines
- Access for emergency vehicles must be maintained at all times
- Users of the Club car park does so at their own risk. Ripon RUFC will not accept responsibility for damage, accident or loss to vehicles or contents.
