SSE Wildcats Centres aim to be a safe environment where girls can have fun, develop new skills and create foundations for a lifelong love of sport. Every week, girls aged 5 - 11 will be given the opportunity to get involved in football through fun sessions that encourage friendships, character-building and fitness/healthy lifestyle.

If you wish your young person to take part in the SSE Wildcats Centre please read the following guidance notes before completing the declaration in the registration process. Please also ask your young person to read the commitment statement at the bottom of this document.

Please note, places are limited and will be allocated on a first come first served basis, subject to receipt of your young person's registration and receipt of payment. <u>Cost</u>

You can book all 16 sessions in advance for a discounted total of £36 per player. Alternatively, subject to spaces being available, players can join on the day for £3 per session.

What you need to bring

Parents/Carers must ensure that their child brings a drink, any necessary medication (e.g. inhalers etc.) and are dressed appropriately outdoor sportswear for the weather conditions, with the correct footwear.

Please note, our 3G Artificial Turf football pitch looks like natural grass and has similar playing characteristics – it provides a firm grip and good ball control. However, if you wear the 'wrong' footwear you could injure yourself and/or damage the playing surface. Please see the Wodson Park 'Acceptable Footwear' guide below:



Muddy Footwear damages the 3G Artificial Turf football pitch surface. Please make sure YOUR boots are CLEAN - BEFORE you go on to the pitch.

Parent /Carer responsibilities at SSE Wildcats Centres

- Parents/Carers must ensure that their child brings a drink and appropriate clothing/ footwear
- Parents/Carers must sign their child in and out at the session
- Upon arrival you will be met by the lead member of staff at the entrance to the playing area.
- Once children are signed in they should remain with Parents/Carers until the session begins or are signposted to the member of staff running the arrival activity.
- 5-10 minutes prior to the end of the session, if a member of staff is available, they can start the sign out process with each parent/carer individually (preferably the lead member of staff). However, if a member of staff is not available to begin sign out at this stage, then this must happen once the session has ended.
- At the end of the session children collect their belongings and are kept within a designated area until they have identified who is picking them up and they have been signed out.
- If Parents/Carers wish to have a discussion with staff, please wait a few minutes until the sign out process has been completed safely, to ensure attention is solely focussed on the safety of children in our care.
- If the named adult is not collecting the child then they have to provide the name and contact number of the person who will be collecting the child to the centre lead.

Signing-in & out

In order to comply with The FA requirements, parents/carers and players are required to Sign-in and out of each session. **Please ensure you always arrive by 9:30am** so we can complete the signing-in process. Coaching sessions will finish at 11am and we ask that you please also allow a few minutes after 11am to sign-out before departing.

Parent/Carer attendance

We always recommend and ask that parents/carers remain present throughout any SSE Wildcats activities their child is part of. Aside from providing reassurance, support and encouragement, which is important to so many children, physical activity always poses some risk of injury. While we naturally take precautions to minimise risk of accidents, on the very rare occasion an incident occurs that requires medical attention, our primary concern must always be the welfare of the child. Spending time attempting to contact a parent/carer in such situations, causing concern to the parent/carer and a potentially dangerous rushed return trip, is something we would prefer to avoid. However, if you are unable to stay and unexpectedly delayed, please contact us and we will ensure the young person remains supervised until you collect them.

Images

This guidance explains why we need to ask you for your consent for any photographs of your young person being used by The FA, SSE or partner organisation. After reading this, you should complete the registration process to let us know your wishes. We live in an age in which digital technology has vastly increased the use of photography, and there has been publicity surrounding concern about the risk of a young person being identified by a photograph in the local press or via social media.

The FA takes the view that the risk of a young person being identified by a stranger is small and that, providing reasonable steps are in place in terms of appropriateness of the photography and to protect the full name and contact details of the young person, photography will be permitted. The FA is mindful of the fact for some families; there may be reasons why a young person's identification is a matter of particular anxiety. If you have special circumstances, either now or at any time in the future, that would affect or change your consent on this issue, it is your responsibility to advise us of any changes.
