The money raised by this competition will be ring fenced to cover essential costs to the club and will be run in accordance with Vale of White Horse District Council Small Society Regulations.

## Rules:

- 1. The scheme shall be known as the Abingdon United 50/50 Club draw and will be run by Abingdon United Football Club.
- 2. Membership shall be a contribution of £5 per month, per share. This can be paid via standing order on the 10<sup>th</sup> of each month or annually as a lump sum of £60. Please note members can buy more than one share
- 3. 50% of the proceeds will be returned as cash prizes.
- 4. The proceeds of the scheme will be used to cover maintenance and improvements of the clubhouse/ground facilities
- 5. The scheme will commence on 23<sup>rd</sup> September 2020 and the first draw will take place on 23<sup>rd</sup> October and monthly thereafter
- 6. Prizes will be distributed in accordance with the Committee instructions and will be in the approximate ratio of 70%, 20% & 10% this will depend on the value of the prize fund.
- 7. As membership will vary month to month the Committee will decide when to add additional payouts.

- 9. The draw will be carried out by random on the 23<sup>rd</sup> of each month
